

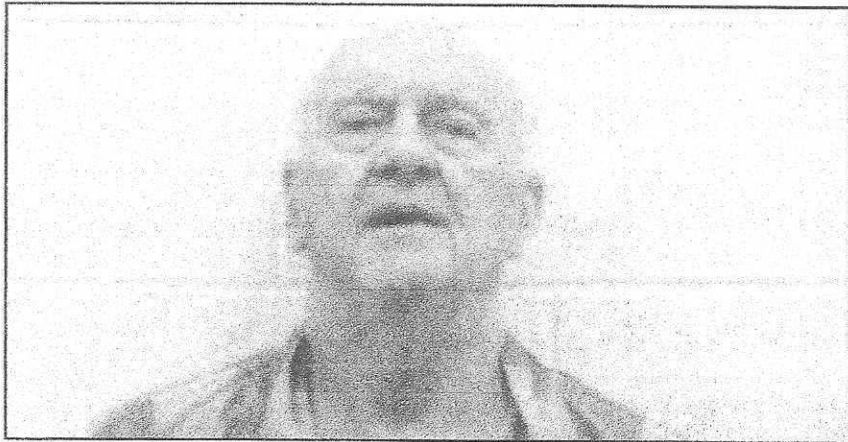

Former Knox County Governmental Librarian Paid for Time Not Worked

Ashley Satterfield indicted after receiving \$108,444 in un-earned pay

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of Ashley Satterfield, the former Knox County Governmental librarian. The Knox County Governmental Library assists the courts, judges, and public officials in Knox County.

Investigators found that Satterfield received at least \$108,444 in compensation for not time not worked between 2014 and her resignation on January 27, 2023.

Comptroller investigators conducted interviews and reviewed documentation including identification badge entry/exit activity to determine that Satterfield was not working on many days.

For example, in July 2022, she received a full month's pay; however, her badge activity records show she was only physically present at the library for approximately one hour that month.

Investigators have also questioned an additional \$40,527 of compensation received by Satterfield. Although Satterfield

DUI

Orville Clark, 83, Black Oak Lane Ohio, was charged with, DUI, Violation of Implied Consent, Open Container, and Possession of Firearm while under the Influence.

Cpl. L. Hawkins LCSO, was dispatched to the area of Interstate 75 South at the 76 mile marker in reference to a reckless driver. The caller, called 911 advising that a Black SUV with Ohio Tags could not maintain its lane, traveling at high rates of speed, and that the driver was slumped over on the window. Cpl. Hawkins arrived in the area and located a Black Ford Explorer with Ohio Tag EJM7572. The ve-

hicle aggressively changed lanes and was jerking the vehicle left and right. Cpl. Hawkins conducted a traffic stop on the vehicle on I-75 SB at the 72 MM. Upon contact with Orville Clark, the driver, Hawkins observed him fidgeting with the center console, his clothing and the seat. Mr. Clark's eyes were bloodshot and his vehicle smelled of an alcoholic beverage. In the passengers floorboard was an empty 1.75L bottle of "Gentlemen Jack". Cpl. Hawkins began to explain why he stopped him and he stated that he was trying to do shock therapy, then began showing Cpl. a tooth in his mouth. Cpl. asked him if there were weapons in his vehicle and he threw his hand

in-between the drivers seat and door and advised yes. Cpl. instructed him to place his hands up while he came to the drivers door to get him out. While pulling him from the vehicle he reached his hand down and touched the firearm to show Cpl. Hawkins where it was. Cpl. Hawkins instructed him to put his hands up once more while he recovered a Kimber 1911 .45 Cal. This gun had a loaded magazine and an empty chamber. Mr. Clark exited his vehicle and began to tell Cpl. that he was headed to Florida from Ohio. He stated that In Richmond Kentucky, he stopped for a drink of bourbon. Cpl. Hawkins then conducted HGN on Mr. Clark, he refused to

continue testing. Cpl. placed him into custody for DUI and he refused to provide a blood sample for testing as well. On the vehicle, appeared to be recent damage and paint exchange from an object.

Mr. Clark denied striking anything with his vehicle. Mr. Clark continued to talk out of his head and move irregularly for the remainder of our encounter. During a Probable Cause search, two more 1.75L bottles of "Gentlemen Jack" were found. Both bottles were open and still had contents inside. Cpl. Hawkins then transported him to The Loudon County Jail. Cpl. attempted to contact the caller to retrieve his information and was unsuccessful. All the above did occur in Loudon County, Tennessee.

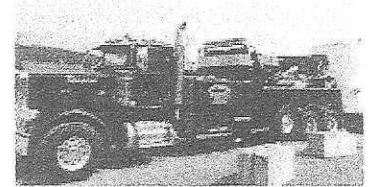

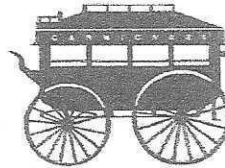
Charged

David Galloway, 41, West Lee Highway Philadelphia, was charged with Simple Possession, Driving on Revoked/Suspended License, Violation of Probation, and Violation of Implied Consent.

Officer Law LCPD, was on routine patrol when he observed a red Chevrolet truck (TN Tag 548-BKGW) slightly blocking the entrance of Highway 321 North "Exxon". Officer observed an unknown male behind the wheel, officer Law then observed the male exit the truck who appeared unsteady on his feet. Upon checking the welfare of the male, he identified himself to be David Galloway. While speaking to Mr. Galloway officer observed him to have constricted pupils, he was sweating from the forehead "42 degrees outside" and appeared to have white foam in the corners of his mouth. Upon running Mr. Galloway through dispatch, they advised he was

revoked for DUI "12/2022". Mr. Galloway then consented to ARIDE; Mr. Galloway did perform unsatisfactorily. 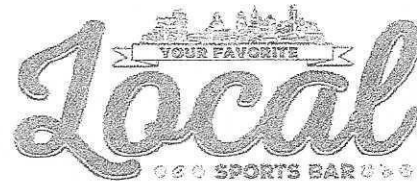

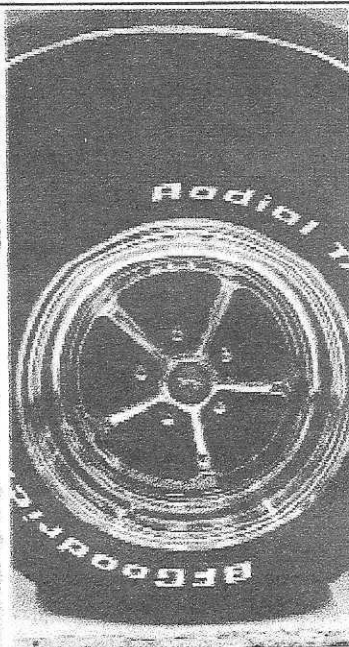

DWI

Trinity Reynolds, 18, Newton Street Alcoa, was charged with Underage Driving while Intoxicated.

Officer Law LCPD, was on routine patrol when officer observed a dark colored Toyota Suv (TN Tag BJZ-1787) traveling South in the Northbound Lane. Upon turning around on the vehicle, the officer observed the vehicle to not have any working tail-lights. Officer then conducted a traffic stop at Highway 321 North "Traditions" and identified the driver to be Trinity Reynolds (18 yoa). While speaking to Ms. Reynolds Officer observed her to have bloodshot watery eyes, and the odor of an alcoholic beverage emitting from her persons. During his investigation, Ms. Reynolds stated she had not consumed any alcohol prior to our encounter, after receiving consent to search the officer located an empty Grey Goose Vodka bottle underneath the passenger seat. Ms. Reynolds then

consented to SFST, officer observed lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and an onset of nystagmus prior to 45 degrees in both of Ms. Reynolds's eyes. Then during my investigation Ms. Reynolds stated she had a sip of the vodka around 2000 hours on 12/22/2023. During the walk and turn, Ms. Reynolds stepped off the line three times during the instructional phase and did an improper turn. During the one leg stand, Ms. Reynolds used her arms to balance, and swayed slightly through the test. During the modified Romberg test, Ms. Reynolds elapsed 40 seconds before she lost balance and almost fell over. Ms. Reynolds then revealed she had consumed two shots of the vodka around 2100 hours. After placing Ms. Reynolds under arrest, she was transported to the Fort Loudoun Medical Center for a consented blood draw, and then transported to the Loudon County Jail without incident. All the

above occurred in Lenoir City, TN.

Officers with the Lenoir City Police Department were dispatched to a physical domestic in the parking lot of Bon Street "Dollar General". The complainant, stated a female got of a truck, began yelling and started throwing things. Officer Law arrived on scene, he identified the male to be Jason Arzola, and the female to be the victim. After separating the parties, Mr. Arzola stated that he and the victim got into a verbal argument while inside his truck, Mr. Arzola stated he began yelling at the victim and started

throwing things. The victim stated Mr. Arzola was upset because he could not find his phone, so Mr. Arzola began yelling and throwing stuff at her. The victim stated at one point he tore off the front cover of his dash, and then threw it near her. The victim stated that she was in fear for her safety due to Mr. Arzola's actions. Due to the totality of the circumstances Mr. Arzola was deemed the primary aggressor and placed under arrest. Mr. Arzola was then transported to the Loudon County Jail without incident. This incident did take place within Loudon County, Tennessee, and all the above occurred in Lenoir City, TN.

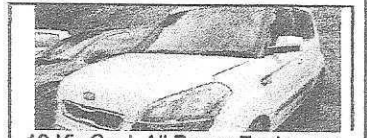

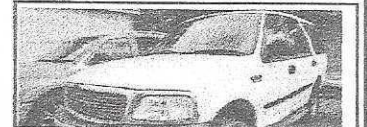

was not authorized to work remotely, she claimed she worked from home periodically, specifically on days when she worked at the library for less than a full workday. Investigators could not determine whether she earned the total compensation paid on these days when she was physically present at the library for less than a full workday.

Based upon this investigation, in December 2023, Ashley Satterfield was indicted by the Knox County Grand Jury on one count of theft over \$60,000 and one count of official misconduct.

"Knox County officials should ensure that requirements related to completing and submitting time sheets are followed," said Comptroller Mumpower. "In this case, Satterfield did not complete timesheets or document any annual or sick leave that

she may have taken. Additionally, the library should be issuing prenumbered receipts when it collects money. Due to the lack of receipts, investigators could not determine if all the library funds were accounted for and deposited."

Isaac Nolen, 20, Allison Lane Lenoir City, was charged with Violation of Alcoholic Beverage Law, and Public Intoxication.

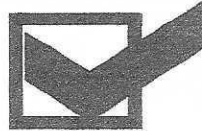

- (B) Sixty (60) days from the date the creditor received an actual copy of the notice to creditors if the creditor received the copy of the notice less than sixty (60) days prior to the date that is four (4) months from the date of first publication (or posting) as described in (1) (A); or
- (2) Twelve (12) months from the decedent's date of death.

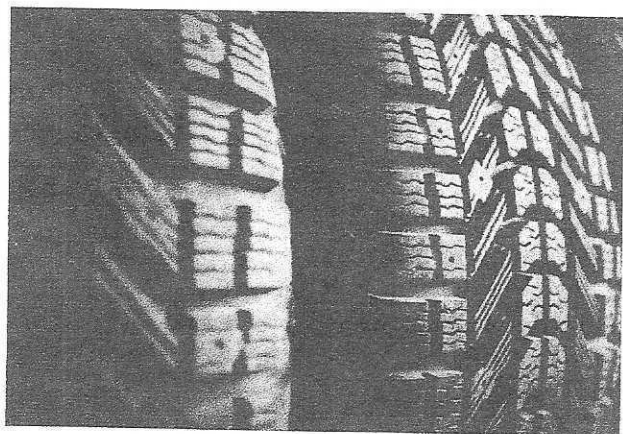

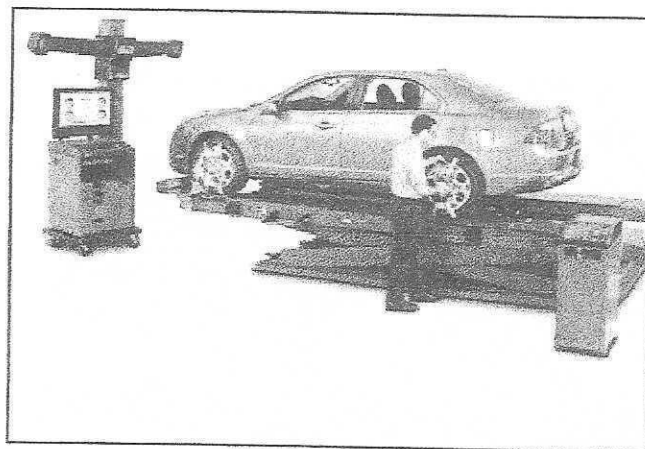
