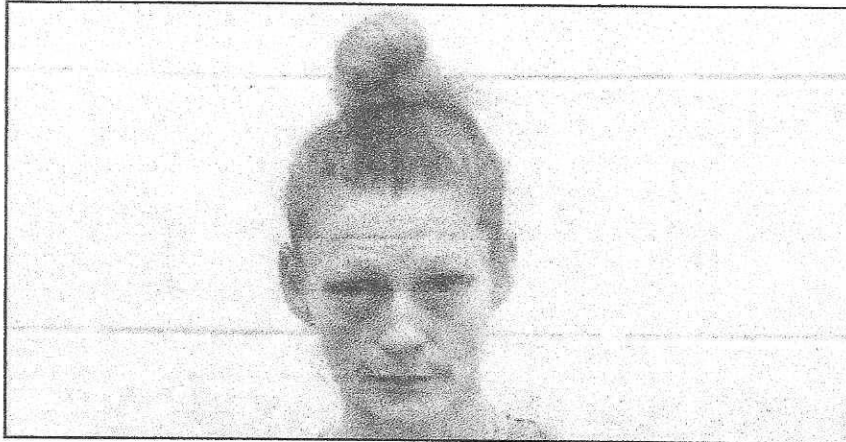

Vanessa Roberts Avery, United States Attorney for the District of Connecticut, announced that JOHN MATAVA, 59, of Coventry, pleaded guilty today before U.S. District Judge Kari A. Dooley in Bridgeport to offenses related to his receipt of COVID-19 relief funds.

In March 2020, the Coronavirus Aid,

Relief, and Economic Security (CARES) Act provided emergency financial assistance to Americans suffering the economic effects caused by the COVID-19 pandemic. One source of relief provided by the CARES Act was the authorization of forgivable loans to small businesses for job retention and certain other expenses

through the Paycheck Protection Program (PPP). In April 2020, Congress authorized more than \$300 billion in additional PPP funding. The PPP allowed qualifying small businesses and other organizations to receive unsecured loans at an interest rate of 1%. PPP loan proceeds were to be used see Fraud pg 5

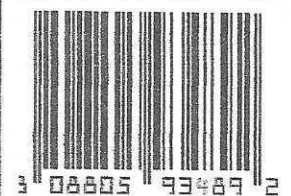

Officer Eldridge LCPD, was dispatched to the Buddy's BBQ/Kenjo in regard

to a welfare check. Officers arrived on scene and made contact with the Kenjo manager who stated that a female was passed out in the drivers seat of a Gray Silverado (295BBWB) with the vehicle still running. Officers observed the vehicle and noticed that it was double parked with the middle of the vehicle strad-

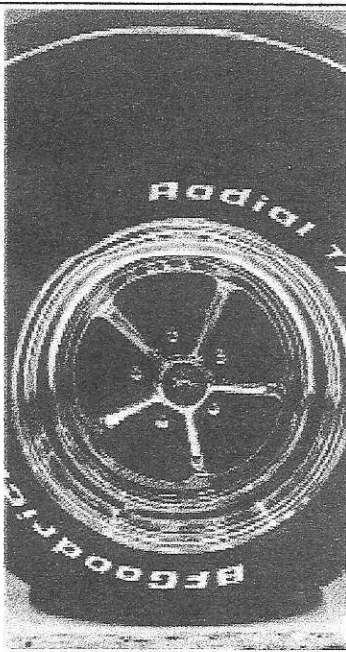

Gary Crockenburg, 59, Dawson Road Sweetwater, was charged with DUI, Violation of Implied Consent, and Evading Arrest.

Deputy Harrison LCSO, was dispatched to Dawson Road in reference to a physical domestic. Dispatch advised the complainant had been beaten up by her intoxicated husband. Just before arriving on scene, the complainant advised her husband was leaving the residence in a white Dodge Dakota. The vehicle passed him on Raby Town Road heading towards Oakland Road. Deputy was able to get behind the vehicle and initiate a traffic stop at which point the male failed to stop and continued on Oakland Road. Deputy initiated a pursuit with the vehicle on Oakland Road at which point Deputies Lane and Branson

were able to assist. After a short, low-speed pursuit, we were able to successfully box the vehicle in and take the offender, Gary Crockenburg in custody without further incident at Oakland Road and Brannon Road. Deputy Branson left the scene and went out to Dawson Road to speak with the victim/complainant and investigate the domestic further. The victim stated to Deputy Branson she was asleep on the bed when her husband woke her up by throwing water on her, and stated she was to perform sexual acts on him. When she refused, he began punching her in the head. The victim stated to Branson she would have bruises on her the next day, but at the time of the incident, there was not enough physical evidence on the scene to support the claim. The victim also provided a

written statement on the incident. While conducting a tow inventory of the vehicle the deputy observed a glass of whiskey in the center console cupholder also a black bag in the console area containing an opened pack of small Fireball whiskey bottles. While Deputy Lane was

transporting Crockenburg to the jail, the offender stated he had been drinking since 1:30 PM. Once on scene at the jail, Deputy Lane read Crockenburg Tennessee Implied Consent to which he refused all tests. This did occur in Loudon County, Tennessee.

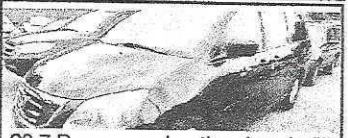

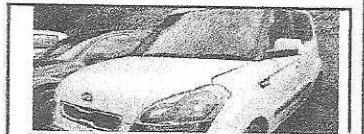

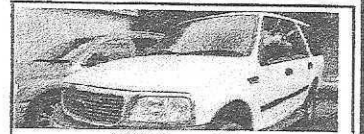

by businesses on payroll costs, interest on mortgages, rent and utilities. The PPP allowed the interest and principal to be forgiven if businesses spent the proceeds on these expenses within a certain period of time of receipt and used at least a certain percentage of the amount to be forgiven for payroll.

The PPP was overseen by the Small Business Administration, which has authority over all PPP loans. Individual PPP loans, however, were issued by private approved lenders, such as Celtic Bank, which received and processed PPP applications and supporting documentation, and then made loans using the lenders' own funds, which were guaranteed by the SBA.

According to court documents and statements made

in court, in April 2020, Matava applied to Celtic Bank for a \$100,000 PPP loan for J.M. Builders LLC. The application submission included several false representations, including that J.M. Builders LLC had eight employees and an average monthly payroll of \$40,000; that the monies would be used for payroll, lease, mortgage, interest and utilities; and that the business owner was not subject to pending formal criminal charges. At the time of the PPP loan application, there were no records of payroll or employees with the Connecticut Department of Labor for J.M. Builders LLC, and Matava was subject to criminal charges in two pending cases related to arrests in 2017 and 2018.

On April 22, 2020, Celtic Bank disbursed \$100,000 to a bank account for J.M.

Builders LLC on which Matava was the signatory. The account was opened on April 21, 2020, and had a balance of \$0 immediately prior to the loan funds being disbursed. Between April 2020 and January 2021, Matava used the funds primarily for personal expenditures, including \$3,498 to pay a dog breeder, \$4,777 for payments to an RV superstore in Connecticut, and legal fees, including a \$2,000 retainer, for four court cases in Rockville, Connecticut.

In January 2021, Matava sought \$100,000 in addi-

tional PPP funds from Celtic Bank, and included with the application several additional false statements and fraudulent tax documents. Celtic Bank denied the application.

Matava was arrested on January 7, 2023. He pleaded guilty today to one count of wire fraud affecting a financial institution, which carries a maximum term of imprisonment of 30 years, and to one count of making an illegal monetary transaction, which carries a maximum term of imprisonment of 10 years. Judge Dooley sched-

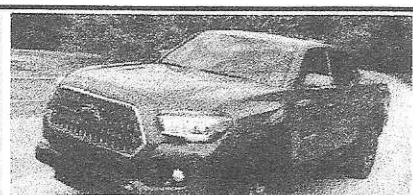

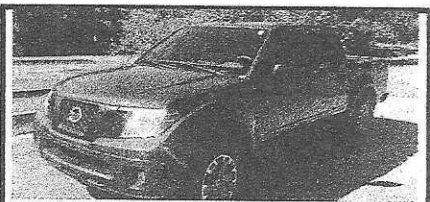

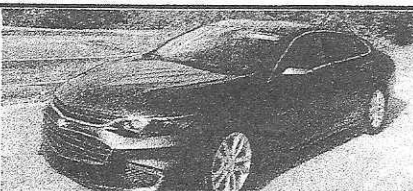

Matava is released on a \$60,000 bond, in home detention, pending sentencing.

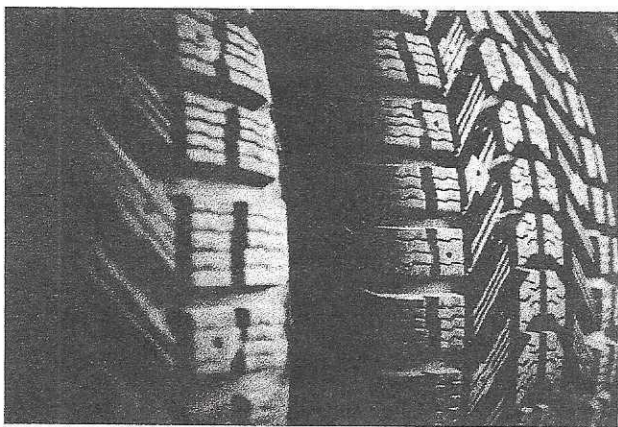
