Former Tipton County 911 Assistant Director Indicted on Multiple Counts

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of Glenda Brown, the former assistant director of the Tipton County Emergency Communications District.

Investigators determined that Brown improperly received at least \$6,150 in unauthorized payroll payments from Octo-

ber 21, 2022 through November 4, 2022. The investigation began after Tipton County officials identified these questionable payment transactions and reported them to the Comptroller's Office.

Brown's misappropriation consisted of unearned compensatory leave payments, unauthorized annual leave payments, excess salary compensation, and unearned payroll

benefits.

For example, as a salaried employee, Brown was not eligible to receive compensation for more than 80 hours per pay period. Brown, who was also responsible for entering time worked by employees, including herself, received 80 hours of salary and 40 hours of sick leave (total 120 hours) on

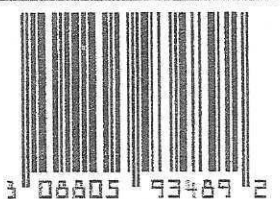

Ammelia Jones, 31, Valley Road Knoxville, was charged with DUI, and Simple Possession.

Deputy Parks LCSO, observed a red Dodge Stratus, Mississippi registration MIB2529, swerve on the opposing side of 321. The deputy turned around to get behind the vehicle and began observing. While traveling behind the vehicle the deputy observed the vehicle failing to maintain lane multiple times, and also noticed the vehicle could not maintain a constant speed. The deputy initiated a traffic stop on the vehicle and we came to a stop in the parking lot of Highway 321 North (Rocky Top Shell).

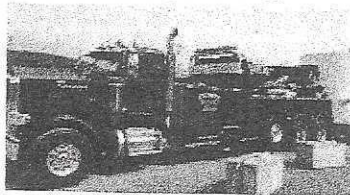
The deputy approached the vehicle and made contact with the driver, Ms. Ammelia Jones, who advised him she was lost. While speaking with Ms. Jones, the deputy smelled the odor of burnt marijuana emitting from the vehicle. The deputy then asked to gathered Ms. Jones documents and called for a second unit for a vehicle search. When deputy asked Ms. Jones to step out and informed her that he smelled marijuana, she advised she had marijuana and a pipe in the car and her cannabis card. The deputy asked Ms. Jones for consent to search the vehicle and she gave consent. While speaking with Ms. Jones, I smelled the odor of an alcoholic beverage

coming from her breath. Ms. Jones also advised she takes prescription medication daily such as Clonazepam and Gabapentin, which she had taken approximately 6 hours earlier. During the search of the vehicle, a small container containing approximately 2.07 grams of marijuana as well as an open container of liquor underneath the drivers seat. The deputy then asked if she would be willing to perform standardized field sobriety tests and she agreed to do so. Ms. Jones did perform field sobriety tests, as well as ARIDE tests administered by Corporal Wallen.

Ms. Jones performed poorly, and due to the facts and circumstances was believed to be operating a vehicle under the influence of an intoxicant. The marijuana was seized and placed into evidence and Ms. Jones was placed under arrest and read implied consent. Ms. Jones agreed to give a blood sample and was transported to Fort Loudoun Medical Center where the sample was obtained. Ms. Jones was then transported to the jail without incident. Both the blood sample and the marijuana were placed into evidence.

Reannah Thompson, 54, Smallen Road Loudon was charged with DUI, Violation of Implied Consent, Simple Possession, and Driving on Revoked/Suspended License. Officers with LCPD, were dispatched to the area of Hwy 321 at the Dam for a reckless driver. The caller stated that a Gray Prius (5614BCPB) was all over the roadway, crossing over the fog line several times while officers were behind the vehicle. Officers passed the vehicle in front of the ALDI and observed the vehicle to almost be straddling the fog line. Officers turned around and got behind the vehicle and observed it cross the fog line again and conducted a traffic stop in the parking lot of Lakeway Urgent Care. Contact was made with the driver (Reannah Thompson) who appeared to have pinpoint pupils and seemed very lethargic. Reannah was asked to step out of the vehicle and informed on the reason for stop, but denied taking anything that would

impair her driving. Reannah gave officers consent to look through her purse which resulted in several cut straws being found with residue and 3 Gabapentin pills that were not in their prescription bottles. Her right eye showed signs of a nystagmus in all 3 portions and her left eye had a nystagmus at maximum deviation. ARIDE was performed by Officer Carrol in which Reannah performed poorly on all tests, showing signs of being impaired. Dispatch advised Reannah to have a suspended drivers license and due to the totality of the circumstances was placed in custody for DUI. Implied consent was read and refused and she was transported to the Loudon Co Jail. The paraphernalia was photographed and the vehicle was impounded by Malones. This did occur in Lenoir city, Loudon co, TN.

her November 4, 2022 pay-check.

Brown attempted to conceal her misappropriation by improperly entering her excessive payroll payments in the district's accounting software under line items not assigned to her.

Brown's employment was terminated by the district's board of directors on December 12, 2022. She subsequently repaid the district \$7,381.19. This amount was calculated by the district to include Brown's improper payroll payments and the value of district equipment assigned to her that she did not return upon termination of employment.

Based upon this investigation, in March 2024, the Tipton County Grand Jury indicted Glenda Brown for one count of theft of property over \$2,500, one count of destruction of and tampering

with governmental records, and one count of official misconduct.

"Government entities should ensure payroll duties are divided between multiple individuals," said Comptroller Mumpower. "One person should not be creating employee timesheets, entering the time worked into the accounting system, and processing payroll. Timesheets should also be approved by a supervisor before being processed."

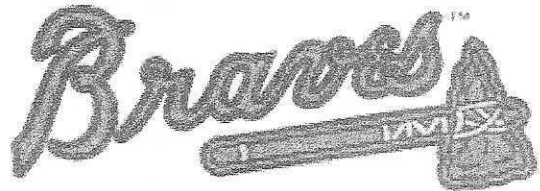

Thomas M. Williams, 79, of the Tellico Village Community, Loudon, TN., went to be with our Lord Jesus Christ on Friday,

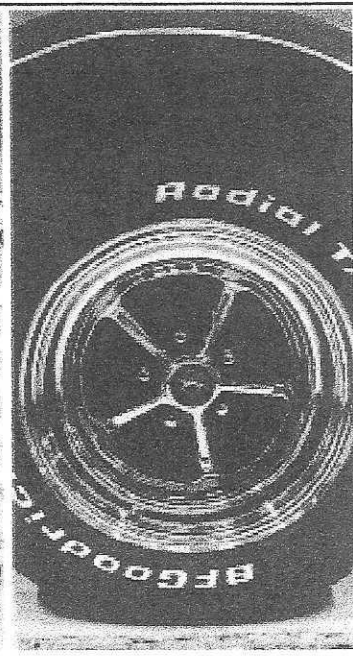

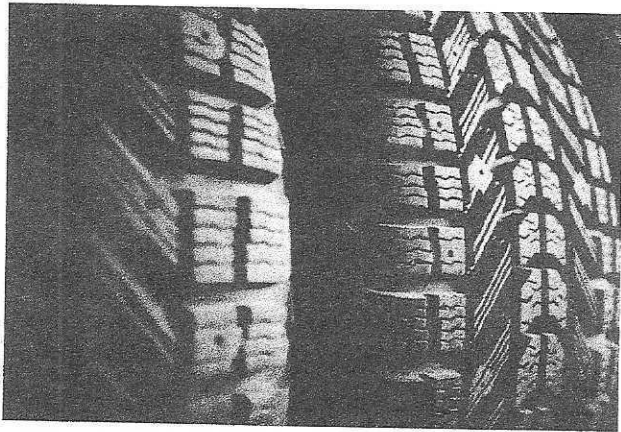

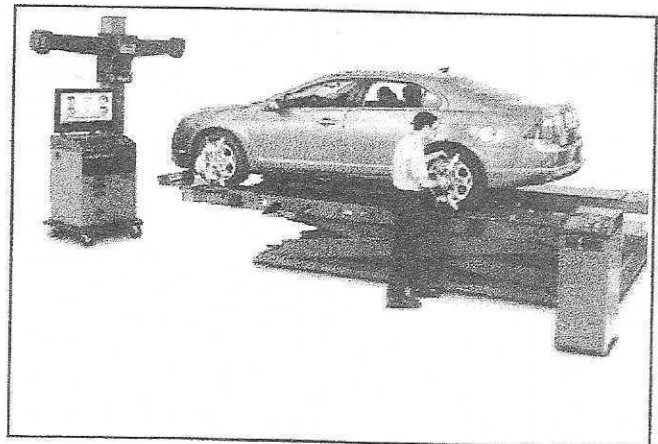
