Victim Run Over by Vehicle Refuses Treatment; One charged with Aggravated Assault


Bryson Young, 33, Holland Trail Lenoir City, was charged with Aggravated Assault. Deputy JC Schultz LCSO, answered a Aggravated Domestic call at Holland Trail in Lenoir City, Tn. Upon arrival the victim gave a verbal statement on bodycam saying that his son who lives with him (Bryson Young) had ran him over with his vehicle and injured

Sextortion

Case Highlights Growing Online Crime with Devastating Real-Life Consequences

The doors were locked, the alarm system was on, and the 13-year-old girl never left her room. But a child predator was able to reach her simply because she was tricked into connecting with him online.

The link between Presley (her name has been changed to protect her identity) and someone she believed was another teenage

girl named K.C. started out as a friendly exchange over a popular messaging app. They sent each other occasional messages and pictures of their outfits over a few weeks.

One mildly revealing photo from Presley, however, gave K.C.—who was actually a grown man in Florida named Justin Richard Testani—an opening

Tennessee State Veterans' Homes Paid for Medical Services That Were Not Provided Medical Providers Indicted for Theft

An investigation by the Tennessee Comptroller's Office has resulted in the indictments of Dr. Christopher F. Standley, Dr. Robert M. North, and his wife Lisa L. North. Investigators determined these individuals owned medical companies that wrongfully obtained payments from Tennessee State Veterans' Homes for medical

services that were not provided.

The Tennessee State Veterans' Homes (TSVH) Board operates four skilled nursing facilities across the state. The homes provide healthcare and quality of life support to veterans. The TSVH Board contracts with medical and mental health service providers to provide care at its fa-

cilities. This investigation was initiated after the TSVH Board reported suspected billing issues related to its contract service providers.

The investigation found that Dr. Christopher Standley, owner of Dynamic Healing, LLC, wrongfully




her mother said. "She let her guard down because she thought it was another teenage girl."

The demands and threats escalated quickly from there. According to FBI investigators, Testani told Presley he would rape and kill her and her loved ones if she didn't perform the increasingly graphic and extreme acts he demanded over a video call.

Presley had become a victim of sextortion. With the internet allowing predators to hide their identities and easily reach thousands of young people over games

and apps, it's a crime the FBI is seeing in alarming and rising numbers.


To keep Presley from hanging up, the predator used details he'd gathered from their conversations and information she'd posted online to make his threats specific and terrifying. According to Presley's mother, he told her, "I know where your mom works. If you don't do what I'm telling you to do, I'll go kill her."

He told Presley he knew where she lived. He knew where she went to school.

He knew how to get to her friends. "She was convinced it was someone who was standing right outside the door," Presley's mother said. "Someone who could get to her immediately."

Presley was desperate and terrified when she finally reached her mom to ask for help.

We have several resources to help caregivers and young people understand what sex-tortion is, how to protect against it, and how to talk about it.

Presley's mother said her daughter called at her first

opportunity to break the phone connection with the predator. Testani wanted to take over one of her social media accounts so he could use it to contact her friends, giving him the ability to deceive and exploit another group of young girls. But as he took over her existing account, he needed her to create a new one for herself so they would still be connected online.

As she was carrying out that demand, Presley had a chance to call for help. "He told her she had two minutes to get it done," her mother said. "When they broke that connection, she felt she could call me."

Presley's mother and step-father raced home. And although they were confused about what was happening, they couldn't mistake the terror in Presley's voice. Her stepfather reached her first and immediately called the

police when he saw what was happening on her phone.

Presley's bravery in reporting helped investigators find the man who terrorized her. Testani pleaded guilty to child sexual exploitation in February and was sentenced to 60 years in federal prison on August 6, 2020.

Special Agent Kevin Kaufman, who investigated the case for the FBI in Tampa with local law enforcement, said that they identified sev-

eral other victims across the country—some as young as 10 years old.


The investigation showed that Testani obtained the login information for other victims' social media accounts, which allowed him to message hundreds of other young people.

The length of Testani's sentence reflects the number of children he hurt, the extreme nature of his crimes,

obtained payments totaling \$20,376.34 by billing for service visits that were not provided to TSVH residents. Standley was contracted to serve as the Medical Director and to provide attending physician services at the Clarksville facility.

Investigators noted there was no evidence that Dynamic Healing (DH) was in the facility on dates when it indicated it provided services to more than 200 individuals. On some occasions DH billed for services when the resident was not in the TSVH; billed for duplicate residential services; or billed when a resident was away on an activity.

In addition to the wrongful payments, investigators are also questioning an additional \$119,924.62 in payments made to Dynamic Healing. These payments are questioned because investigators

could not determine whether DH was in the facility or actually saw the residents for the services for which they billed.

Secondly, investigators found that Medical Psychology Consultants (MPC), wrongfully obtained payments totaling \$2,392.71. Dr. Robert M. North, owner, was originally contracted to provide mental health services to residents at the Humboldt, Clarksville, and Murfreesboro facilities. On September 14, 2016, Lisa North, Office Manager and wife of Dr. North, became the registered owner of MPC.

MPC billed for services provided to residents who either did not reside at the TSVH or were away on hospital or therapeutic leave; billed for services that had already been paid in prior invoices; billed when the doctor claimed to provide services to two separate res-

idents simultaneously; or billed for services rendered while a resident was away on an activity.

In addition to the wrongful payments, investigators are also questioning an additional \$4,653.77 in payments to MPC. These payments are questioned because investigators could not determine whether MPC was in the facility or actually saw the residents for the services for which they billed.

In October 2020, the Rutherford County Grand Jury indicted Christopher F. Standley on one count of theft over \$10,000. Robert M. North and his wife Lisa L. North were also each indicted on one count of theft over \$1,000.

ed," said Comptroller Justin P. Wilson. "The facilities should keep better records such as sign-in information and notes on when services start and end. Invoices should be reviewed to ensure there are no discrepancies and that vendors are only paid once. I'm pleased to note that the TSVH board has indicated they have implemented policies and procedures to correct these problems."

and the devastating effects this type of sexual violence has on its victims. Presley's mother said her daughter is still dealing with depression and anxiety, has trouble concentrating in school, and experiences panic attacks.

The fact that Presley never met Testani in person and never even saw his face only amplified her fear. This man who hurt her could be anyone, anywhere. "That's why she went from a social butterfly to absolutely terrified to leave the house," her mother said.

On this episode of Inside the FBI, we're warning kids, teens, and caregivers about an increasingly common online threat called sextortion. Listen

The New Stranger Danger Kaufman stressed that this case and the many he sees like it are a reminder to children, teens, and those who love and care for them to rethink dated assumptions about where children are safe and at risk.


