Cristy Sewell, 47, Emerald Heath Road Powell, was charged with DUI.

Deputy S. Gaumer LCSO, responded to the area of Highway 321 near State Route 444 for the report of a reckless driver in that area.


Deputy asked dispatch if the caller was going to stay behind the vehicle, to which they responded yes. Dispatch notified Deputy that the caller and the vehicle driving recklessly came to a stop on the side of the road near Antioch Church Road. Deputy arrived on scene and pulled behind the white Lexus that had been reported as the vehicle that was driving recklessly. Deputy initiated his overhead lights as to detain the vehicle. As Deputy exited my vehicle, the white Lexus started to drive away. Deputy entered his vehicle and used his manual siren which made the vehicle come to a stop. At that time, I exited

my vehicle and approached the Lexus. The driver, identified as Cristy Sewell, the offender, rolled down the window and did not look at me. Deputy identified himself and told her that he had pulled her over due to having driven recklessly enough that someone had called the police due to her driving behavior. While talking to her, Deputy noticed that her eyes were bloodshot and watery and her speech was heavily slurred. There was also a strong odor of alcohol emanating from within the vehicle and off Ms. Sewell's person. Deputy asked her for her license, which she looked over multiple times while Deputy was standing at the door. She was unable to locate the license and instead provided him with her name and birthdate for verification. At this point, Sgt. M. Fagiana had arrived on scene to speak with the driver who called Ms. Sewell in

for reckless driving. Deputy told Ms. Sewell that he could smell alcohol on her breath and asked how many drinks she had consumed this evening, and she said "two". Deputy asked what kind, and she said "margaritas". Deputy asked if they were big or little, and she replied "little". After confirm-

ing Ms. Sewell's identity, Deputy returned to the car. As Deputy approached the drivers side door, she opened the door. Deputy asked her if she would be willing to participate in voluntary roadside sobriety tests f, and she replied yes. She stepped out of the vehicle and used the door for balance. While



walking back to his car, she used the vehicle for balance once more. Once she was standing at the front of his vehicle, she attempted to perform standard field sobriety tests (SFST's), and she performed poorly enough that Deputy stopped the tests in the middle of the walk and turn. Deputy told Ms. Sewell that he believed she was under the influence enough that it impaired her ability to drive, so he placed her under arrest for driving under the influence. After placing her in handcuffs and placing her in the back of his car, Deputy read her Miranda Rights to her and then Implied Consent, to which she refused to give a blood or breath sample. While the vehicle was being inventoried for tow, multiple open bottles of hard liquor were found behind the drivers seat. Another Yeti cup containing a hard liquor was found in her cup holder. A small, white capsule identified as Temazepam and a prescription for Bupropion were also located in the center console.

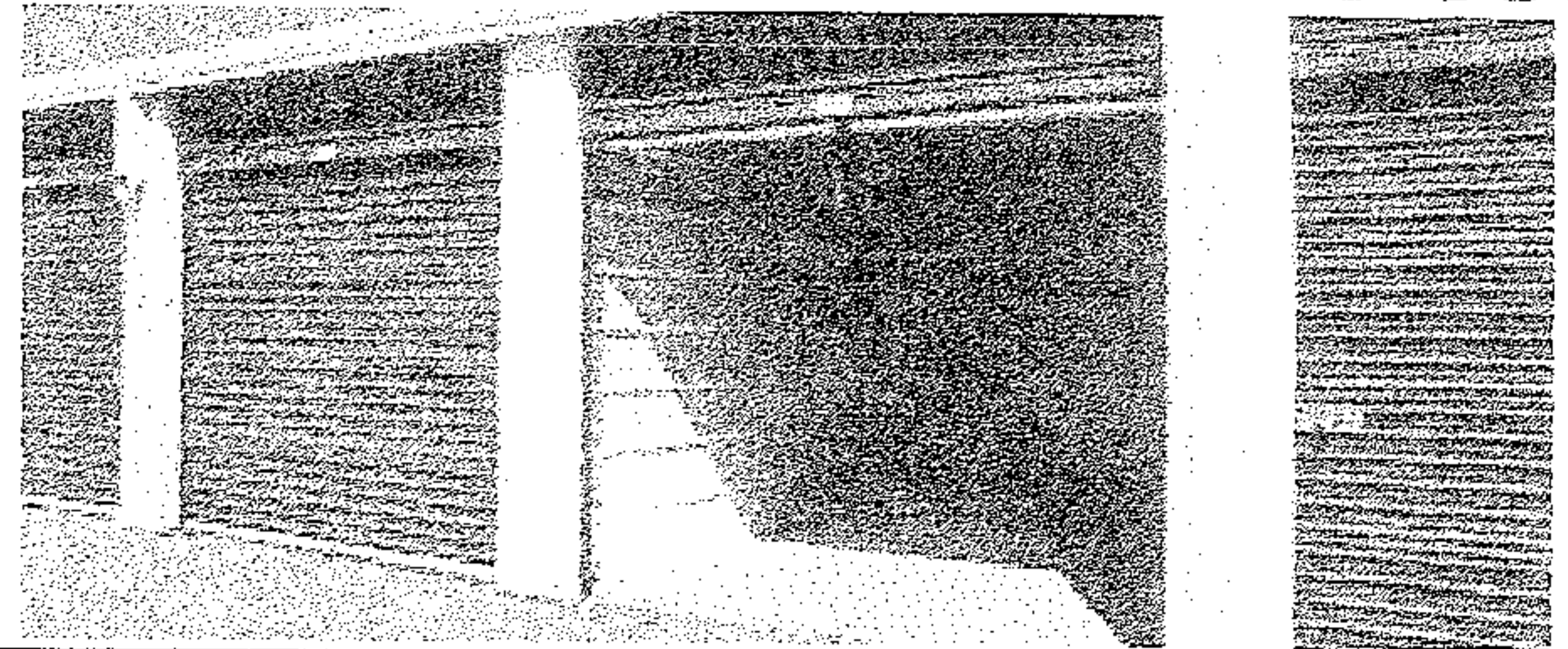
