DHS Launches Next Round of P-EBT

Qualified families to receive P-EBT cards in mail

Department of Human Services (TDHS) is extending its successful Pandemic Electronic Benefit Transfer (P-EBT) program into the fall semester by sending qualifying families a card they can use to buy food for their student who has been

impacted by the pandemic. Over 500,000 students received benefits to replace school meals lost during the spring. That's more than half of all public-school children in the state.

Fall semester P-EBT will provide parents with \$5.86 in benefits per student for each school day that child

CDC Issues Framework for Resuming Safe and Responsible Cruise Ship Passenger Operations

The Centers for Disease Control and Prevention (CDC) issued a Framework for Conditional Sailing Order that introduces a phased approach for the safe and responsible resumption of passenger cruises. The Order establishes a framework of actionable items for the cruise line industry to follow so they

can resume passenger operations with an emphasis on preventing the further spread of COVID-19 on cruise ships and from cruise ships into communities, and to protect public health and safety. The Order applies to passenger operations on cruise ships with the capacity to carry at least 250

passengers in waters subject to U.S. jurisdiction.

Recent outbreaks on cruise ships overseas provide current evidence that cruise ship travel facilitates and amplifies transmission of COVID-19—even when ships sail

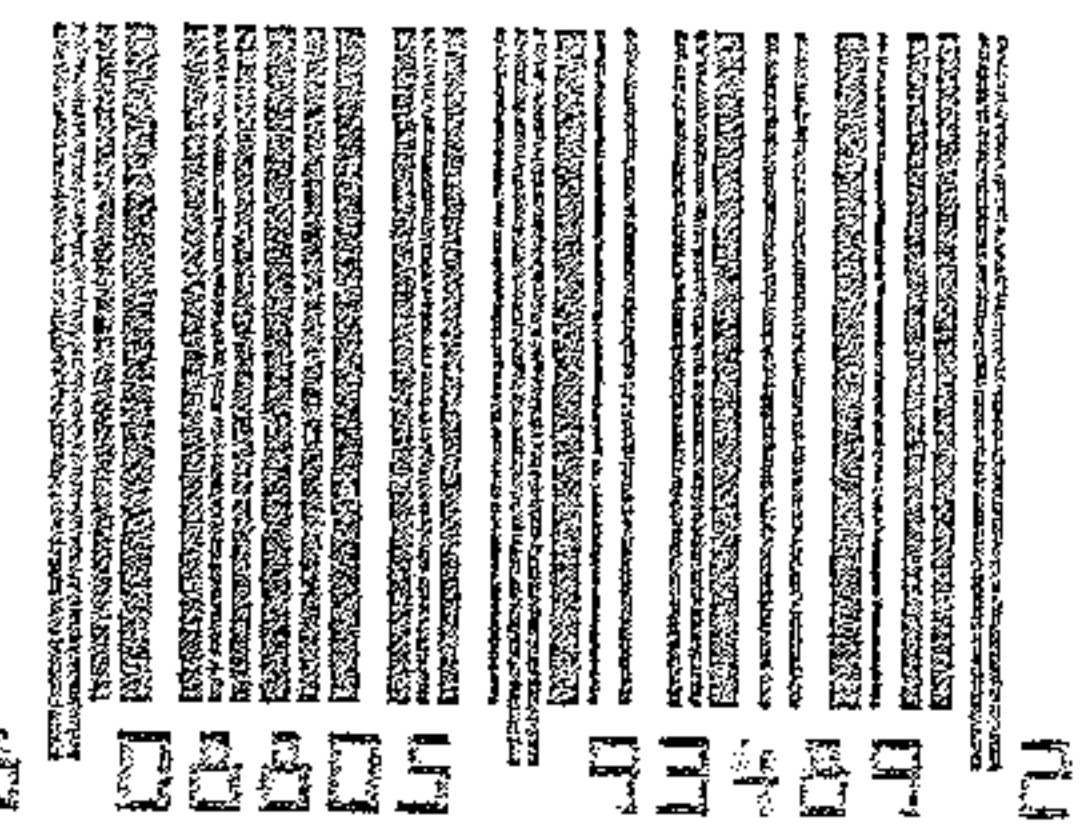
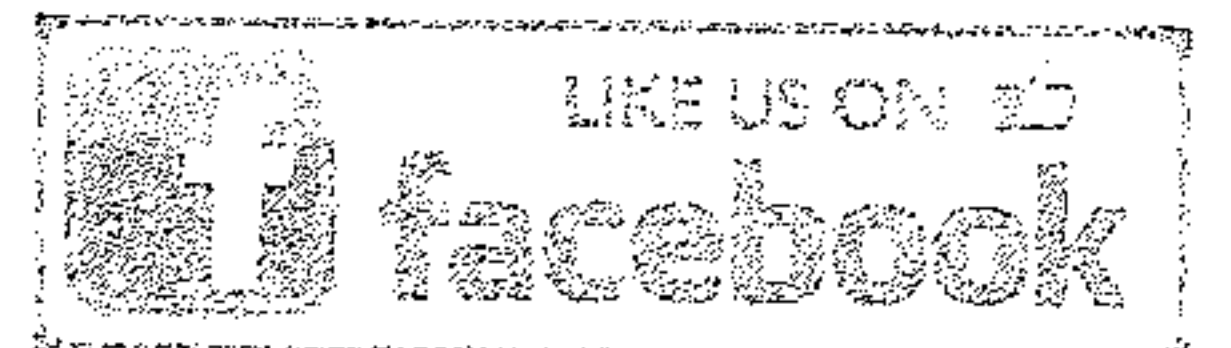

identified as Daniel Aikens, the suspect. When Deputy asked what the problem was, the complainant stepped outside and stated that the suspect had come into the residence and attacked another male. Deputy asked the suspect to speak with him away from the others, and he complied without incident.

According to the suspect, he believed that the victim whose name he did not know was in the house due to possible narcotic activity, and he did not want such things around his 14 month old son. When the suspect arrived, he saw the victim in the living room through the window and confronted him. The victim, was transported by Priority EMS to Fort Loudon Medical Center for bleeding head wounds and various scrapes. According to the caller and witness, the suspect showed up unexpected and entered the residence through

the front door. He asked the victim, "What are you doing around my son?" and then charged the victim. The suspect and the victim fought in the living room and kitchen area, knocking over the television stand and shattering the window on the stove. The witness got her two sons and hid in a back bedroom, calling 911. While the suspect does share a child with the caller, both statements indicated that he was not expected at the residence at the time of the incident, and he did enter the residence and assault the victim within the residence. Both the victim and the witness provided a written statement, and verbal statements from all involved were recorded on body camera. Lt. Charlie Cosner arrived on scene and questioned the suspect and the caller. The suspect was placed under arrest and transported to the Loudon County Jail without incident.

missed because of the COVID-19 pandemic in July, August, and September. These benefits can be used to purchase food at any establishment that accepts EBT or online with Amazon and Walmart.

To be eligible, students must receive free or reduced meals at school or attend a Community Eligibility Provision school and they must have missed at least five consecutive days of in person instruction because of school closure or virtual learning.

TDHS and the Tennessee Department of Education partnered with local school districts to identify students that meet the

qualifying criteria and the correct addresses to mail the cards. The department is now in the process of mailing these cards to families.

"P-EBT provided families with important support they needed during the summer and we're excited to partner with schools to extend the program into the fall semester," said Tennessee Department of Human Services Commissioner Danielle W. Barnes. "Schools have truly become places families depend upon for nutrition and this program will provide resources to replace those meals while students are taking part in virtual learning. Helping families during this unprecedented time is how we will

build a thriving Tennessee."

For the second round of P-EBT, benefits will be issued on a new card and mailed to the homes of qualifying students. Funds will not be placed on a family's existing EBT/P-EBT card. Families receiving benefits through the Supplemental Nutrition Assistance Program (SNAP) or the Temporary Assistance for Needy Families (TANF) may be eligible for P-EBT during the fall semester.

The Families First Coronavirus Response Act authorized the U.S. Department of Agriculture to approve states for P-EBT. Ap-

proved state agencies may operate P-EBT when a school is closed for at least five consecutive days during a public health emergency designation when the school would otherwise be in session. Tennessee is among the more than 40 states that have received P-EBT approval.

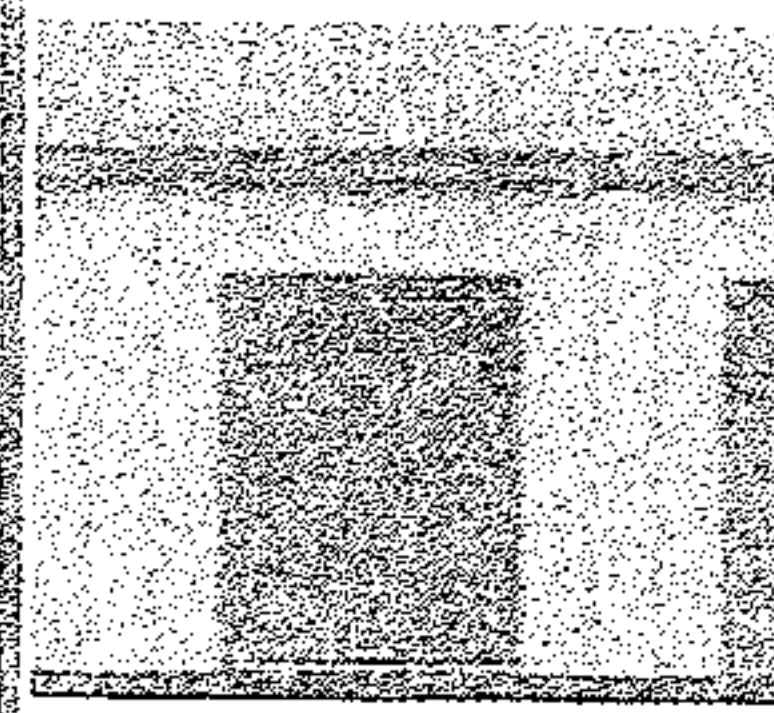

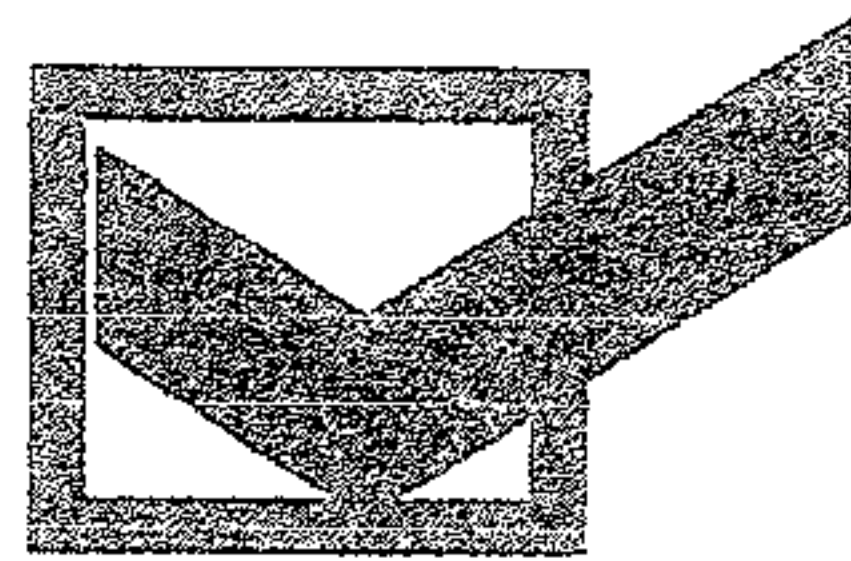

at reduced passenger capacities—and would likely spread the disease into U.S. communities if passenger operations were to resume in the United States without public health oversight.

“This framework provides a pathway to resume safe and responsible sailing. It will mitigate the risk of COVID-19 outbreaks on ships and prevent passengers and crew from seeding outbreaks at ports and in the communities where they live,” says CDC Director Robert R. Redfield, M.D. “CDC and the cruise industry have a shared goal to protect crew, passengers, and communities and will continue to work together to ensure that all necessary public health procedures are in place before cruise ships begin sailing with passengers.”

Cruising safely and responsibly during a global pan-

demic is very challenging. The Framework for Conditional Sailing Order requires a phased approach to resuming passenger operations. A phased approach is necessary because of the continued spread of the COVID-19 pandemic worldwide, risk of resurgence in countries that have suppressed transmission, ongoing concerns related to restarting of cruising internationally, and need for additional time for the cruise industry to test the effectiveness of measures to control potential COVID-19 transmission on board cruise ships with passengers without burdening public health.

“CDC and the cruise industry have the same goal: A return to passenger sailing, but only when its safe. Under the CDC’s Framework for Conditional Sailing Order, cruise lines have been given a pathway to systematically demonstrate their ability to sail while keeping

passengers, crew and their destination ports safe and healthy,” said former Utah Gov. Mike Leavitt, co-chair of the Healthy Sail Panel.

During the initial phases, cruise ship operators must demonstrate adherence to testing, quarantine and isolation, and social distancing requirements to protect crew members while they


build the laboratory capacity needed to test crew and future passengers. Subsequent phases will include simulated (mock) voyages with volunteers playing the role of passengers to test cruise ship operators’ ability to mitigate COVID-19 risk, certification for ships that meet specific

David Bell, 28, Morgan Ave, Harriman, was charged with Mfg/Del/Sale or Poss. Of Meth.


Deputy Jenkins LCSO 922, was dispatched to Hwy 70 W in reference to 2 males possibly attempting to break into storage units. The caller advised dispatch that shortly after he saw the males he saw a black sedan with a nonworking passenger side tail light leave the scene towards 321. While on scene checking for signs of burglary a vehicle matching that description pulled into the alley between the storage units and the apartments at this address. In this vehicle were: female driver, David Bell, front-seat passenger, a male, back passenger side passenger, and female, back driver

side passenger. Bell and one passenger were sweating despite the cool weather and shaking consistent with the use of a stimulant narcotic. One passenger was lethargic and nodding off during our encounter consistent with the use of an opioid narcotic. While speaking to the occupant's Bell advised that there may be needles in the car used for illegal narcotics. Deputy asked driver for consent to search the car and she advised that she had no

problem with it. During the search, Deputy found 2 clear baggies with approximately .57 grams of a white crystalline substance believed to be meth under the front passenger seat within easy reach of Bell. Bell advised Deputies that it was his meth. Bell also advised that he used

meth about 2 hours before our encounter. Bell is on probation for a drug charge out of Roane County. Bell was transported to jail. Deputies did not find any evidence of any break-ins or attempted break-ins at the storage units. This did happen in Loudon County Tn.

requirements, and return to passenger voyages in a manner that mitigates COVID-19 risk among passengers, crew members, and communities.

"Our member lines are 100 percent committed to helping to protect the health of our guests, our crew and the communities we serve, and are prepared to implement multiple layers of protocols informed by the latest scientific and medical knowledge," said Kelly Craighead, president and CEO of Cruise Lines International Association (CLIA). "We look forward to reviewing the new Order and are optimistic that it is an important step toward returning our ships to service from U.S. ports."

CDC will help ships prepare and protect crew members during the initial phases by:

- establishing a laboratory team dedicated to cruise ships to provide information and oversight for COVID-19 testing,

- updating its color-coding system to indicate ship status,

- updating its technical instructions, as needed, and

- updating the "Enhanced Data Collection (EDC) During COVID-19 Pandemic Form" to prepare for surveillance for COVID-19 among passengers.
