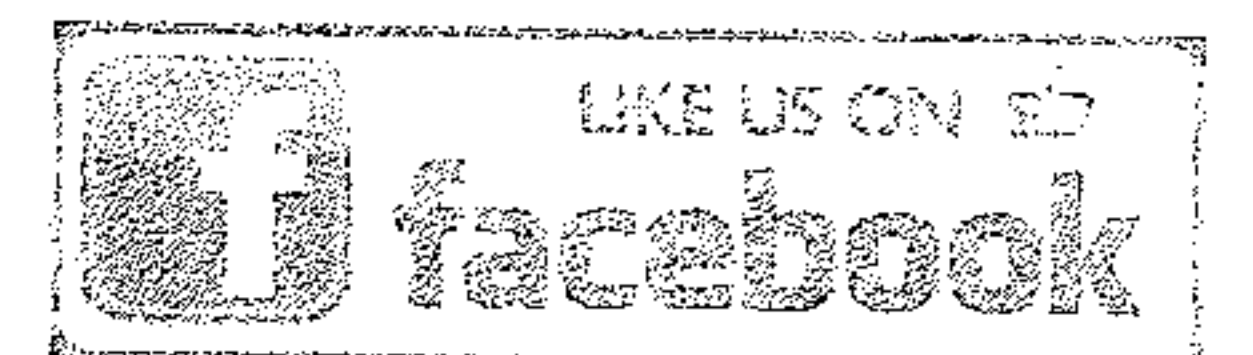

been burglarized. The victim requested that law enforcement check said residence.

Upon officer's arrival Tennessee Ave. Greenback, Deputy heard the sound of what appeared to be footsteps inside the house as Deputy approached. Upon walking upon the wooden porch to check the side entrance, Deputy noticed a door lock faceplate laying on the porch and saw that the door had been forcibly open with the door jam broken.

Deputy immediately advised dispatch and supervisors of what he had discovered and was told to standby for backup. Deputy thus waited and kept watch on the front and side door of the residence. Upon arrival by Cpl. Ernie Brown and with his assistance, the residence

been taken. LCSO Detective Sgt. Chris Bowen responded and processed the scene. Contact was made to the complainant by him where she advised that she would leave Florida as soon as possible. Once she got here and determined what was missing, she would contact Detective Bowen with a complete list.

**Truck Driver**

Johnny Parrott, 55, Indian Mountain Road Jellico, was charged with DUI in Commercial Vehicle, and Violation of Implied Consent.

Officer Espinoza LCPD, was dispatched to a reckless driver traveling on U.S Hwy 321 N. The description dispatched advised was a white Peterbilt truck, pulling an

empty trailer. Officer made contact with the above truck, and while observing the peterbilt for roughly 3 miles. The Peterbilt was traveling on the shoulder on multiple occasions, and swerving in and out of the lanes of travel. Officer conducted a traffic on U.S Highway 321 and White Wing Road. Officer immediately identified the driver as Johnny Ray Parrott. He advised, he had ingested approximately four oxymorphone pills earlier this day. Due to the inconsistent driving Officer observed, he asked Parrott to step out of the vehicle. Parrott willingly agreed to perform a series of SFST's. During the Walk and Turn Test, Parrott used arms for balance, and failed to stop at 9 steps. While performing the one leg stand, the defendant swayed, and put

foot down multiple times. Deputy Green who is a Drug Recognition Expert, asked Parrott to perform a series of test. Shortly after, Deputy Green advised he performed poorly, and believed the defendant was under the influence. Parrott also refused to provide a blood sample. Before concluding his investigation, Officer was able to determine Johnny Ray Parrott was under the influence of an intoxicant. Officer placed him under arrest

and transported him to the Loudon County Jail without incident.

"The Library That Dolly Built," directed and produced by UTK journalism professor and director of Land Grant Films Nick Geidner, and narrated by Danica McKellar, goes behind the scenes of Dolly Parton's Imagination Library to show how one of the most famous and beloved performers in the world has partnered with thousands of local community organizations to develop an efficient and effective program for spreading the love of reading.

Parton created the Imagination Library to inspire a love for books and reading amongst the nation's preschool children. Since its inception in 1995, the Imagination Library has grown into a global endeavor and recently hit a new milestone, gifting

its 150 millionth book.

Dolly Parton said, "I am so excited that we can finally tell the whole story of the Imagination Library. It is certainly not just about me. Our story is the story of children, of families and communities who all share the dream to inspire kids to love to read and to love to learn. My hope is this documentary will encourage more towns, more states, and even more countries to jump onboard. One thing is for sure, I think this is the best investment I have ever made!"


Imagination Library started as a gift for the children in Dolly's hometown of Sevierville, Tennessee, and is now active in all 50 states, and five countries, gifting 1.7 million free, age-appropriate books to children every month. The film also provides a glimpse of the profound impact the Imagination Library has on

the people through original interviews with authors, policymakers, Imagination Library staff, recipients, and the legend herself, Dolly Parton. Woven throughout the film is a biographical sketch of Dolly Parton, featuring rare photos and films from her childhood. Unlike most biographies of Dolly,

it doesn't focus on her music. Instead, it demonstrates that at every point in her career, any time she has had success, Dolly Parton has returned home to Sevierville to give back to her people.

commented Knox County Mayor Glenn Jacobs. "The Knox County Public Library, which administers the local program, has been integral to the development of the project, aiding Dr. Geidner along the way. Many of the scenes were filmed in our libraries and with local families. This is such a great program that truly supports early literacy in the tangible way. We can't teach children to learn to read if they don't have books in their homes. Dolly Parton is brilliant, and we are immensely grateful for her vision and generosity."

The Imagination Library affiliate in Knox County launched 16 years ago with the help of former Governor Phil Bredesen, Mayor Mike Ragsdale, and Mayor Bill Haslam. Today, it has mailed out 3,250,000 million books to 60,000 children. The program boasts one of the highest per capita registrations of any urban program in the world.

## Obituaries

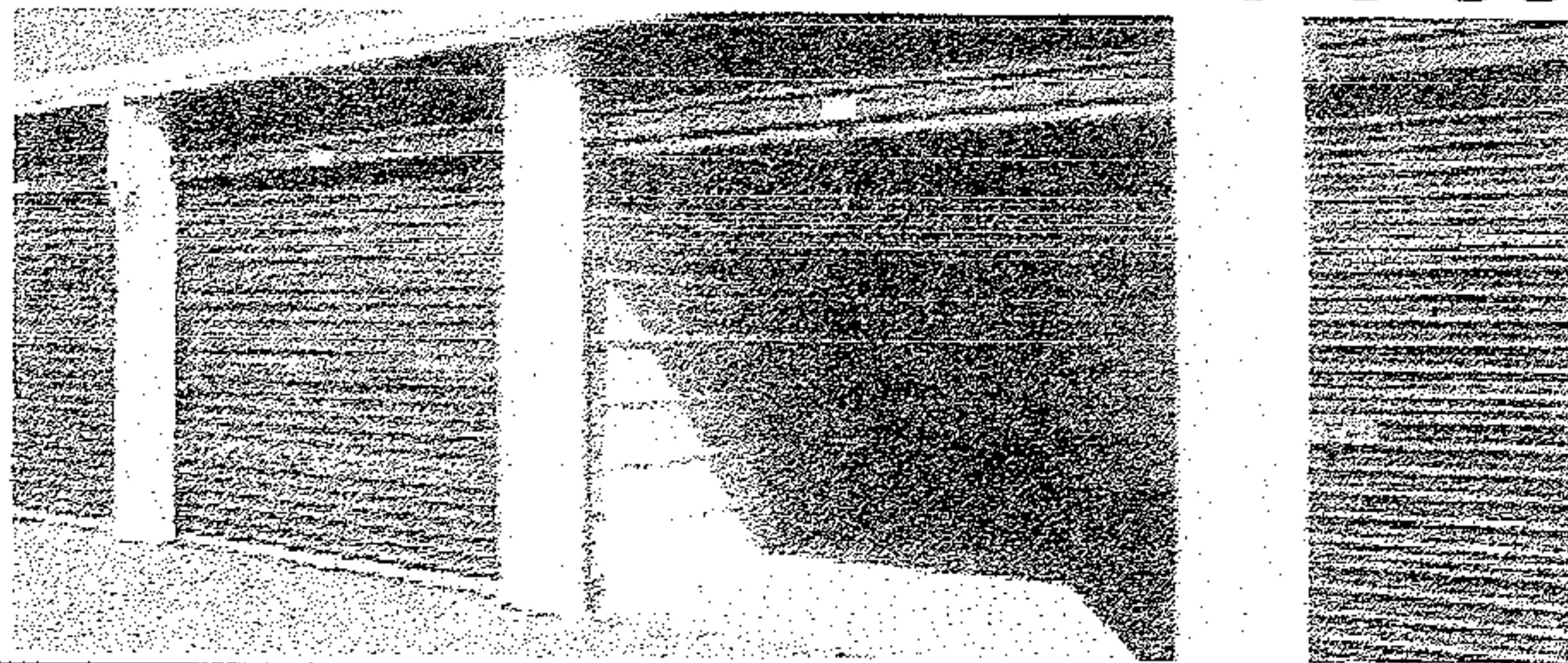
Dr. Thomas DeCoursey Pryse, DMD, of Knoxville, Tennessee passed away on November 30, 2020 nearly reaching the age of 97 years old. He died peacefully at home with his beloved wife, Mary, by his side. Tom was born in Beattyville, Kentucky on December 26, 1923 to Roscoe and Sammie Belle Pryse. They later moved to Clinchmore, TN where his father was the doctor for the mining community. Tom graduated from Tennessee Military Institute in 1940 then went to Vanderbilt University for his undergraduate work. He then graduated from the University of Louisville School of Dentistry with a DMD. In 1949 he married his sweetheart, Mary Elaine Hargis, and they spent 71 love-filled years together. They have three children (Tandy, Thomas Jr, and Tegwyn), 8 grandchildren, and 13 great grandchildren. He loved watching his children show horses and ride around the family farm, cheering for UT football, and keeping up with the Atlanta Braves. Tom and Mary were world travelers both with friends and through the International College of Dentists. Working into his late 70s, Dr. Tom Pryse was a pillar in the orthodontic community. He began practicing in Knoxville with Dr. Bowyer in 1953, after serving in the Air Force as Chief of Orthodontics on his base. He later brought his nephew Dr. John C. Pryse, Jr into the practice, and they worked together for 40 years. Dr. Pryse was a member of the American Association of Orthodontics, the American Dental Association, The Second District Dental Society, and the Pierre Fauchard Academy. He is a fellow of the International College of Dentists and the American College of Dentists.

He has served as president of the Second District Dental Society, the Southern Association of Orthodontists, the Tennessee Society of Orthodontists, and the Tennessee Dental Association. Some of his many professional awards include: Fellowship Award, Tennessee Dental Association; Man of Year, Second District Dental Society; Man of Year, Pierre Fauchard Academy, Tennessee Section; Distinguished Service Award, Tennessee Association of Orthodontists; The Oren A. Oliver Distinguished Service Award, Southern Association of Orthodontists; Honorary Graduate of the University of Tennessee Department of Orthodontics for Contributions to Orthodontics; Dr. Frank P. Bowyer Service to Dentistry Award, Second District Dental Society; and the Dr. Jack Wells Memorial Dedication to Dentistry Award. He was a member of St. John's Episcopal Cathedral, the Knoxville Welsh Society, Rotary Club of Knoxville, Masonic bodies-Blue Lodge, York Rite, Scottish Rite, Kerbela Shrine Royal Order of Jesters, and the Public Health Council of the State of Tennessee. Dr. Pryse was not only accomplished but also loved by all who

knew him. He was the embodiment of kindness and generosity, and he will be dearly missed. He is preceded in death by his parents, Dr. Roscoe Pryse and Sammie Belle Pryse; his brother and sister in law Dr. John C Pryse, Sr and Joann Lusby Pryse of LaFollette. He is survived by his loving wife, Mary; children Tandy Lacy (Richard), Thomas D. Pryse, Jr., Tegwyn Pryse; grandchildren Mary Helen Posch (Timothy), John Thomas Lacy, Jake Lacy (Emily), Thomas "Trey" D.
