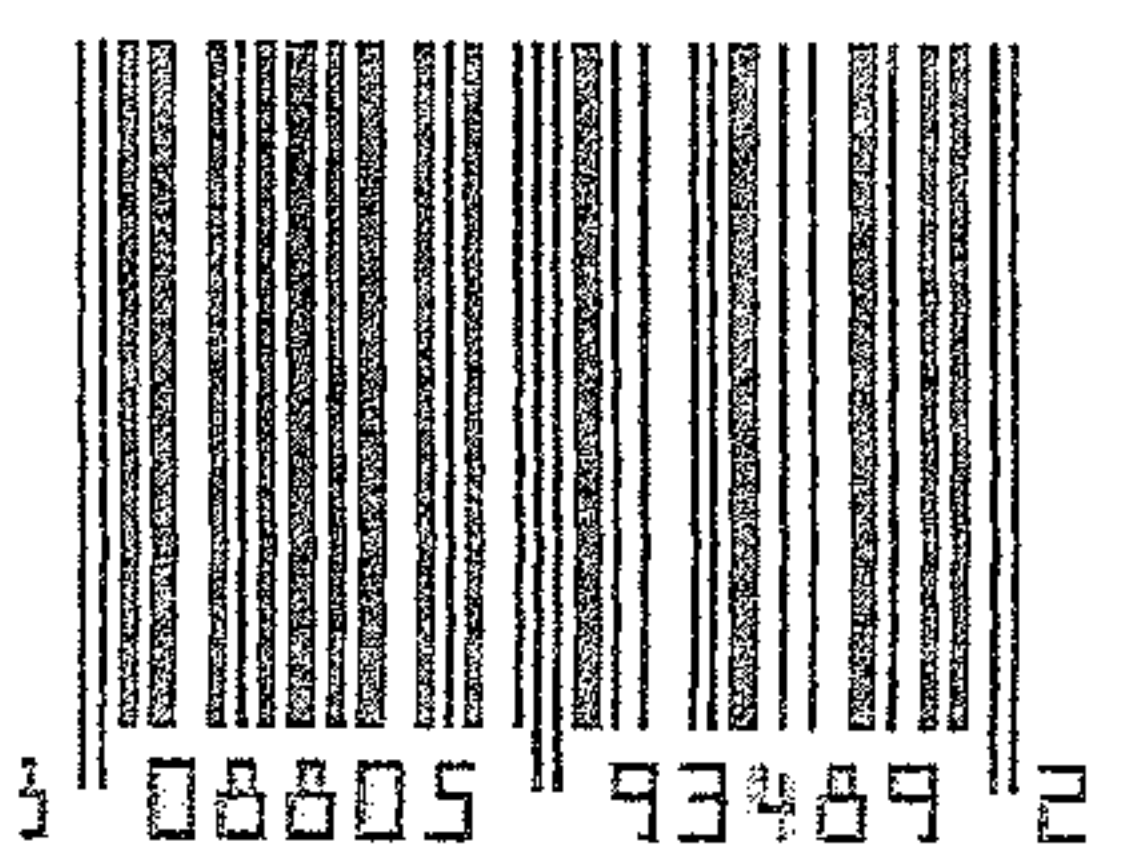

complainant stated she observed a white Porsche traveling at a high rate of speed and failing to maintain it's a lane. Deputy made contact with a vehicle matching the complainant's description in Wendy's parking lot, then followed the vehicle as it traveled south on Hwy 72. While observing the Porsche Deputy did view it cross the center line numerous times and even traveled into the ditch line. Deputy initiated a traffic stop prior to the Landfill and the vehicle continued on without breaking. Deputy then activated his siren and the vehicle finally came to a stop at Prospect Church Rd. Upon contact with the driver, identified as Brittany Irick, Deputy immediately smelled a strong odor of an alcoholic beverage coming from her person. Deputy also viewed two young girls in the back seat who the defendant stated were her daughters. Deputy had the defendant exit the vehicle for further questioning at which time she stated she had been at a bar in Knoxville where she consumed 5-6 alcoholic beverages before bringing her kids home. Irick could not walk back to my vehicle without losing her balance nor stand upright without leaning against the vehicle. Irick did consent to S.F.S.T and performed so poorly Deputy terminated the test during the walk and turn for her safety. Deputy attempted to wait till the children were removed from the scene by a

guardian to physically arrest Irick but due to her actions becoming progressively aggressive Deputy had no other option but to remove her from the scene. Deputy did take Irick into custody for D.U.I and Child Endangerment then read the Implied Consent Advisement multiple times to which she refused to answer. Deputy

also cited the defendant with Roadways Laned for Traffic and Violation of Implied Consent. Deputy then transported the defendant to the Loudon County Jail. Said did occur in Loudon County, TN.
