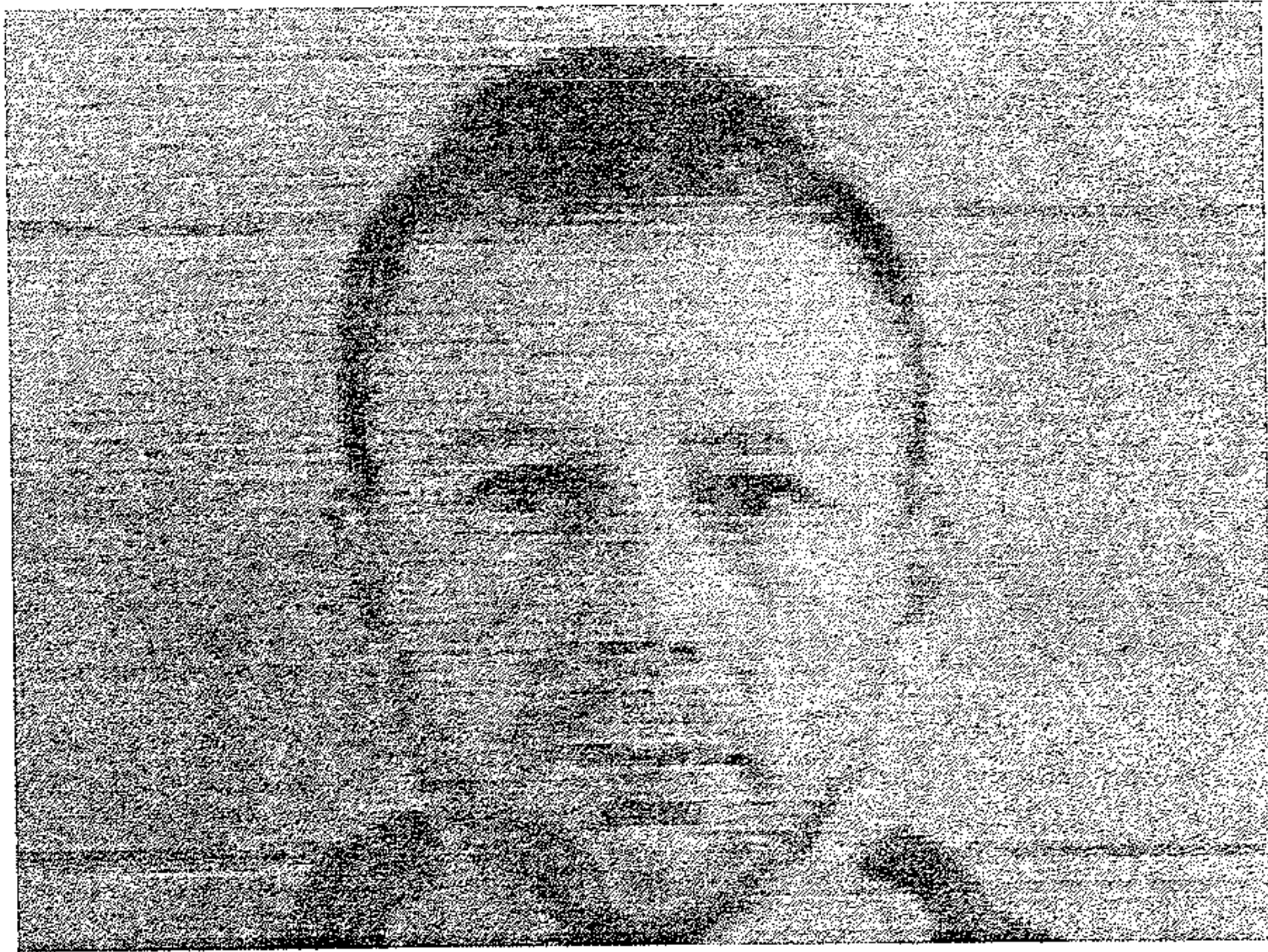

Former Chattanooga Police Officer Sentenced To 20 Years In Prison For Sexual Assault

Desmond Logan, 35, a former officer with the Chattanooga Police Department (CPD), was sentenced by the Honorable Curtis L. Collier, U.S. District Court Judge in the Eastern District of Tennessee at Chattanooga.

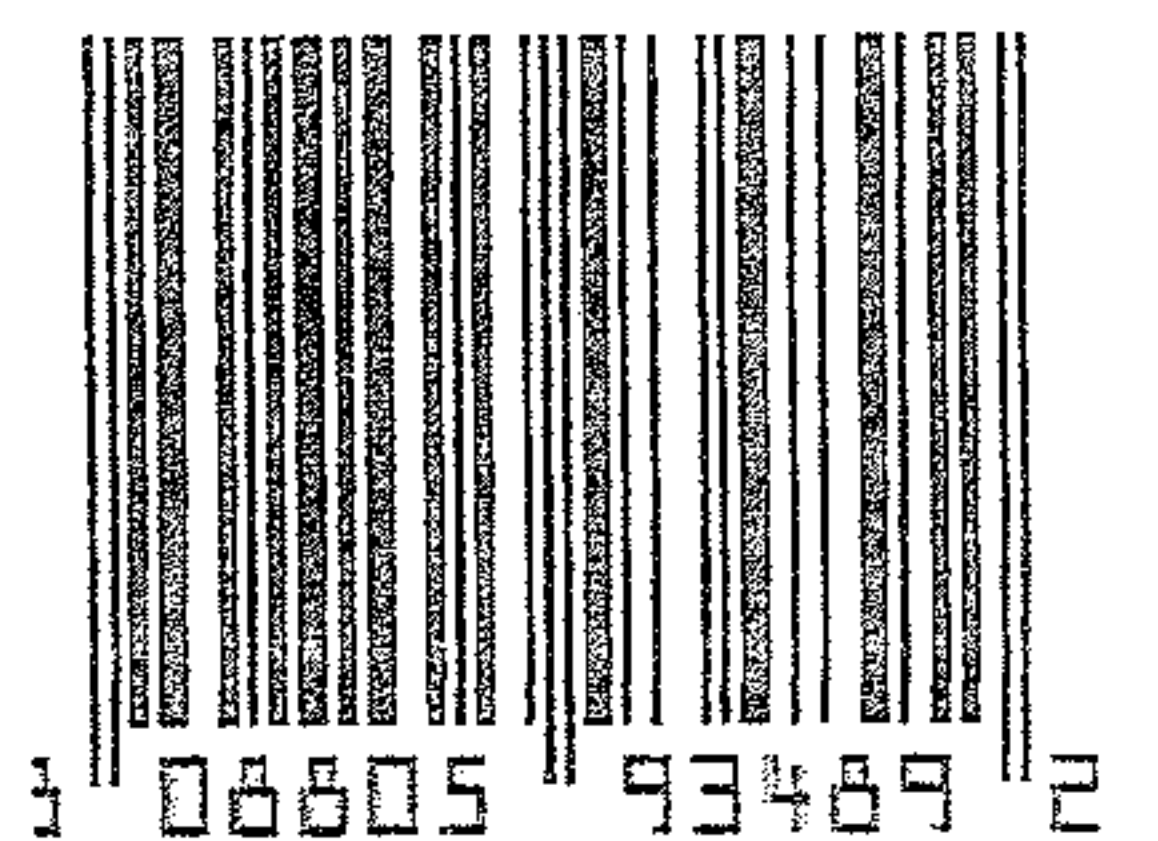
Logan will serve 20 years in prison, the maximum sentenced permitted under the law, followed by three years of supervised release, for crimes involving sexual mis-

conduct while on duty. Logan previously pleaded guilty to two civil rights offenses on September 12, 2019. Logan will be required to register with the sex offender registry in any state in which he resides, works, or attends school, and comply with special sex offender conditions during the supervised release.

According to court documents filed in connection with the defendant's guilty plea,

the first offense occurred during the early morning hours of June 12, 2018. The defendant, while on duty as a CPD police officer, handcuffed and arrested K.B.V. Rather than transporting K.B.V. directly to the Hamilton County Jail, the defendant drove K.B.V. in his squad car to an empty and isolated parking lot. There, the

John Davis, 27, Homeless Lenoir City, was charged with Violation of Probation, Driving on Revoked/Suspended License, Tampering/Fabricating with Evidence, and Simple Possession.

Peggy Wilson, 50, Beaty Chapel Road Tellico Plains, was charged with Tampering/Fabricating with Evidence, Simple Possession, and Assisting other Agency.

Deputy Clay Jenkins LCSO, conducted a traffic stop on a black Ford Fusion for the display of registration plates as the registration and the date of expiration was unreadable on I-75 NB 80.2 MM. Deputy then made contact with driver John Davis Jr. who advised the tag was damaged due to rainfall and he would get a new registration tomorrow. When asked if anything illegal was inside of the vehicle, Mr. Davis advised he had a set of scales and rolling paper used for marijuana but advised he had no narcotics inside of the vehicle. Deputy then made contact with the passenger and owner of the vehicle Peggy Wilson who advised that there should be nothing illegal in the vehicle, but she may have a warrant out of Monroe County. Consent to search the vehicle was then given by the owner Peggy Wilson and the operator John Davis. Upon search of the vehicle, then observed an Mtn. Dew can in the center console with a clear plastic baggy. Upon retrieving the clear plastic baggy from the can, Deputy then found a white crystal-like substance (methamphetamine) inside of the

baggy weighing approximately 0.3 grams. Besides the can of Mtn. Dew also in the center console, was a needle inside of a white styrofoam cup. Mr. Davis and Ms. Wilson both advised the methamphetamine was not there's but was located between them. Ms. Wilson did advise the Mtn. Dew was her's but knew nothing about the meth. Upon further investigation, it was found Mr.

Davis had a suspended driver's license and also had one active local Loudon County warrant for Violation of Probation. It was also found that Ms. Wilson had one active Monroe County warrant for failure to appear on narcotic charges. Both were then taken into custody and transported to the Loudon County Jail without incident. All of this did occur in Loudon County, TN.

Mark Goedeke, 57, Echo Hollow Road Lenoir City, was charged with DUI, Violation of Implied Consent, and Driving on Roadway Laned for Traffic.

Deputy Chance Gray LCSO, observed a silver Dodge Dakota traveling on Highway 70 cross the yellow line multiple times, and swerving all the way into the turn lane at the intersection of highway 11 and 70. Deputy then initiated traffic stop on the vehicle at the Shell station at Dixie Lee Junction. Upon stop Deputy made contact with the driver Mark H. Goedeke. While speaking with Mr. Goedeke Deputy noticed him to have blood shot watery eyes and slurred speech. Deputy then asked Mr. Goedeke where he was going, to which he stated work and that he was supposed to be there at 7:00 am, and the time of the question was approximately 8:55 Pm. Mr. Goedeke was asked if he had had anything to drink to which he stated two shots of fireball before he went to bed.

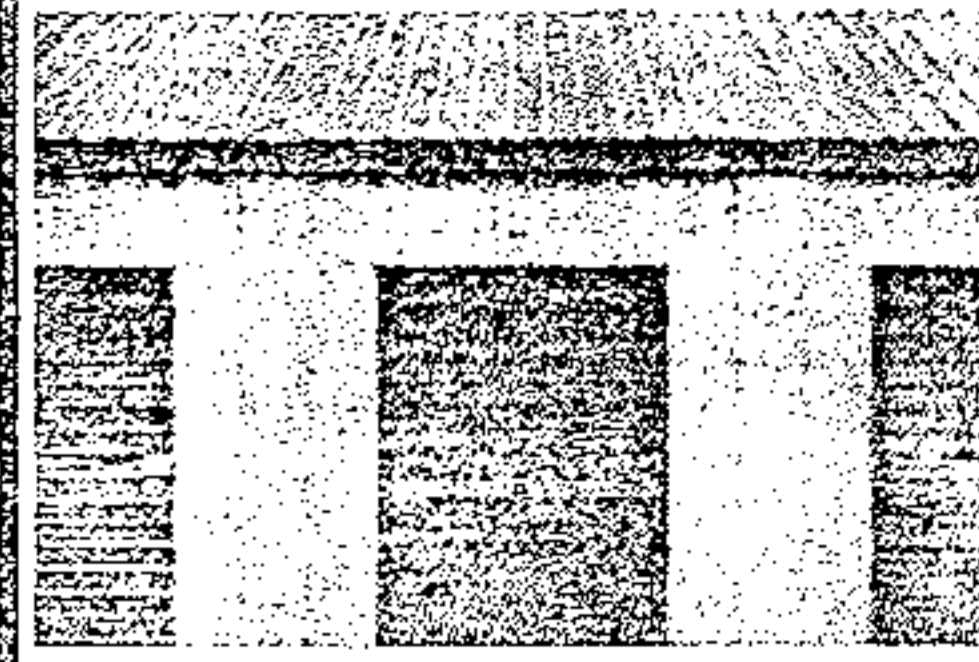
Seth Etie, 39, County Road 713 Athens, was charged with DUI, Simple Possession x2, Poss. Of Drug Para., Open Container, Driving on Revoked/Suspended License, Exercise Due Care, and No Proof of INS. Trooper Louis Guillebeaux THP, was dispatched to a crash with injury at Steekee Road. Upon arrival Trooper observed a silver vehicle that was down an embankment. The vehicle had struck several mailboxes, a guard-rail, and a fence. A Loudon County Deputy explained to Trooper that Narcan had to be used on the driver because he was unresponsive. While inventorying the vehicle Sgt. Woody THP, located a bottle of pills without a prescription label. A glass marijuana pipe, and a small container with marijuana inside. Trooper also found an open container of beer that was over half

empty. The driver identified as Seth Etie was transported to UT Medical. Trooper arrived at UT Medical, and attempted to perform a field interview with Etie, who admitted to taking one Xanax, and drinking alcohol. Trooper had Etie perform sobriety test which he did poorly on. Once Etie was cleared by medical he was transported to the Loudon County Jail.

defendant sexually assaulted K.B.V.

The second offense occurred on the evening of January 2, 2016. The defendant, while working a security detail at the University of Tennessee in Chattanooga, entered the passenger seat of D.H.'s car and asked for a ride to his own car, which he claimed was parked in a different parking lot. The defendant then directed D.H. to an empty and isolated parking lot. Logan took out his taser and put it against D.H.'s leg, causing D.H. to fear that he would cause her further physical harm. When D.H. tried to escape, Logan prevented her from getting out of the car.

In addition to these two offenses, the defendant admitted as part of his guilty plea that he sexually assaulted two other women. In each instance, one on July 31, 2015 and the other on May 30, 2016, the defendant arrested each victim, and instead of transporting her to jail, drove her to a deserted area where he sexually assaulted her.

"The Department of Justice will vigorously prosecute officers who commit sexual assault," said Assistant Attorney General Eric Dreiband of the Civil Rights Division. "This case is a reminder that sexual assault allegations involving law enforcement officers should be fully investigated. The Department will continue to take such allegations seriously and work to vindicate the Constitutional rights of those who are victimized by officers acting under color of law."

"The actions of Desmond Logan jeopardized public safety and violated the trust of the citizens of Chattanooga he swore to protect. This case exhibits our continued efforts to prosecute those who would abuse their authority to commit acts of violence and injustice against members of our community," said U.S. Attorney J. Douglas Overbey of the Eastern District of Tennessee. "Our office will continue to stand by and protect the victims of such crimes."

"Civil Rights violations, particularly when they involve a member of law enforcement,

are of tremendous concern," said Special Agent in Charge Joe Carrico of the FBI's Knoxville Field Office. "The entire law enforcement profession is tarnished when an officer betrays the oath to protect and serve. The FBI will vigorously investigate any officer or agent of the law who is breaking the rules that he or she is sworn to uphold or is violating the civil rights of others."

This case was investigated by the Knoxville Division of the FBI, with the support of the Hamilton County Sheriff's Office. Assistant United States Attorney James Brooks of the Eastern District of Tennessee and Special Litigation Counsel Fara Gold and Trial Attorney Olimpia Michel of the Criminal Section of the Civil Rights Division of the U.S. Department of Justice prosecuted the case.

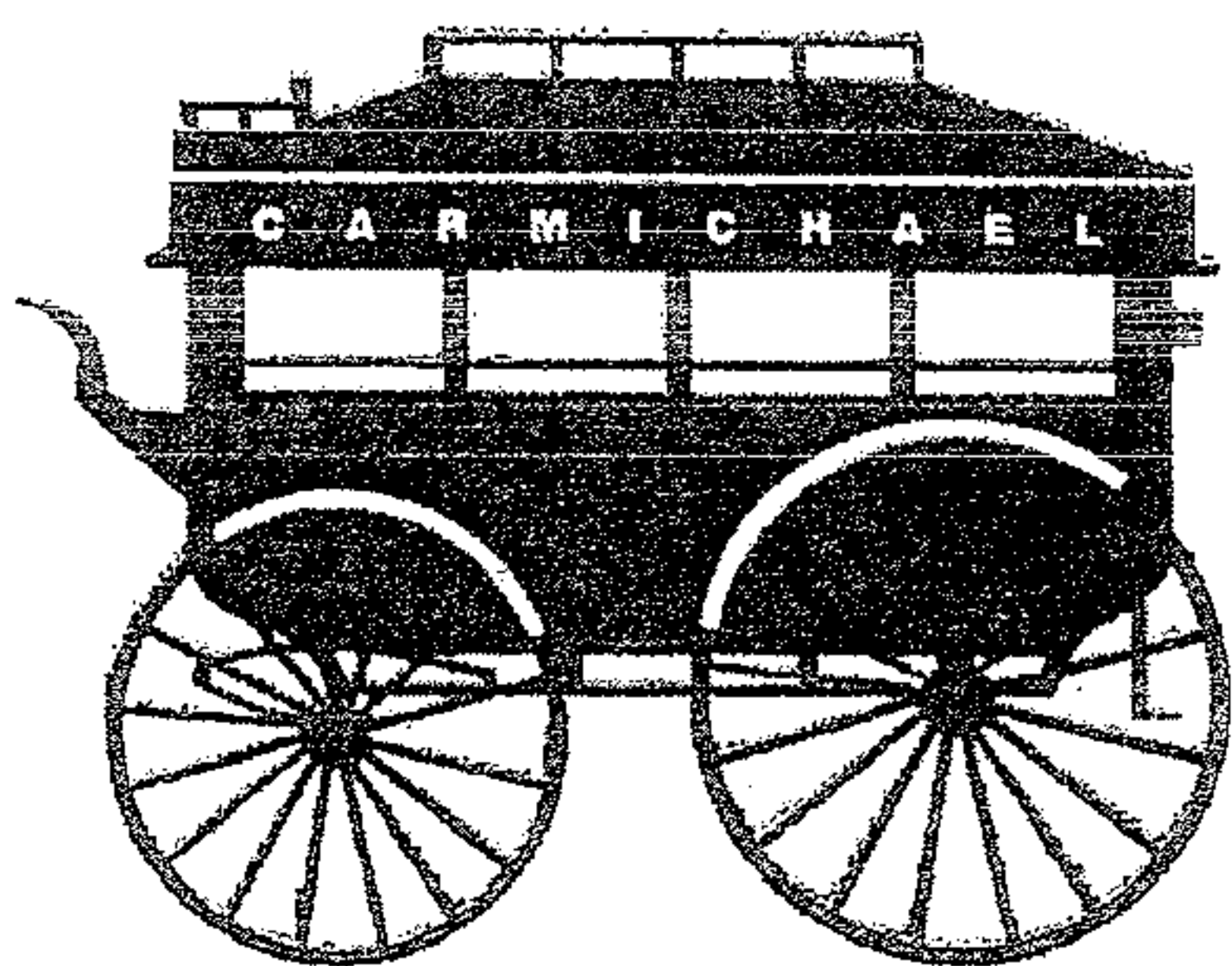

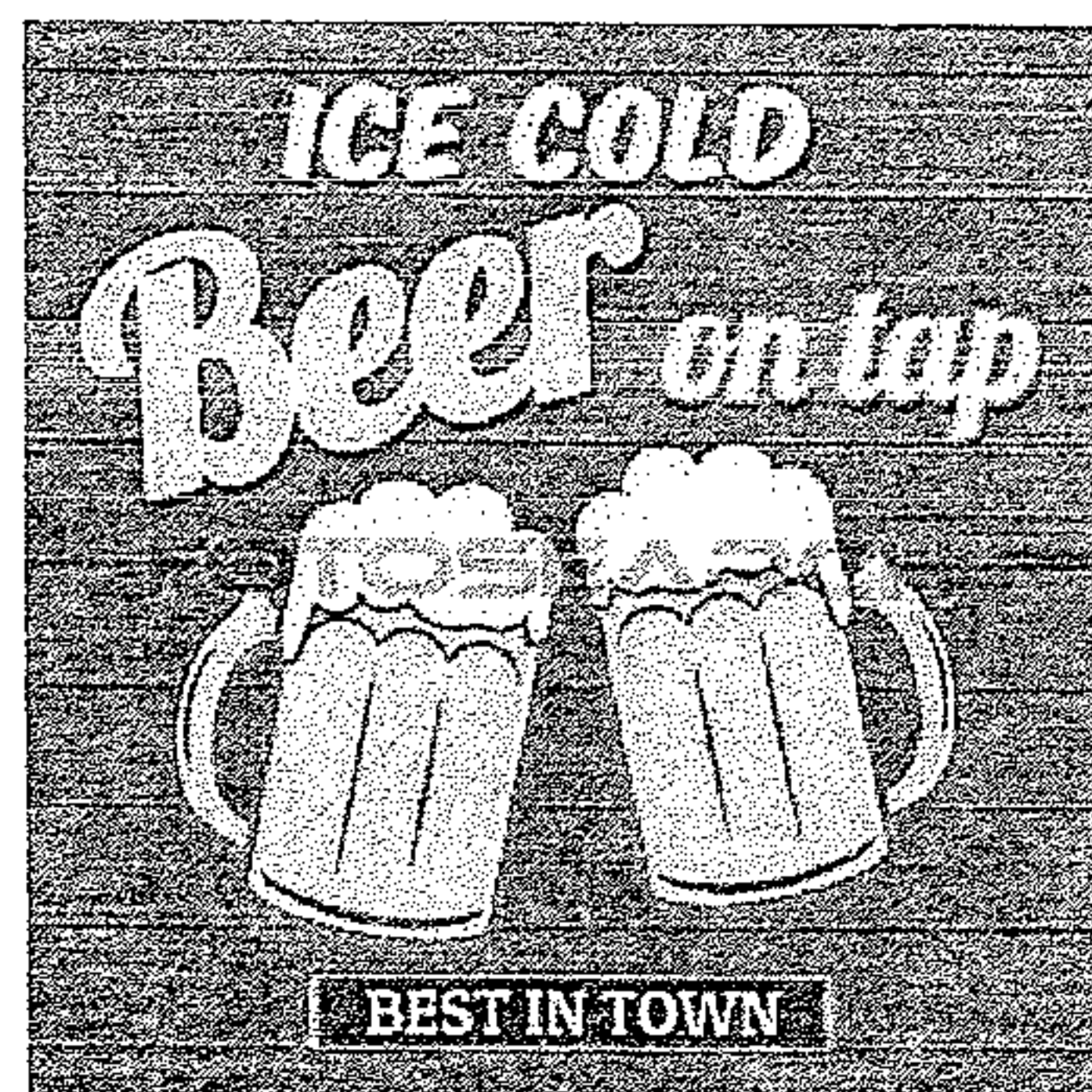

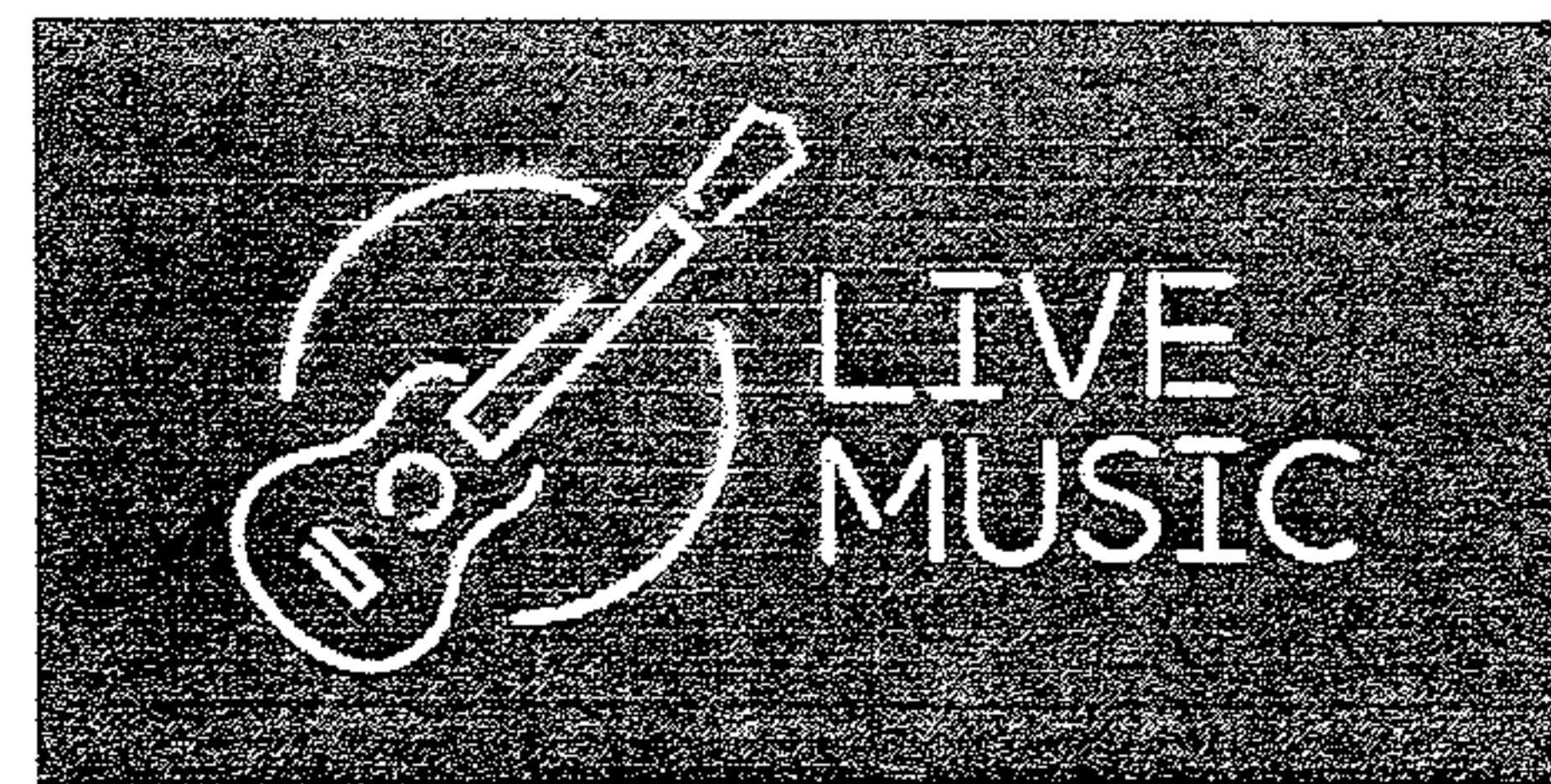
