





### DUI

Laned for Traffic. Deputy Rogers LCSO observed a van pass by his vehicle traveling on Hwy 11. The driver ducked making an attempt to hid his face as he passed. While following the vehicle Deputy observed it cross the center line several times while traveling on Ford Rd. Deputy initiated a traffic stop on Ford Rd in the area of Dewitt Rd.

Upon contact with the driver, he was very nervous and agitated. The driver displayed very rigid moments, chewing/grinding his teeth, and had sores consistent with narcotic use. Deputy identified the driver as Joseph Duggan who stated he was leaving a friend's house on Pardue Ln and was heading home. Mr. Duggan did state there was a marijuana bowl in the back seat and did not believe there was any other narcotics or paraphernalia within the vehicle.

While searching the vehicle Deputy did locate a backpack behind the driver's seat that had a syringe, a spoon with burnt residue, a lighter, and a razor blade all together within another zippered container as well

as the marijuana bowl.

After running Mr. Duggan's information through Dispatch it was confirmed that he had an active Criminal Court Failure to Appear warrant on a Violation of Probation out of Roane County. Mr. Duggan stated he was on Probation for meth charges and Deputy detained him at that time until the vehicle search was completed.

Deputy then read the offender his rights and he did consent to S.F.S.T and A.R.I.D.E testing. Mr. Duggan did display signs of narcotic impairment and did not perform satisfactorily on the tests. Deputy then placed Mr. Duggan under arrest for Driving Under the Influence and his Roane Co. warrant. Deputy then read Tennessee Implied Consent to the offender who stated he did understand the advisement but refused a blood draw.

Deputy also cited Mr. Duggan with Violation of Implied Consent, Possession of Drug Paraphernalia, and Driving on Roadways Laned for Traffic. Said did occur in Loudon County, TN.



### Theft

The investigation found that Combs used several schemes misappropriate school money and conceal her activities.

Investigators discovered that Combs used a checkswap scheme to steal cash. For example, she received a \$600 check from a business for a promotional banner to be displayed at athletic events. She did not issue a receipt for the check or record it in the school accounting system. Instead, Combs exchanged the check for cash from other school collections – effectively "cashing" the check through the collection drawer for her own personal use.

Combs also altered school records and manipulated receipts for school cash collections to conceal her misappropriation of cash. In all, investigators found that Combs stole \$34,754 in cash.

Additionally, Combs used

for personal purchases totaling \$643. These purchases included wine, a kitchen blender, and various food items. Investigators are also questioning more than \$7,000 in other purchases of mostly food and other grocery items that can't be definitively tied to Combs.

In July 2020, the Grainger County Grand Jury indicted Valerie Anne Combs on one count of theft over \$10,000.

"There were several weaknesses within the school's financial processes that allowed this theft to go undetected for several years," said Comptroller Justin P. Wilson. "The former bookkeeper was largely responsible for nearly all the financial activities of the school, and school officials failed to ensure deposits were made intact or review charge card statements and invoices prior to payment."

CDC Expects 2020 Outbreak of Life-Threatening Acute Flaccid Myelitis

Doctors urged to quickly recognize symptoms and to hospitalize patients immediately

The Centers for Disease Control and Prevention (CDC) anticipates that 2020 will be another peak year for cases of acute flaccid myelitis (AFM), an uncommon but serious neurologic condition that affects mostly children. The disease has peaked every two years between August and November in the

United States since 2014. Enteroviruses, particularly enterovirus-D68 (EV-D68), are likely responsible for these peaks in cases.

CDC released a new CDC Vital Signs report to alert health care providers to a possible outbreak this year. This Vital Signs report reveals a delay in care for some patients in 2018: 35% of patients were not hospitalized until two or more days after limb weakness. AFM can progress rapidly over the course of hours or days, leading to permanent paralysis and/or the life-threat-


ening complication of respiratory failure in previously healthy patients, so delays in care can be serious.

This Vital Signs report is intended to provide an anticipatory alert as we prepare for a possible outbreak this year.

Parents and doctors should suspect AFM in patients with sudden limb weakness, especially during August through November. Recent respiratory illness or fever and the presence of neck or back pain or any neurologic

symptom should heighten their concern.

Pediatricians and frontline providers in emergency departments and urgent care centers should be prepared to quickly recognize symptoms of AFM and immediately hospitalize patients. Timing is critical at each step-prompt AFM recognition leads to optimal medical management and early specimen collection. When health care providers recognize symptoms as soon as possible, there is a better chance of detecting the cause of AFM, which might help predict the outcome. Other laboratory tests and an MRI of the brain and spinal cord can distinguish AFM from other conditions with limb weakness.




