

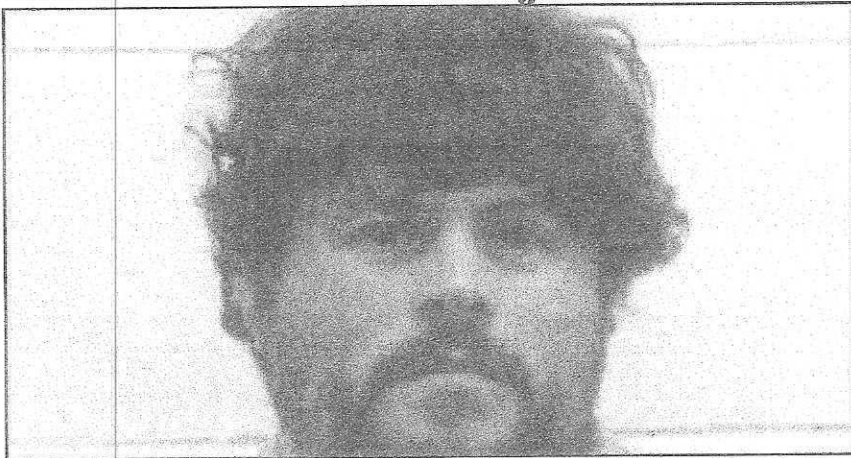

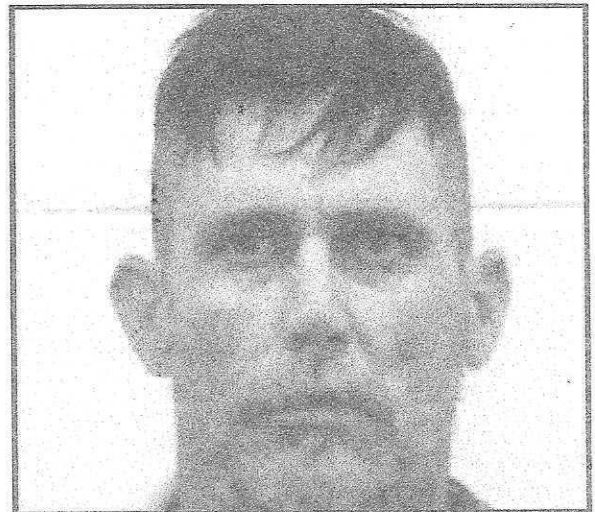

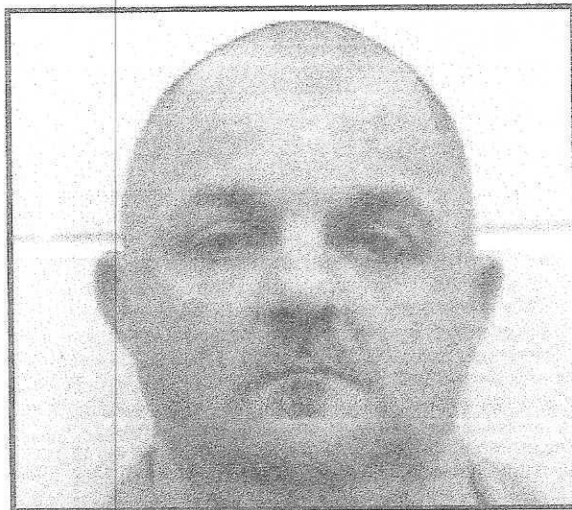

## Leader of Oath Keepers and 10 Other Individuals Indicted in Federal Court for Seditious Conspiracy and Other Offenses Related to U.S. Capitol Breach

### Eight Others Facing Charges in Two Related Cases

A federal grand jury in the District of Columbia returned an indictment yesterday, which was unsealed today, charging 11 defendants with seditious conspiracy and other charges for crimes related to the breach of the U.S. Capitol on Jan. 6, which disrupted a joint session of the U.S. Congress that was in the process of ascertaining and counting the elec-

toral votes related to the presidential election.

According to court documents, Elmer Stewart Rhodes III, 56, of Granbury, Texas, who is the founder and leader of the Oath Keepers; and Edward Vallejo, 63, of Phoenix, Arizona, are being charged for the first time in connection with events leading up to and including Jan. 6. Rhodes was arrested this morning in Little Elm, Texas, and Vallejo was

arrested this morning in Phoenix.

In addition to Rhodes and Vallejo, those named in the indictment include nine previously charged defendants: Thomas Caldwell, 67, of Berryville, Virginia; Joseph Hackett, 51, of Sarasota, Florida; Kenneth Harrelson, 41, of Titusville, Florida; Joshua James, 34, of Arab, Alabama; Kelly Meggs, 52, of

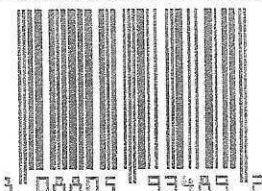

### Veh. Assault

Christopher Petty, 36, Lindner Lane Lenoir City, was charged with Vehicular Assault, and DUI.

Deputy D Slemple LCSO, was dispatched to a wreck with injury at Ford Road, Lenoir City TN. When Deputy arrived at 20:38, he made contact with Christopher Petty (OFFENDER) who stated he was driving his vehicle when he hit a patch of ice and lost control of his vehicle. The vehicle traveled through a board fence next to the roadway, resulting in significant damage to the vehicle and fencing. Mr. Petty also had three children in the vehicle with him, one being his biological daughter. One victim suffered had a laceration to her forehead with bleeding and complained of pain in her right arm, requiring evaluation and treatment at a medical facility. She

was attended to by Priority EMS on scene and released to the fiancé of the offender. Upon interviewing Mr. Petty, Deputy noted the smell of alcoholic beverage emanating from his person. Deputy asked Mr. Petty if he had been drinking alcohol and he denied doing so. In addition, Dep A. McCoy also made contact with Mr. Petty and noted the same strong smell of alcoholic beverage emanating from the offender. Mr. Petty was asked on two separate occasions if he would perform Standardized Field Sobriety Tests and he refused on both occasions. Due to the totality of circumstances, Mr. Petty was placed under arrest at 21:06 for the suspicion of DUI and vehicular assault. Mr. Petty was read the implied consent form and refused to submit blood or breath sample. Due to exigent circumstances,

Deputy obtained a search warrant for a blood sample which was signed by Judge Sledge at 22:35. Mr. Petty was transported to Fort Loudon Medical Center for blood draw which occurred at 23:23. Mr. Petty was then transported to the Loudon County Justice Center without incident. Said did occur in Loudon County, TN.

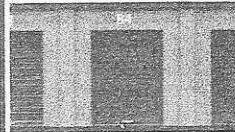

Kevin Cress, 39, Corinth Church Road Loudon, was charged with Joy Riding, and Vandalism.

Deputy Eric Curtis LCSO, responded to Corinth Church Rd in Loudon, TN in reference to a vehicle theft. Upon arrival, Deputy made contact with the victim/complainant. She stated that her son, Kevin Cress, was sitting in her truck listening to the radio because he cannot listen to it in the house without causing problems. Cress had been told multiple times that he was not allowed to drive the truck anywhere, and he had also been told that his license was revoked. Shortly before contacting dispatch, the victim reported that Cress started the vehicle and drove it recklessly out of the driveway and onto the road, nearly striking

a post office delivery worker. The victim attempted to call Cress multiple times, and was ignored each time. The victim stated that Cress had an address in Paint Rock that he would go to often in order to purchase methamphetamine, and she also knew that he had no money to speak of. Due to the danger presented by the suspect's behavior, his multiple reason not to drive the vehicle, and his erratic behavior described by the victim, Deputy issued a warrant for Joyriding in this incident. 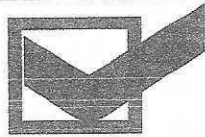

Dunnellon, Florida; Roberto Minuta, 37, of Prosper, Texas; David Moerschel, 44, of Punta Gorda, Florida; Brian Ulrich, 44, of Guyton, Georgia and Jessica Watkins, 39, of Woodstock, Ohio. In addition to the earlier charges filed against them, they now face additional counts for seditious conspiracy and other offenses.

Eight other individuals affiliated with the Oath Keepers, all previously charged in the investigation, remain as defendants in two related cases. All defendants – except Rhodes and Vallejo – previously were charged in a superseding indictment. The superseding indictment has now effectively been split into three parts: the 11-defendant seditious conspiracy case, a seven-defendant original case, and a third case against one of the previously charged defendants.

In one of the related cases, the original superseding indictment, charges remain pending against James Beeks, 49, of Orlando, Florida; Donovan Crowl, 51, of Cable, Ohio; William Isaacs,

22, of Kissimmee, Florida; Connie Meggs, 60, of Dunnellon, Florida; Sandra Parker, 63, of Morrow, Ohio; Bernie Parker, 71, of Morrow, Ohio, and Laura Steele, 53, of Thomasville, North Carolina. The other case charges Jonathan Walden, 57, of Birmingham, Alabama.

The three indictments collectively charge all 19 defendants with corruptly obstructing an official proceeding. Eighteen of the 19 defendants – the exception is Walden – are charged with conspiring to obstruct an official proceeding and conspiring to prevent an officer of the United States from discharging a duty. Eleven of the 19 defendants are charged with seditious conspiracy. Some of the defendants are also facing other related charges.


As alleged in the indictments, the Oath Keepers are a large but loosely organized collection of individuals, some of whom are associated with militias. Though the Oath Keepers will accept anyone as members, they explicitly focus on recruiting current and former military, law enforcement and first-respond-

er personnel. Members and affiliates of the Oath Keepers were among the individuals and groups who forcibly entered the Capitol on Jan. 6, 2021.

The seditious conspiracy indictment alleges that, following the Nov. 3, 2020, presidential election, Rhodes conspired with his co-defendants and others to oppose by force the execution of the laws governing the transfer of presidential power by Jan. 20, 2021. Beginning in late December 2020, via encrypted and private communications applications, Rhodes and various co-conspirators coordinated and planned to travel to Washington, D.C., on or around Jan. 6, 2021, the date of the certification of the electoral college vote, the indictment alleges. Rhodes and several co-conspirators made plans to bring weapons to the area to support the operation. The co-conspirators then traveled across the country to the Washington, D.C., metropolitan area in early January 2021.

According to the seditious conspiracy indictment, the defendants conspired through a variety of manners and means,


including: organizing into teams that were prepared and willing to use force and to transport firearms and ammunition into Washington, D.C.; recruiting members and affiliates to participate in the conspiracy; organizing trainings to teach and learn paramilitary combat tactics; bringing and contributing paramilitary gear, weapons and supplies – including knives, batons, camouflaged combat uniforms, tactical vests with plates, helmets, eye protection and radio equipment – to the Capitol grounds; breaching and attempting to take control of the Capitol grounds and building on Jan. 6, 2021, in an effort to prevent, hinder and delay the certification of the electoral college vote; using force against law enforcement officers while inside the Capitol on Jan. 6, 2021; continuing to plot, after Jan. 6, 2021, to oppose by force the lawful transfer of presidential power, and using websites, social media, text messaging and encrypted messaging applications to communicate with co-conspirators and others.





**5th DUI**

Kevin Bluford, 39, Barrier Drive Loudon, was charged with DUI, Driving on Revoked/Suspended License, Violation of Implied Consent, Ignition Interlock Devices, Financial Responsibility Law, and Driving on Roadways Laned for Traffic.

Deputy Bengel LCSO, responded to Hwy 11 at Shaw Ferry Rd for a motorcycle wreck. The caller stated that he watch a motorcyclist wreck into a pole and land in a yard. The caller stopped to help and witnessed the motorcyclist attempting to flee the scene but was unsuccessful and wrecked the bike again in the yard. Deputies Tinnell and Brewer arrived on scene and found the Offender/Kevin Bluford in the roadway on Shaw Ferry attempting to leave the scene. Upon arrival, Deputy observed the wrecked Suzuki in the grass and Bluford, who was unsteady on his feet. When Deputy approached Bluford, he could smell a strong odor of an alcoholic beverage coming from his person, he had slurred speech and bloodshot eyes. While speaking to Bluford, he became hostile and made a spontaneous utterance telling Deputy to take him to jail

for DUI and that he "messed up". Deputy asked Bluford to consent to SFST to which he refused and stated he had multiple DUI's and was not going to comply. Bluford was asked multiple times to consent to SFST but refused. Bluford was taken into custody and read the TN Implied Consent Advisement and refused. Bluford's DL is Revoked for DUI and is required to have an ignition interlock device. Deputies were unable to find insurance on the Suzuki. Bluford was transported to the Loudon County Jail and while en route, Bluford rambled on about having "7 DUI's" and that he would serve years for the additional DUI he would be charged with and stated, "I'm guilty as fu&&". Bluford is being charged with DUI 5th, Implied Consent, Driving on Revoked, Ignition Interlock Devices, Driving on Roadways Laned for Traffic, and Financial Responsibility. Said events occurred in Loudon County.
