

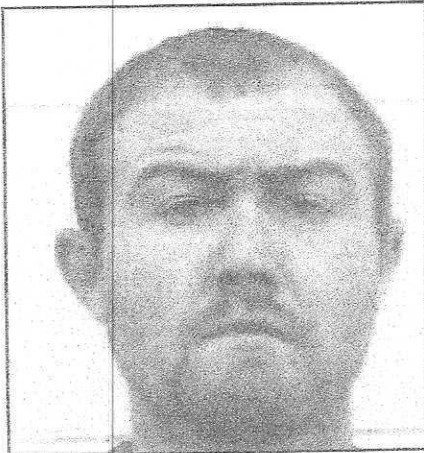

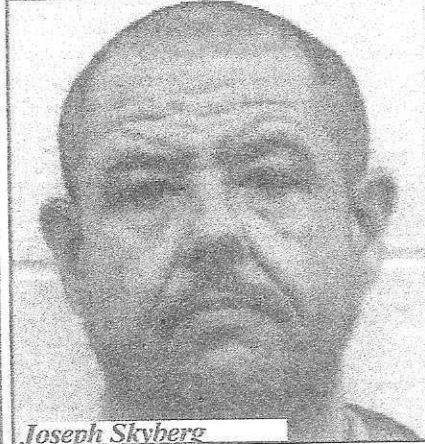

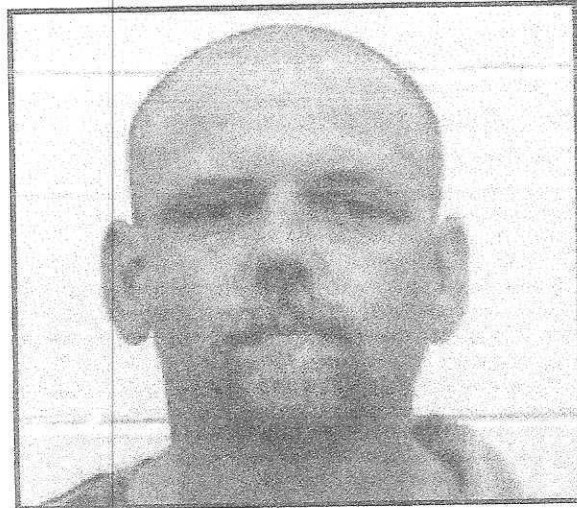

## CDC Releases Updated Maps of America's High Levels of Inactivity

25% of U.S. adults are not active enough to protect their health

More than 1 in 5 adults is inactive in all but four states, according to new state maps of adult physical inactivity prevalence released by the Centers for Disease Control and Prevention (CDC). For these maps, physical inactivity for adults is defined as not participating in any physical activities outside of work over the last month – activities such as running, walking for exercise, or gardening.

State and territory-level estimates of physical inactivity range from 17.7% of people in Colorado to 49.4% in Puerto Rico. In seven states and one territory (Alabama, Arkansas, Kentucky, Louisiana, Mississippi, Oklahoma, West Virginia, and Puerto Rico), 30% or more of adults were physically inactive. By region, the South had the highest prevalence of physical inactivity (27.5%), followed by the Midwest (25.2%), Northeast (24.7%), and the West (21.0%).

"Getting enough physical activity could prevent 1 in 10 premature deaths," said Ruth

Petersen, MD, Director of CDC's Division of Nutrition, Physical Activity, and Obesity. "Too many people are missing out on the health benefits of physical activity such as improved sleep, reduced blood pressure and anxiety, lowered risk for heart disease, several cancers, and dementia (including Alzheimer's disease).

The new maps are based on combined 2017-2020 data from the Behavioral Risk Factor Surveillance System (BRFSS), an on-going state-based telephone interview survey conducted by CDC and state health departments. This is the first time that CDC has created state maps of physical inactivity for non-Hispanic American Indian/Alaskan Native and non-Hispanic Asian adults.

The demographics of physical inactivity

The maps point to notable

differences in physical inactivity levels by race and ethnicity. Overall, Hispanic adults (32.1%) had the highest prevalence of physical inactivity outside of work, followed by non-Hispanic Black (30.0%), non-Hispanic American Indian/Alaskan Native (29.1%), non-Hispanic White (23.0%), and non-Hispanic Asian adults (20.1%).

The maps also show that:

Two states (Alaska and Montana) and Guam had a physical inactivity prevalence of 30% or higher among non-Hispanic Asian adults.\*

Five states (Arkansas, Kentucky, Mississippi, Oklahoma, and West Virginia) had a physical inactivity prevalence of 30% or higher among non-Hispanic White adults.

27 states had a physical inactivity prevalence of 30% or higher among non-Hispanic American Indian/Alaska Native adults.\*

23 states and the District of Columbia had a physical inactivity prevalence of 30% or higher among non-Hispanic Black adults.\*

25 states and Puerto Rico had a physical inactivity prevalence of 30% or higher among Hispanic adults.

\*49 of 52 jurisdictions had sufficient data to be included

in these results.

Physical activity can benefit everyone. Lack of access to safe and convenient places to be physically active may contribute to the observed racial and ethnic disparities.

What more can be done?

CDC is working with communities and partners across

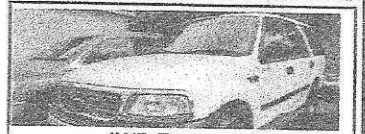

### Dope Dealer

Thomas Bowers, 32, Anderson Road Sweetwater, was charged with Driving on Revoked/Suspended License, Speed Limit, Simple Possession, Man/Sell/Del/Resale Sch. II & VI, DUI, Violation of Implied Consent, and Poss. Of Drug Para.

Deputy W. Jenkins LCSO, was on routine patrol in a marked patrol car when Deputy observed a Honda passenger car pass him on Spring St. headed toward Washington Pike. After the vehicle passed him Deputy observed it accelerate to a high rate of speed in what appeared as an attempt to elude him. Deputy then got behind the vehicle on Pond Creek Rd with one vehicle in between him and the vehicle. Deputy was driving the speed limit and the Honda was gaining distance on him indicating to Deputy that the vehicle was traveling well in excess of the posted speed limit of 50 MPH. The vehicle then got on 75 S. Deputy was able to catch up to the vehicle and run the tag. Dispatch advised that the registered owner of the vehicle was suspended. Deputy stopped the vehicle 75 S at the 63.2 MM. Deputy approached the passenger side window of the vehicle and smelled marijuana coming from inside the vehicle. Deputy asked the driver/offender, who came to be known as Thomas Joshua Bowers, if he had a valid driver's license and he handed Deputy a TN ID only card. Deputy asked the offender if he had any marijuana in the car and he answered no but looked in the passenger side floor board. Deputy asked the offender if he had any meth in the car and he answered no but again looked in the passenger side floor board. Deputy asked the offender when the last time he smoked marijuana in the car was and he told him last night. Deputy had the offender step out of the vehicle and asked him what he was going to find

when Deputy searched his car. The offender told Deputy that he was going to find needles and an ounce of dope which he elaborated to mean meth. At this time Deputy placed the offender in custody in the back of his patrol vehicle, read him his Miranda advisement which he acknowledged, and conducted a search of his vehicle. Deputy found 40.5 grams of Meth in multiple baggies, 43 grams of marijuana in multiple baggies, multiple suboxone strips with no prescription, a digital scale, multiple cut straws, a burnt glass pipe with drug residue inside, and multiple needles. All the contraband was located in the passenger side floor board of the offender's vehicle. Deputy offered the offender field sobriety tests which he refused to do. Deputy also read him Tennessee Blood and/or breath consent advisement and he refused to comply for a blood draw. The offender stated " I just told you I did dope an hour ago why would I take the test and let it tell you that". It should be noted that the offender had blood-shot eyes, was lethargic, and passed out in the backseat of his patrol car. James towing responded and towed the vehicle. On the way to jail Deputy asked the offender what he did for a living to support his drug habit and he answered " What do you think I do? You just caught me, I sell dope for a living". The offender also admitted to Deputy that he was speeding in an attempt to get away from him. The offender has active warrants out of Anderson, Knox, and Monroe counties. The offender also has a suspended license. This incident did begin in Loudon County Tn. Narcotics Investigator Ezell responded to the Sheriff's Office and used the TRUNARC device to test the substance which came back positive for meth (scan #s 1370, 1371, 1367). 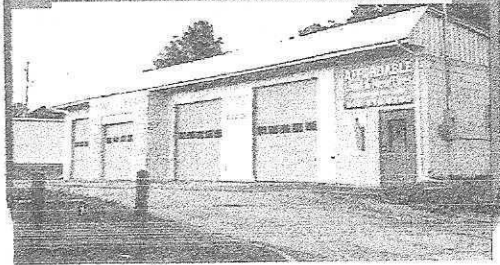

the country as part of the Active People, Healthy NationSM initiative, to make it easier, safer, and more convenient for people to be active where they live, learn, work and play. The overall goal of the initiative is to help 27 million Americans become more physically active by 2027 to improve overall health and quality of life and to reduce healthcare costs. The initiative helps community leaders take advantage of proven strategies to make physical activity safe and enjoyable for people of all ages and abilities. Building active and walkable communities may also help support local economies and create more cohesive communities.

The Physical Activity Guidelines for Americans, 2nd edition external icon, recommends that adults get at least 150 minutes of moderate-intensity physical activity each week. This can be broken into smaller amounts such as 22 minutes every day or 30 minutes five times a week. Individuals and families are encouraged to build physical activity into their day by going for a brisk walk or a hike, walking the dog, choosing the stairs instead of the elevator or escalator, parking further away in the parking lot and walking the rest of the way, walking or

cycling to run errands, and getting off the bus one stop early and walking the rest of the way. The key is to move more and sit less.

Community leaders can also encourage school and youth physical activity programs, educate, and support families and individuals to be more active. They can create activity-friendly routes to everyday destinations such as home, work, school, and grocery stores. Together, leaders and community members can work with various populations to design and implement culturally relevant solutions to reduce disparities in physical inactivity.
