the level of protection  
offered by COVID-19

vember 2021, people  
who were unvaccinat-  
ed and did not have

at the highest risk of

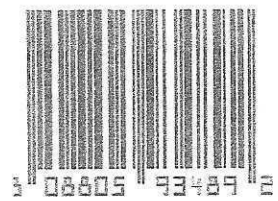

## Heroin

Paula Mitchell, 40, Hwy 50, Holley Ridge NC., was charged with DUI, Driving on Suspended/Revoked License, Simple Possession, and Poss. Of Drug Para.

Deputy Rogers LCSO, observed a silver pickup swerving violently and not maintaining a consistent speed while travel South on I75. Deputy initiated a traffic stop at the 81 exit and made contact with Ms. Paula Mitchell who was moving objects around in her purse as she was looking in her mirrors.

While speaking with Ms. Mitchell Deputy observed a

syringe between her legs in the seat. After asking Ms. Mitchell to step out of the vehicle she attempted to hide the syringe in a pocket of the door. When questioned,

Ms. Mitchell did admit to using the syringe to shoot Heroin, also stating she used the drug while in her vehicle just before she left Ashville. Ms Mitchell stated she was enroute to Chattanooga to buy tires but was running late. During a probable cause and consented search of the vehicle

Deputy did located a magnet box with several baggies, syringes, tourniquets, and a

burnt spoon all containing a white residue. Deputy also located one small container with a small amount of a white substance which Ms. Mitchell identified as Heroin. Ms Mitchell did consent to SFST/ARIDE testing and did not perform satisfactory, see case notes. After checking the offender's information through Loudon E911, it was confirmed Ms. Mitchell had a suspended license in North Carolina. Deputy took Ms. Mitchell into

custody for D.U.I, Simple Possession. Deputy then supplied and read TN Implied Consent to the offender to which she did consent to a blood draw. Deputy transported the offender to the Fort Loudoun E.R where the blood draw was conducted and then to the Loudon County Jail. Ms. Mitchell was also cited with Drug Paraphernalia and Suspended License. Said did occur in Loudon County, TN.

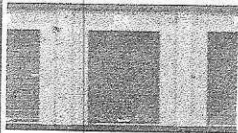

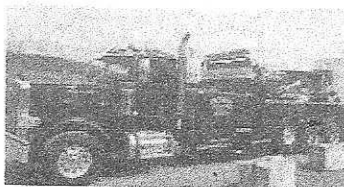

**Vandalism**

Cortland Hedrick, 24, Knox Road Knoxville, was charged with Vandalism.

Deputy C. Bengel LCSO, was responding to a Vehicle Burglary call in Jackson Crossing. While en route and as Deputy was entering the subdivision, he observed a white Chevy Suburban that appeared to be stuck in the ditch line on Hwy 70 just outside the entrance to Jackson Crossing. Deputy proceeded into the neighborhood where he observed numerous sections of the property that had been driven through. It appeared as if someone drove an off-road vehicle through the grass/field and destroyed the area causing ruts in the landscape. Deputy proceeded past and onto the original call for service. Once clearing Deputy checked out with the Suburban on Hwy 70 E, just outside Jackson Crossing. Deputy observed the vehicle to be abandoned and was stuck in the ditch with mud up to the

rear bumper. Deputy noticed the tires were a unique, off-road/all-terrain type tire. Deputy also inspected the tread pattern on the tires and the imprints that the tires left in the snow leading up to where it became stuck. Deputy took pictures and left the vehicle and arrived inside Jackson Crossing to look at the damage. Deputy noticed that the tread pattern to be the same as what the Suburban left prior to becoming stuck. Deputy took various pictures of the damage and called for the Suburban to be towed from the scene. Money-makers Wrecker Service arrived and towed the Suburban and Deputy put a hold on it pending an investigation. The registered owner of the Suburban is Cortland Hedrick. Deputy was able to get into contact with the HOA Treasurer victim. Victim was able to provide information for the HOA and is a point of contact for them. Victim estimates the value of the damage to be well over \$1000.

There were multiple vehicle burglaries less than a 1/4 mile from where the Suburban was abandoned and even less of a distance from where the vandalism occurred. Deputy called and notified Lt. Detection Cosner and made him aware of the incident. Later in the evening, Deputy received a call from Money-makers Wrecker Service stating that Hedrick had shown up to get his vehicle.

Sgt. Detective Kirkland and Deputy arrived at Money-makers and spoke to Hedrick. Hedrick

stated that while he was driving his Suburban last night, he was speeding, slid off the road, and got stuck in the ditch. Hedrick was taken into custody and transported to the Loudon County Jail. Once at the Sheriff's Office, Sgt. Kirkland and Deputy interviewed Hedrick, who admitted to driving through fields and tearing up the grass.

Hedrick is being charged with Felony Vandalism. Said events occurred in Loudon County, TN.

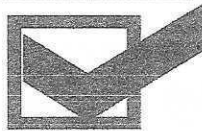

time and can lead to the emergence of new variants that have new characteristics, including ones that impact the level of immunity vaccination and/or prior infection can provide. The level of protection offered by vaccination and surviving a previous infection changed during the study period. Vaccination remains the safest strategy for protecting against COVID-19.

There are important caveats to the data presented in this study:

The analysis was conducted before the emergence of the Omicron variant and the findings cannot be applied to the current Omicron wave.

The study ended prior to the widespread implementation of booster doses and does not reflect the immunologic benefit of additional vaccine

doses.

The analysis did not include information on the severity of initial infection and does not reflect the risk of morbidity and mortality from COVID-19 infection.

Additionally, a recent study external icon shows with increasing time since prior infection, vaccination provides greater protection against COVID-19 compared to prior infection alone, emphasizing the importance of being up to date on COVID-19 vaccination. Later this week, CDC will publish additional data on COVID-19 vaccines and boosters while Omicron has been circulating.
