CDC/ATSDR Updates Guidelines for Examining Unusual Patterns of Cancer and Environmental Concerns

The Centers for Disease Control and Prevention and the Agency for Toxic Substances and Disease Registry (CDC/ATSDR) has released updated guidance to help state, tribal, local, and territorial public health agencies, and other partners as they investigate patterns of disease in communities, including cancer, and environmental concerns.

CDC/ATSDR conducted extensive scientific literature reviews and gathered comprehensive feedback via focus group sessions, meetings and interviews with community members, subject matter experts, and state, tribal, local, and territorial partners. The new guidance:

Places a greater emphasis on engaging and communicating with community members,

Recommends health departments consider proactive evaluation of cancer registry data at regular intervals to identify unusual patterns of cancer in a timelier fashion,

Replaces the steps in the 2013 Guidelines with new investigative phases and detailed criteria to:

address environmental concerns more

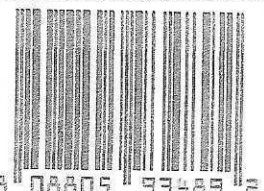

Silas Parks, 33, Mealer Road Lenoir City, was charged with Violation of Order of Protection, and Electronic Tracking of Motor Vehicle.

The victim came to the Loudon County Sheriff's Office and spoke to Detective Partin in his office. Victim said that over the past few months, her friends have been receiving messages on Facebook from Silas Parks asking if they had seen her. When they said that they had not, he responds by saying he knows victim has been in the area or knows she was on a certain road. These messages were sent shortly after victim would leave her friend's house or while she was driving on those particular roads mentioned by Silas Parks. Victim friends sent her screenshots of the messages and she was concerned that Silas Parks has been tracking

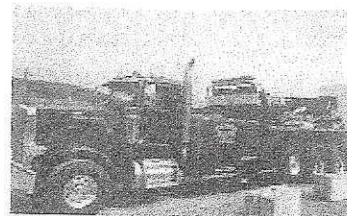
her somehow. Victim said that on today's date, she found a white Apple Air tag in her vehicle hidden under her spare tire compartment. Victim gave Detective the Air Tag and provided pictures showing where it was located in the vehicle. Sgt. Detective Mills was able to find the serial number to the Air Tag and learned that it was registered to a phone number with the last four digits of 7542. A search of our records showed that Silas had a phone number ending in 7542 and victim was able to confirm that this is still his phone number. Partin asked victim how Silas would have put this device in her vehicle and she explained that they were going through a divorce. During the court proceedings, Silas was ordered to give the vehicle over to her by a certain date. She

said that he held onto the vehicle for a few days past the ordered date and believes that is when he put the device in her car. Victim does have an active Order of Protection out of Loudon County General Sessions with a hearing date set for January 17th, 2022. This did occur in Loudon County, Tennessee.

All of the above occurred in Loudon County, Tennessee.

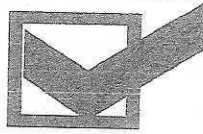

Meth

Bradley Williams, 30, Oakland Road Sweetwater, was charged with Mfg/Del/Sale or Poss. Of Meth.

Deputy J. Sartin LCSO, observed a silver Mazda pass him on Interstate 75 southbound around the 77 mile marker. Deputy paced the vehicle at 79 miles per hour in a 70 mile per hour zone. Deputy initiated a stop at the 72 mile marker southbound on I-75. Upon contact with the driver, Mr. Bradley Williams, Deputy could smell an odor of marijuana coming from the vehicle. Deputy had Mr. Williams step out of the vehicle and he began getting argumentative. Deputy explained to Mr. Williams why he got him out of the vehicle, and he admitted to having the marijuana in his vehicle. Mr. Williams continued to be argumentative, and Deputy placed him into handcuffs. He then stated he had "a little dope on him."

When asked what he had he stated "ice". In his jacket pocket Deputy found a small baggie with crystal like substances that was believed to be meth. A small burnt marijuana cigarette was found in the vehicle which was seized for destruction. Mr. Williams was taken into custody and charged with possession of methamphetamine. Lt. Ezell tested the drug with TruNarc and it was confirmed to be methamphetamine. The field weight of the meth was 1.8 grams. This did occur in Loudon County, TN.

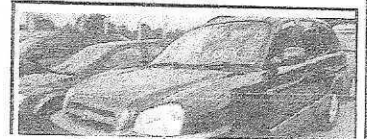

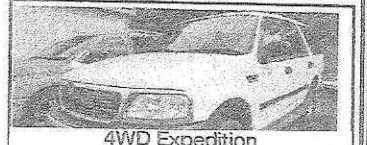

CDC broadly, and de-emphasize statistical significance as the primary criterion for moving forward with evaluating unusual patterns of cancer.

Revising the guidelines was a component of Trevor's Law, a section included in the Frank Lautenberg Chemical Safety for the 21st Century Act. CDC Expands Updated COVID-19 Vaccines to Include Children Ages 6 Months through 5 Years

Following FDA action, today CDC expanded the use of updated (bivalent) COVID-19 vaccines for children ages 6 months through 5 years. Children ages 6 months through 5 years who previously completed a Moderna primary series are eligible to receive a Moderna bivalent booster 2 months after their final primary series dose. Children ages 6 months through 4 years who are currently completing a Pfizer primary series will receive a Pfizer

er bivalent vaccine as their third primary dose.

Updated COVID-19 vaccines are formulated to protect against some of the more recently circulating viruses.

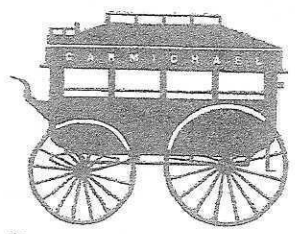
Most importantly, COVID-19 vaccines are critical to providing ongoing protection as immunity wanes and the virus continues to mutate.

The vast majority of children in this age group have not received any doses of a COVID-19 vaccine. CDC is working to increase parent and provider confidence in COVID-19 vaccines and improve uptake among the 95% of children who are not vaccinated or who have not completed the COVID-19 vaccine primary series.
