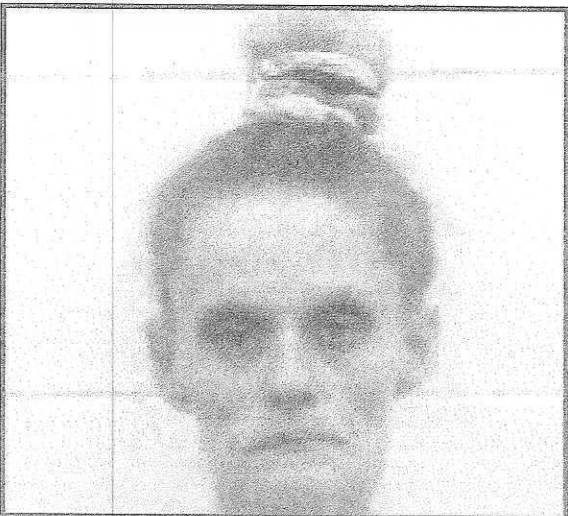

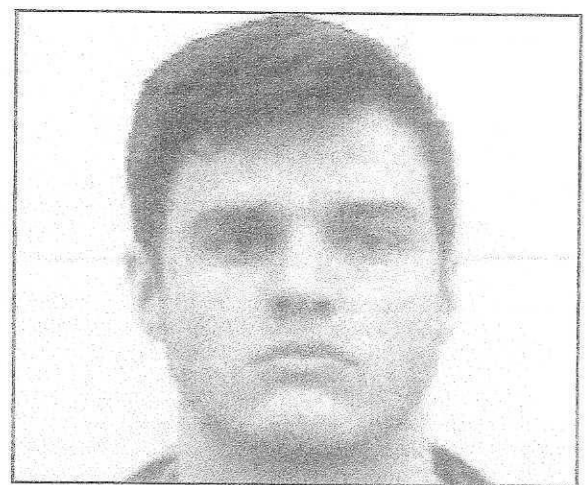
Investigation Thwarts Brazen Bribery Scheme

Businessman Paid for Elected Official's Divorce in Exchange for Lucrative Contracts

Three people—an attorney, an elected official, and a businessman—engaged in an outrageous corruption scheme that involved paying for an elected official's divorce. But an FBI investigation thwarted their efforts.

Agents opened a case in 2014 after re-

ceiving a lead. Established sources reported large-scale corruption involving the garbage, construction, and engineering industries in the suburbs north of Detroit. The case began there, where public official Dean Reynolds was caught extorting people and selling his votes.

"We were able to intercept him in real time accepting and demanding bribes," said

Special Agent Robert Beeckman, who investigated this case out of the FBI's Detroit Field Office. Agents also saw Reynolds accepting a cash delivery. As a local legislator in the 10th largest Michigan municipality, Reynolds used his connections for capital gain.

Reynolds made sure to have connections in the garbage industry,

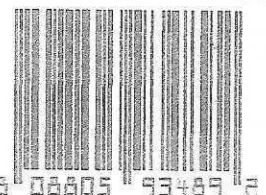

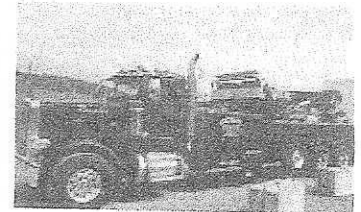

Colton Hughett, 21, Emerald Street Georgia, was charged with Identity Theft, Simple Possession, and Driving on Revoked/Suspended License.

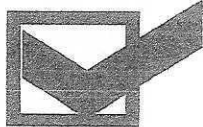
Deputy Parks LCSO, observed a gray Volkswagen CC Sport, bearing Georgia registration RRZ0053, fail to maintain lane on Interstate 75. The vehicle's right side tires left the roadway over the white line in such a manner that only half of the vehicle remained within the designated travel lane. Officer got behind the vehicle and initiated a traffic stop on Interstate 75 Northbound at the 71.4 mile marker. Officer approached the vehicle on the passenger side and made contact with the driver, later identified as Mr. Colton Hughett, and the passenger. Officer advised the two of the reason for the stop and asked for Mr. Hughett's driver's license. While speaking with the two Officer observed the odor of marijuana coming from the vehicle. Mr. Hughett presented a Tennessee driver's license belonging

to Mr. Daniel, Mr. Hughett's brother. Mr. Hughett claimed to be Mr. Daniel Hughett Jr. and advised he was on his way back to Knoxville from Atlanta. Officer advised Mr. Hughett that if his license was valid it would just be a warning for failing to maintain lane. Officer asked Mr. Hughett if he would exit his vehicle and come back to my vehicle while Officer issued him a warning citation. Mr. Hughett agreed and exited his vehicle where Officer asked if he would mind if he patted him down for weapons. Mr. Hughett advised he had no weapons and advised that Officer could pat him down. Officer did so and asked if he would sit in my passenger seat while he issued the warning citation from my driver's seat and he agreed. Officer advised dispatch to conduct a driver's license status check for who he believed to be Mr. Hughett at the time. Officer also advised dispatch to conduct a warrant check. While speaking with Mr. Hughett he advised his license to be valid and confirmed all of the information on what was

later revealed to be his brother's identification to be correct. While writing the warning citation Officer asked Mr. Hughett if there was anything illegal in the vehicle and he advised there was not. Officer then told Mr. Hughett while speaking with him at his vehicle Officer observed the odor of marijuana coming from the vehicle. Mr. Hughett admitted to there being a marijuana roach in the vehicle. A short time later Officer asked Mr. Hughett if there was only a marijuana roach in the vehicle. He then advised there was four grams of marijuana and a handgun in the vehicle, both of which he claimed possession. Mr. Hughett further stated that he had smoked marijuana within the past few hours while operating the vehicle. Another unit arrived and Officer asked Mr. Hughett his first name and he advised Colton. Officer introduced Mr. Hughett to Sgt. Rogers as Colton and Mr. Hughett advised Officer had mistaken his name. Mr. Hughett then admitted to deputies on scene that his name was

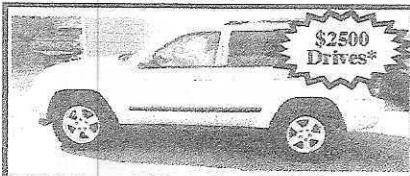
Colton Hughett, and he provided his brother's driver's license due to his being suspended. Mr. Hughett also stated his brother did not know he was using his license. A search of the vehicle was conducted yielding a mason jar containing marijuana in a plastic baggie (approx. 9.5 grams field weight). The mason jar was found under the passenger's seat. The marijuana was taken and placed into evidence and deputies also located the handgun and ran a serial number check through dispatch. The handgun was not stolen and was cleared and placed in a safe location. Dispatch advised Mr. Hughett's license to be suspended as a habitual offender. Mr. Hughett was placed under arrest and placed in the backseat of his patrol vehicle. The vehicle and handgun was released to the passanger and Mr. Hughett was transported to the Loudon County Justice Center without incident. The marijuana and the identification was bagged and placed into evidence. All of the above occurred in Loudon County,

one of the township's biggest expenses. On the other end of several phone calls was Chuck Rizzo, president of Rizzo Environmental Services, Inc. Rizzo's company had one of the largest and most lucrative garbage businesses in Southeast Michigan. He offered Reynolds bribes to secure favorable contracts. He spoke specifically about securing Reynolds' vote on an \$18 million contract.

In exchange for the lucrative contract, Rizzo paid Reynolds' divorce expenses.

Rizzo asked his lawyer Jay A. Schwartz to provide a variety of services, including advice about how to commit bribery and divorce counsel for Reynolds. Schwartz agreed. A subpoena of his billing software confirmed that \$40,000 worth of legal services were provided for free.

As the divorce went on, Reynolds fought a custody battle that required a psychological evaluation. Another wiretap caught Schwartz proposing that a third party could pay for it; however, that person needed to have

one very crucial ability.

"[Schwartz] talked about finding a third party who could hold up on the witness stand if ever questioned under oath about where the money came from. You have an attorney, an officer of the court, proposing a bribery scheme with a view towards perjury if necessary...hiding it from a judge," Beeckman said. Schwartz swindled an unsuspecting family friend into the scheme.

Schwartz was sentenced to 27 months in prison and fined \$250,000. Rizzo was sentenced to 66 months in 2018. In 2019, Reynolds was sentenced to 17 years in prison. A total of 22 people were indicted in the scheme.

The FBI prioritizes these cases because systemic corruption can cause a domino effect leading to general mistrust of authority.

"There are places in the world that have given up. They have corruption at such a level that their governmental systems have completely failed," Beeckman said. "The public there has no confidence in the people who run their country. We're not there in this country, and we have no intention of getting there."

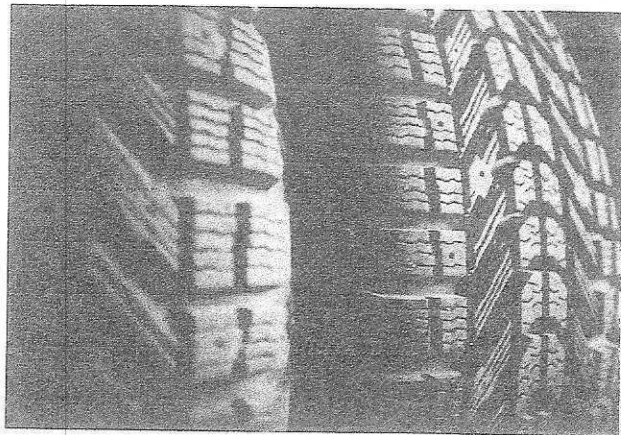

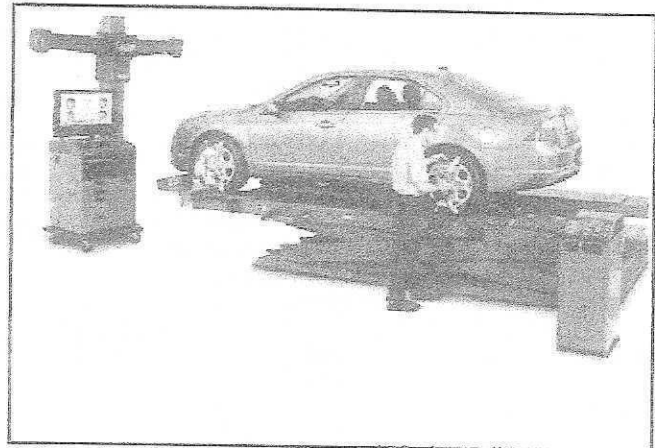

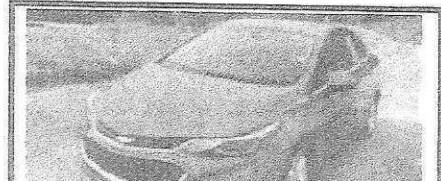
