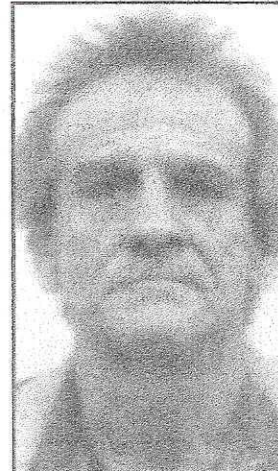

## St. Louis County Man Sentenced to 20 Years for Fentanyl Conspiracy

U.S. District Judge Stephen R. Clark on Thursday sentenced a St. Louis County, Missouri man involved in a fentanyl distribution ring to 20 years in prison.

Anthony "Peta Man" Caldwell, 27, was the final defendant to be sentenced out of 11 people who distributed multiple kilograms of fentanyl in the St. Louis area

over the course of the conspiracy, which began at least as far back as January 2018.

Caldwell was also identified as the man who used a semi-automatic rifle to shoot a woman in her car on Interstate 70 in St. Louis on April 30, 2019, sparking the FBI to begin investigating, according to court filings.

which also involved the Drug Enforcement Administration, the St. Louis Metropolitan Police Department and the St. Louis County Police Department, would eventually uncover a drug ring that was supplied by an Arizona man charged in a different case. That man supplied fentanyl to Caldwell's co-defendants, Kevin

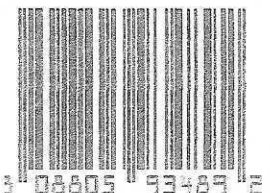

**DASAUN HYLTON**, 33, Bronx New York, was charged with Theft of Property.

Officer Sparks LCPD, was dispatched to Loves Truck Stop in reference to a

suspicious person. The complainant/ victim advised that a black male with black, shoulder length hair that was driving a black pickup truck with "Emergency Response Vehicle" written in yellow lettering on the truck had stopped at her address in Roane County asking for money for gas. The complainant felt that this was suspicious and wished for an officer to check on this person. Upon arrival to Love's, Sgt. C. Espinoza located a black pickup truck matching the description of the reported vehicle bearing

New York Registration, 35415MA. After running the registration through dispatch, it was found that the black 2013 Toyota Tacoma bearing this registration had been reported stolen out of New York, NIC# V044570837. Officer, Sgt. Espinoza and Officer Wilkes made contact with the male matching the description that the complainant gave of the male driving the black pickup.

Upon making contact, the male was found to be Dasaun Paul Hylton out of New York, who advised that the vehicle he was driving matched the description of the vehicle that was both described by the complainant, as well as the black pickup that had been reported stolen. Mr. Hylton was found to also

be in possession of the keys to the stolen vehicle. Mr. Hylton was placed into custody for being in possession of the stolen motor vehicle. Mr. Hylton advised that he was unaware of the vehicle being stolen, and that he had borrowed the vehicle from a friend in order to drive it for work.

James Jenkins, 54, Beller Town Road Powell, was charged with Poss. Of Drug Para.

Atosha Fritz, 43, Hutchinson Avenue Knoxville was charged with Man/Sell/Del/Resale Sch. II & 1, and Poss. Of Drug Para.

Law enforcement arranged a controlled narcotics delivery from Atosha Fritz to an undercover agent. Fritz agreed to meet an undercover agent at Buddy's BBQ in Lenoir City to deliver the narcotics. When Fritz arrived at the meet location, she texted the undercover agent stating where she was parked and what vehicle she was parked beside. Law enforcement made contact with Fritz and her boyfriend James Jennings. In plain view on Jennings's lap was a Meth pipe. Agents asked Fritz if he could search the

vehicle and she agreed. Fritz had a black case that contained one baggy of Fentanyl Compound (0.63 grams), one clear container with a pink lid that contained Heroin and Fentanyl compound (4.02 grams), one clear container with a clear lid that contained Fentanyl compound (3.30 grams), one cut straw and a glass pipe. Found in Fritz's purse was a cut straw. Jennings was found to be in possession of an additional meth pipe. Fritz and Jennings were transported to the Loudon County Jail. While at the jail Agent read Fritz her Miranda warning which she signed and agreed to speak with him. Fritts stated that she sells drugs to support her Crack Cocaine habit. Fritz stated she didn't know that she delivering fentanyl to an undercover agent and that she thought she was delivering Cocaine. This did happen in Loudon County.





**Fentanyl**

White and Maricus Futrell, through the use of couriers or by mailing packages of fentanyl. White and Futrell then supplied Caldwell and others.

Caldwell was responsible for between 1.2 and 4 kilos of fentanyl as part of the conspiracy, court records show, and the whole conspiracy was responsible for 12 kilograms. Caldwell supplied other conspirators and sold the drug in the Fairgrounds Park neighbor-

hood of St. Louis.

Investigators recovered fentanyl, cash, assault rifles, handguns and a stolen Dodge Charger during the case.

White, 29, of St. Louis County, was sentenced to 10 years in prison. Futrell, 22, of St. Louis County, was sentenced to 11 years in prison in a related case.

Caldwell was shot in the head shortly before he was arrested in connection with the case, according to court records and testimony. He pleaded guilty in August to a drug conspiracy charge.
