

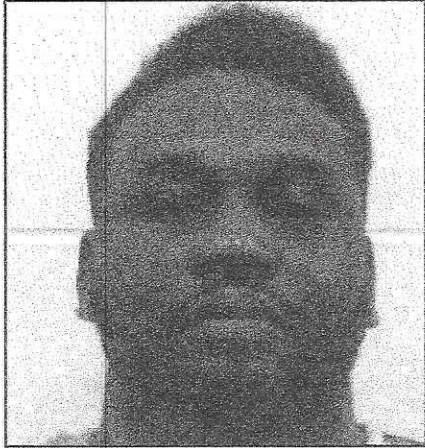

FBI Builds on Outreach and Recruiting Efforts at HBCUs

Regional Beacon Event Seeks to Strengthen Connections, Draw Applicants

Jermicha Fomby, special agent in charge of the FBI's Jackson Field Office, converses with attendees at a Beacon Project event held March 8, 2022 at Jackson State University.

Building on the summer 2021 launch of the Beacon Project, FBI leaders and executives from 25 Historically Black Colleges and Universities (HBCUs) met in Jackson, Mississippi, this week to further the project's goals of strengthening community ties and improving the diversity of the FBI.

"The proactive steps the FBI took in establish-

ing the Beacon Project places us on the proper path to improving diversity, equity, and inclusion in the workforce, as well as maximizing outreach in underrepresented communities," said Special Agent in Charge Jermicha Fomby, head of the FBI's Jackson Field Office and one of the Beacon Project's founders.

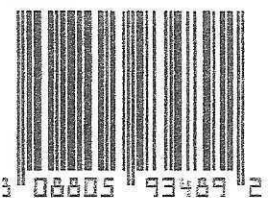

Devarus Fullwood, 29, Parkwood Ave Georgia, was charged with Unlawful Carrying or Possession of a Weapon, Possession of a Firearm, Simple Possession, and Man/Sell/Del/Resale Sch. I.

Jarvis Bush, 31, Camden Forrest Trail Georgia, was charged with Convicted Felon in Possession of a Firearm, and Simple Possession.

Trooper Basaldua THP, was observing northbound traffic on I-75 in Loudon County. Trooper observed a white Jeep Renegade traveling northbound in violation of the Slow Poke Law. Trooper paced the vehicle's speed at 74 mph in a 70 mph zone. Trooper initiated his emergency equipment getting the vehicle to pull over at the 70.6 mile marker shoulder. Trooper approached the vehicle and identified all 3 occupants and called for backup. After speaking with the driver Trooper could smell a strong odor of Marijuana coming from his persons. Trp. Clowers arrived on scene and spoke with the front seat passenger. The passenger identified as Jarvis Bush stated he had a small amount of Marijuana on his person. Trp. Clowers got Mr. Bush and the female passenger out of the vehicle. He then deployed his K-9. Trooper then patted down the driver finding a bag of green leafy substance identified as Marijuana from his crotch area. Trp. Clowers then spoke with Mr. Bush. It

was at this time, Mr. Bush stated he had a firearm under the driver's seat of the vehicle. He stated he had bought it from a white male in Atlanta about two weeks ago. A criminal history check of Mr. Bush showed him to be convicted felon. Mr. Bush was convicted of Possession of Methamphetamine on 1-14-2019 in Clayton County Superior Court in Georgia. He was then placed under arrest. A search of his person found to be a small amount of green leafy substance identified as Marijuana in his crotch area. Trp. Clowers transported Mr. Bush to the Loudon County Sheriff's Department.

Trooper Clowers THP, was patrolling I75 north bound in the area of 64 mm, when he observed a silver Kia Soul traveling in the left lane with no other traffic around it and not passing anything. The vehicle traveling like this for several miles. Trooper traveled behind the vehicle as it stayed in the left lane and dropped to 66 mph with no vehicle in front of it. Trooper conducted a traffic stop on the vehicle at the 67 mm and made a passenger side approach. Trooper made contact with the driver Joshua Brooks and Devarus Fullwood to be the right rear passenger. AAK-\$& was located in the front passenger seat. Upon speaking with the driver Trooper observed an odor of marijuana coming from inside the vehicle. Trooper ask the drive to step out and to the back of

the vehicle. Trooper found Brooks license to be suspended. Brooks stated they were headed to Ohio to see the passengers aunt. Trooper ask about the marijuana Brooks stated there was a small amount and a handgun in the glovebox. Trooper ask Fullwood to step out, he ask the Trooper if he could have his jacket. When the Trooper picked up the jacket it felt

heavy and ask what was in it. Fullwood stated there was a gun magazine in it. The mag fit the gun in the glove box. In the passenger door there was a Tupperware container containing several grams of crystal chunks believed to be MDMA.

Also located were several small packages of marijuana. Both subjects were transported to Loudon County Jail.

Ilena Estenoz, 40, Gadusi Lane Loudon, was charged with Man/Sell/Del/Resale Sch. VI., and Poss. Of Drug Para.

Deputy K. Palmer LCSO, observed a green Nissan Altima in the ditch at Overlook Drive and White Oak Road. Deputy observed a female sitting inside the vehicle. When made contact with the female in the passenger seat of the vehicle Ms. Ilena Ann Estenoz. Deputy asked Ms. Estenoz what was going. FBI

“As its name implies, it shines a light of hope for the present and future ways in which we serve our communities.”

Fomby said that moving forward requires an honest and open examination of where the FBI has been, where we are now, and where the organization hopes to go.

HBCU leaders agree. Many of those in attendance at the March 8 event, held at Jackson State University, lauded the FBI for enhancing and re-opening lines of communication and responsiveness between law enforcement and minority universities.

During his opening remarks, FBI Deputy Director Paul Abbate reflected on times when the FBI could have been a better partner. Those in attendance said those times contributed to a mistrust of law enforcement then—and to some extent, now.

“We all know the FBI wasn’t always as good a partner to the

Black community—particularly at the outset of the civil rights era,” Abbate said. “Before 1964, the federal government left protection of civil rights to state and local governments. Wrongly, many murders went uninvestigated, were covered up, or were purposely misidentified as an accident.”

Abbate says the Bureau is learning from its past, including the FBI’s wiretap of Dr. Martin Luther King, Jr.: “We’ve studied these abuses of power and mistakes of the past and learned from them in an attempt to do better and become a better FBI.”

Moving policies and programs forward and improving training and oversight over the last five decades have helped the FBI improve. The highest remaining hurdle is in building a more diverse and inclusive FBI workforce—especially when it comes to the Bureau’s leadership and its special agents. Both groups are still predominately male and white.

The Beacon Project embodies an understanding that recruiting efforts alone can’t address that gap; greater trust and creating strong and consistent connections are essential elements of drawing a more diverse pool of applicants into the FBI. And greater diversity isn’t a goal in and of itself, but something that is key to the FBI’s current and continued success. “The FBI’s intentional efforts to diversify are crucial to creating an inclusive workforce and to being increasingly effective and efficient in our investigations and keeping the American public safe,” said FBI Chief Diversity Officer Scott McMillion.

There have been some encouraging signs in recent years

as special agent applicants have grown increasingly diverse. The Jackson Field Office event brings a more local focus to that work. By bringing together the heads of FBI field offices in Birmingham, Cincinnati, Dallas, Houston, Jackson, Little Rock, Memphis, Mobile, and New Orleans with executives from colleges and universities in those same regions, relationship-building and engagement can continue in shared cities, towns, and neighborhoods.

The FBI’s Office of Diversity and Inclusion plans to work closely with the Office of Public Affairs’ Community Relations Unit to plan other regionally focused Beacon events. This summer, the FBI will be hosting additional HBCU presidents as well as the leaders of other minority-serving institutions in Washington, D.C., to continue building these relationships.

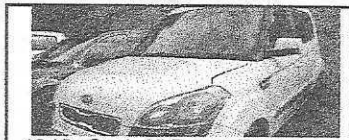

Brett Johnson, 28, South Congress Parkway Athens, was charged with Driving on Revoked/Suspended License, Requirements for Stop Signs Vehicle, Evading Arrest, Driving on Roadway Laned for Traffic, and Speeding.

Mr. Johnson was confirmed revoked for DUI. All occurred in Loudon and Knox Counties.
