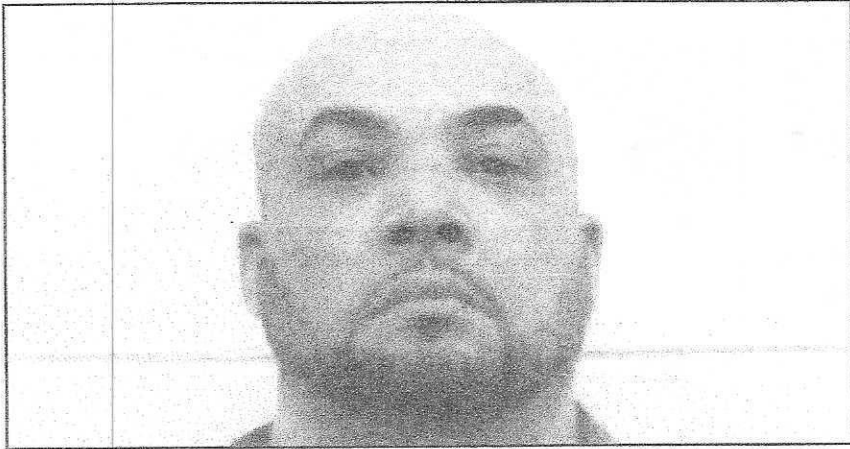

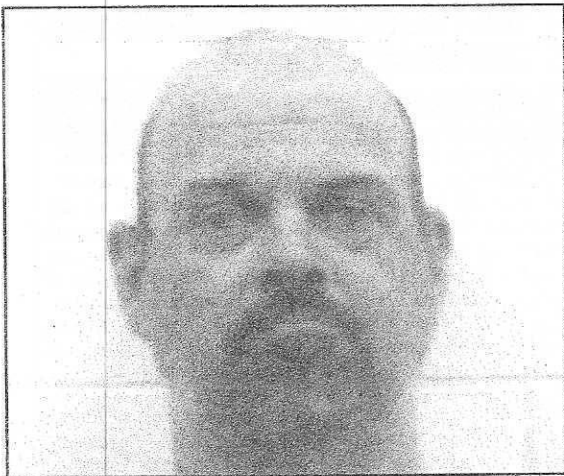

The Tennessee Comptroller's Office has released its annual audit of Overton County government for the fiscal year ended June 30, 2021. The audit includes 12 audit findings, 10 of which are related to significant issues within the school department's central office.

The audit findings indicate material

weakness, deficiencies, and areas of non-compliance within the school department. The number of findings within the school department has grown from two issues in fiscal year 2020 to 10 problems in fiscal year 2021.

A few of the many audit findings include inaccurate financial statements, accounting

deficiencies, expenditures exceeding budgeted appropriations, an improperly issued loan, and a laptop and several flash drives that went missing from the central office.

The Comptroller's Office strongly recommends that Overton County consider adopting a centralized

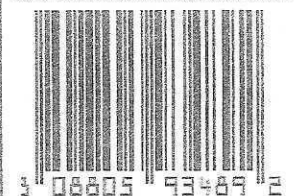

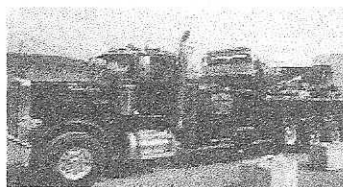

Deputy Fleming LCSO, and Sgt. Fagiana responded to Scenic Hill LN in reference to a domestic between Wheylen Osborne and victim. Upon arrival, Deputy made contact with Mr. Osborne outside the backdoor to the home smoking a cigarette.

Deputy then told him to keep his hands visible and make his way towards him. He then said that his fiancee victim and himself have been drinking and they got into an argument and he put his hands over her mouth. Further, into the investigation Deputy made contact with the victim, she was visibly shaken up and crying. The

victim told Deputy that they were both drinking and got into an argument about her youngest son.

system of accounting, budgeting, and purchasing. A centralized financial department would oversee all of the county, highway, and school funds and could significantly improve the accountability and quality of services provided to the citizens of Overton County.

"In our experience, when counties adopt a centralized financial department, they vastly improve their fiscal responsibility," said Comptroller Mumpower. "These poor audit results within the school department indicate that something needs to change. I believe the time is right for a central system in Overton County.

In addition to the ten audit findings in the school department, the Comptroller's Office also reported two findings related to the Office of County Clerk.

Comptroller's Office Takes Action to put Mason on Strong Financial Footing

The Tennessee Comptroller's Office is exercising its authority to supervise the financial affairs of the Town of Mason in an effort to improve the West Tennessee town's fiscal condition.

For at least 20 years, Mason has been poorly managed regardless of who was leading the town. The town has recently been impacted by the closure of a prison - reducing the population to an estimated 794 people. Comptroller Jason Mumpower believes Mason's citizens and taxpayers deserve an accountable government that is capable of providing services and improvements to the community. His letter and

corrective action notification to the town are attached.

The decision to enhance supervision of the town's finances comes after Mason's Board of Mayor and Aldermen voted not to surrender the town's charter. To view financial facts regarding the Town, click here.

The Tennessee Comptroller's decision is consistent with similar actions taken by the Office in other Tennessee communities. This supervision has achieved positive results, including improved financial integrity and stability.

"The citizens and taxpayers of Mason deserve a financially sound government," said Comptroller Mumpower. "By closely supervising the town's finances, we will put Mason on a path toward fiscal responsibility."

The Comptroller is granted the authority to direct Mason's financial affairs under Tenn. Code Ann. § 9-21-403(c). Going forward, all expendi-

tures involving taxpayer or ratepayer money must be reviewed and approved by the Comptroller's Office. The Comptroller will also direct the town to operate on a balanced budget and pay back the estimated \$597,905 that Mason currently owes to its Water and Sewer Fund by June 30, 2024.

The Comptroller's division of Local Government Finance will continue its direct supervision over the town government for as long as it takes for Mason to improve its financial condition and demonstrate that it is capable of managing a balanced budget with strong internal controls.

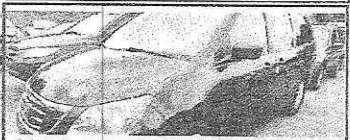

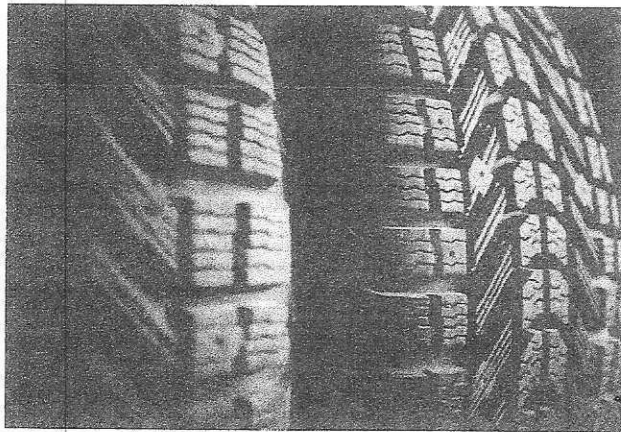

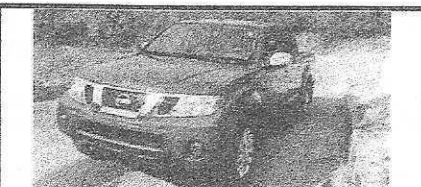
