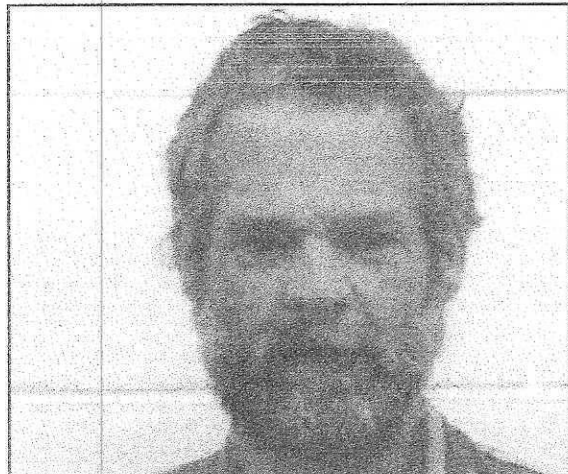

Former State Employee Indicted After Wrongfully Obtaining Grant Funds

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of Gina Morton, a former employee of the Tennessee Department of Mental Health and Substance Abuse Services (MHSAS).

The investigation began after MHSAS officials discovered that Morton was receiving compensa-

tion from a MHSAS grantee agency for work, some of which she only could have performed during the same hours she was working for the state.

Morton began working for MHSAS in 2007 as a Mental Health Program Specialist. Beginning in January 2012, Morton accepted an additional position with MHSAS grantee Volunteer Be-

havioral Health Care System (Volunteer) as a school-based liaison working with high school students.

Morton's job with Volunteer required her to be physically present at Holloway High School in Murfreesboro. Her state job required her to work from the MHSAS headquarters in down-

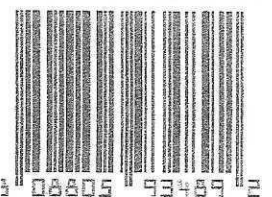

Reckless

Joshua Brown, 20, Old Stage Road Lenoir City, was charged with Reckless Endangerment x2, Evading Arrest, and Speed Limit Law.

Sergeant Matt Fagiana LCSO, observed a black Dodge Challenger traveling at a high rate of speed on US 321 near the Blount County Line. When Sgt. activated his radar it confirmed his observations and gave a reading of 78 MPH in a posted 60 MPH zone. When Sgt. attempted a traffic stop on the vehicle, he refused to stop. After running the registration, it was known by other LCSO Deputies that the registration came back to Joshua R. Brown, who has previous DUI history with

LCSO and previous evading history with Knoxville Police Department. The driver, later confirmed to be Joshua R. Brown, turned on to Meadow Road West and began to evade at a high rate of speed. Brown disregarded traffic lanes and passed several motorists, including two motorcyclists, and came dangerously close to several third party citizens. Brown continued to evade, reaching speeds up to 130 MPH, and eventually coming to a stop at a residence off of Newberry Drive. Brown ran into the house and was subsequently taken into custody. Brown was taken to LCSO Intake and held pending bond. All of the above occurred in Loudon County, TN.

Robert Moore, 49, Homeless Loudon, was charged with Aggravated Assault.

Officer M. Newman LPD, received a call of fight at Mulberry St. Once there Officer spoke to the complainant who advised he had broke a fight up between two people beside the dumpster. Upon further investigation Officer found (victim) standing beside the dumpster bleeding profusely from both arms. The victim explained he was attacked by Robert Moore after Mr. Moore entered the store in an agitated state and was asked to calm down. Victim injuries were so sever he was taken to Ft. Loudoun Medical Center for further treatment. Upon speaking to Mr. Moore he was very uncooperative and appeared under the influence of alcohol. He was then arrested and transported to Loudon County Jail.

Revoked Driver Charged

Isaiah Christian, 25, Grand View Drive Lenoir City, was charged with DUI, and Driving on Revoked/Suspended License/ Deputy Jared Johnson LCSO, was dispatched to Dutton Road for the report of a vehicle that was parked in front of that residence with a male loitering around the vehicle. Deputy arrived on scene and observed a red Ford Explorer stuck in the ditch in front of the driveway of the residence and a male standing on the road next to the Ford. The male identified himself with his Tennessee identification card as Isiah Christian. Christian advised me that he was driving the Ford and got stuck in the ditch attempting to make a U-turn. While speaking to Christian Deputy observed his eyes were red and watery, his speech was slurred and Deputy detected an odor of an alcoholic beverage emanating from his person. A status check of his license revealed his status was revoked for a prior DUI. Corporal Zac Frye and Deputy Luke Hawkins arrived on scene to assist.

Corporal Frye placed Christian through SFST's and Deputy Hawkins placed him through ARIDE tests. After completing all the tests Deputy Hawkins advised me that Christian displayed signs of impairment. Deputy placed Christian under arrest for DUI. Moneymakers arrived on scene and took possession of the Ford. Deputy Hawkins read the implied consent form to Christian and he submitted to a blood test. Deputy Hawkins transported Christian to Ford Loudoun Medical Center and observed the blood draw. Said did occur in Loudon County, TN.

DUI Follows Traffic Stop

James Baty, 34, Mountain Rise Drive Knoxville, was charge with DUI.

Deputy Fleming LCSO, was driving North on HWY 321 when he observed a grey Mercedes with a TN tag 51AU17 stopped in the intersection of Simpson Road and HWY 321. The operator / offender pulled into the parking lot of Gold's Gym. Deputy Fleming, pulled in right behind him in order to

conduct an officer investigation. Deputy made contact with James Baty when he quickly exited his vehicle prior to any activation emergency equipment, and then told Deputy his girlfriend, passenger, was drunk and had gotten into a fight with his roommate's wife and then left. Deputy Palmer conducted SFST with James and, through the series of tests, determined that the offender was impaired. Deputy placed the offender in custody for Driving under the influence (T.C.A 55-10-401). Deputy Fleming, read Mr. Baty his Miranda rights. Mr. Baty was read the Implied consent form TN blood and / or breath consent advisement, which James was willing to consent for a breath test on the Intox EC/ IR II. The Intox EC/IR II revealed an intoxication level of 0.142 g/210L Blood Alcohol Content. This all occurred in Loudon County, TN, without further incident.

Comptroller investigators determined that Morton received \$82,913 in pay from Volunteer for work she did not perform. Morton fraudulently represented that she had worked at least 6,160 hours at the high school for Volunteer, when in fact she was working onsite at MHSAS.

Furthermore, grant contracts prohibit MHSAS employees from being paid with grant funds. Morton's salary with Volunteer was paid with grant reimbursement money paid by MHSAS.

In January 2018, Volunteer officials discovered that Morton was employed full-time by MHSAS. Volunteer reported the grant contract violation to MHSAS and accepted Morton's resignation. After an internal investigation, Morton also resigned her position with MHSAS

effective March 20, 2018.

In February 2022, the Davidson County Grand Jury indicted Gina Morton on one count of the theft over \$60,000.

Einar Chavez, 25, Little Madison Way Knoxville, was charged with Theft of Property.

Investigator Kirkland LCSO, received information of a past theft at Oostinali Way. The complainant, stated that Matthew with the

Mr. Chavez called our E-911 Dispatch and requested to speak with Inv.. After speaking with him on a recorded line, he admit-

ted that he stole the lumber from the residence to build a deck at his residence. Knox County Sheriff's Office made contact with the vehicle and Mr. Chavez at the Wal-Mart at Walker Springs in Knoxville. Mr. Chavez was arrested on scene and transported to the Loudon County Jail for Theft of Property over \$1000. The vehicle was towed to Mon-eymaker's Wrecker Service and the property owner was notified and recovered his stolen property. The theft did occur in Loudon County Tennessee.
