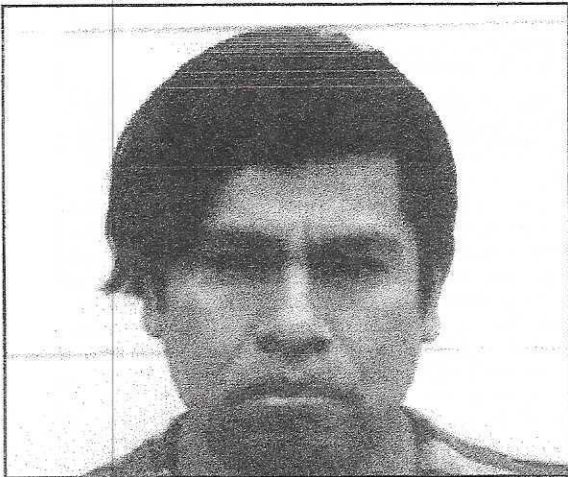

Man Charged with PI by LPD

Former McNairy County Circuit Court Clerk and Wife Indicted

Byron and Stephanie Maxedon investigated for false time sheet scheme

An investigation by the Tennessee Comptroller's Office has resulted in the indictments of Byron and Stephanie Maxedon. Byron Maxedon served as the McNairy County Circuit Court Clerk until he resigned on December 13, 2021. His spouse, Stephanie Maxedon, worked as deputy court clerk from Oc-

tober 14, 2019 through April 20, 2020.

Investigators determined that Stephanie Maxedon received at least \$3,163.62 in wages for time that she did not work. Byron Maxedon was aware that 11 of Stephanie Maxedon's 14 time sheets included time that she did not work. In fact, investigators found that Byron Maxedon completed

and falsified four of his wife's time sheets on her behalf.

Of the 1,040 total hours reported on Stephanie Maxedon's time sheets, she was not working approximately 30 percent of the time.

As a result of her fraudulent time reports, at least

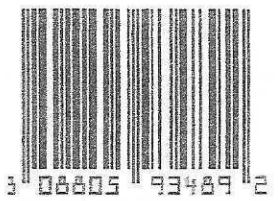

Deputies and Investigators with the Loudon County Sheriff's Office responded to Deputy Craig Brewer at Loudon Ridge Road, Lenoir City, after Deputy Brewer called in a shots fired call. Upon arrival, Investigator Marty Stanley, assisted by patrol units, cleared the residence of people for officer and bystander safety. While clearing the residence several items of drug paraphernalia

were noticed in plain view. Lt. Charlie Cosner asked for and received verbal consent to search the residence from Kevin Dwayne Helton and Brittany Michelle Currier who lived in the residence. When Deputy walked through the residence, he noticed a safe in the bedroom which was cracked open. Deputy opened the door of the safe and noticed two glass jars of what appeared to be prescription pills. The residence was secured and a search warrant was applied for and granted to search the residence. Approximately 451 two milligram Xanax pills, 178.2 grams of two milligram Xanax pill pieces, 28.3 grams of psilocybin mushrooms, 32.8 grams of marijuana, 4 suboxone strips, 1 two milligram diazepam, 1.2 grams of crystal methamphetamine, and 1.2 grams of a brown substance that tested positive for fentanyl were found during the search. Two drug ledgers, digital scales, baggies, several snort straws, four cell phones, \$310 in US currency hidden in a boot, a Hi-Point 9mm and

a Raven arms .25 Auto were also found during the search. Additionally, several powders which were unable to be tested were found and sent to the TBI lab. Both Helton and Currier's wallet, identification and other identifying papers were found in the bedroom where most of the illegal narcotics were found. This happened in Loudon County, TN.

\$1,434.77 in county provided benefits were also paid on Stephanie Maxedon's behalf.

In February 2022, Bryon and Stephanie Maxedon were both indicted by the McNairy County Grand Jury on one count of theft over \$2,500, one count of official misconduct, and one count of false entries in governmental records.

"Investigators discovered several problems within the circuit court clerk's office," said Comptroller Jason Mumpower. "These included a failure to review time sheets

for accuracy and a lack of policies and procedures regarding the timekeeping process. I encourage the new clerk to strengthen oversight and internal controls."
