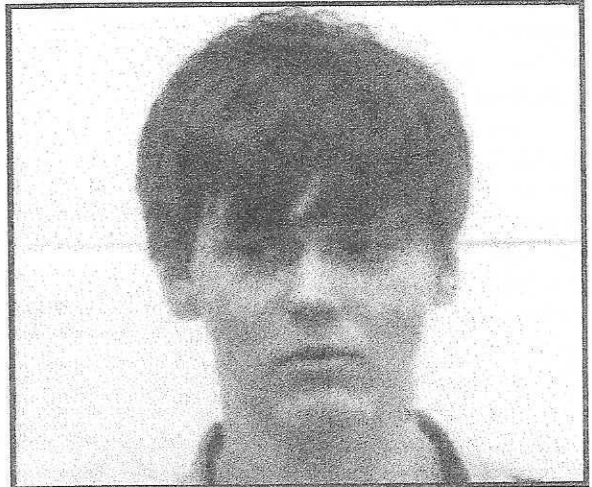

The Centers for Disease Control and Prevention's (CDC) Tips From Former Smokers® (Tips®) campaign, now celebrating its 10th anniversary, returns today with new ads encouraging people who smoke to quit. The campaign has had significant and sustained impact over the past decade, helping more than 1 million U.S. adults to quit smoking and inspiring millions more to try to quit.

Year after year, the Tips campaign has proven its effectiveness while promoting a range of quit services.

In addition to promoting the 1-800-QUIT-NOW telephone-based counseling service, the Tips campaign will now also promote the new National Texting Portal developed in collaboration with the National Cancer Institute. Available in English and Spanish, the por-

tal is designed to reach adults who may want to receive text messages to support them as they quit smoking. Adults can text QUITNOW to 333888 for free help in English or text DÉJELO YA to 333888 for free help in Spanish (mobile plan data and message rates may apply). Pedro Cruz, 33, West Market Street Johnson City, was charged with DUI, Leaving the Scene of Accident, Due Care, Driving on Roadways Laned for Traffic, Duty to Render Aid and Give Information, Driving without a License, and Open Container.

Deputy Bengel LCSO, responded to Sugarlimb Rd at I-75 to look for a Hit and Run suspect vehicle. The Victim was hit by the suspect vehicle which was described as a maroon SUV. The Victim was sideswiped/pushed into the guard rail at the 82mm on I-75 S. The Victim stated that the vehicle was passing the 81mm and less than 2 minutes after the call was dispatched Deputy observed a maroon Toyota

SUV with heavy front right side damage go passed the Sugarlimb exit. Deputy observed the Toyota sway back and forth within the travel lane and was driving under the speed limit with a line of cars behind it. Officer was advised by central dispatch that a white female wearing black boots, blue jeans and a white shirt went to Lenoir City Fire Department asking for help. After speaking with firefighters, the female walked off when asked if she was okay. Officer was then advised by central dispatch that the firefighter followed the female to Gold's Gym where she was seen knocking on the windows

of vehicles. Upon my arrival at Gold's Gym, Officer made contact with a female matching the description, who identified herself as Ms. Kayla Norris.

Officer was speaking with Ms. Norris who stated her and her boyfriend had been in an argument and she was walking it off. Officer then drove Ms. Norris back to her residence at Pearl Drive to meet with the boyfriend and get his side of the story. Upon arrival at the resi-

Evidence-based campaign continues with new powerful stories

The Tips campaign continues to tell powerful stories about real people experiencing smoking-related diseases and disabilities and the toll these conditions have taken on them and their loved ones.

The new 2022 Tips ads feature the following people:

Tonya M. developed heart failure from smoking cigarettes and relies on a surgically implanted heart pump to keep her alive. Now Tonya's husband and kids take care of her.

Michael F. lives with smoking-related chronic obstructive pulmonary disease (COPD). In his new ad, Michael explains that his wife used to smoke too, but she quit so she could stay healthy enough to help take care of him.

Rebecca C. smoked ciga-

rettes and got Buerger's disease, which cut off blood flow to her right foot. Only after the surgery to remove all five toes on her right foot did she fully understand how smoking could change her life.

Geri M. smoked menthol cigarettes and now lives with COPD. Although it's becoming harder and harder for her to breathe, Geri's tip is to enjoy every day and never give up hope about the future.

Asaad M. was 19 when his mother was diagnosed with colorectal cancer from smoking cigarettes, and he became her full-time caregiver. His tip for families is to find gratitude everywhere you can because nothing in life is guaranteed.

"For the past 10 years, the Tips campaign has saved lives and smoking-related healthcare costs with powerful, effective ads that motivate adults to quit smoking," said CDC Acting Deputy Director Debra Houry, MD, MPH. "One of the most important actions people can take to improve their health is to quit smoking. Today, we're releasing new ads and resour-

ces to inspire adults to make that lifesaving decision."

Tips addresses health disparities in pursuit of health equity

Although there has been significant progress in reducing cigarette smoking, it remains the single largest cause of preventable disease and death in the United States. In addition, unfair and unjust practices, policies, and social conditions have affected some population groups more than others, which, in part, has contributed to higher smoking prevalence in these populations.

The Tips campaign addresses tobacco-related health disparities to advance health equity by increasing the reach, representation, receptivity, and accessibility of quit smoking messages. The campaign also increases awareness of free quit-smoking resources among all adults—no matter who they are, where they live, or how much money they make. help people quit smoking. These ads are strategically placed on a variety of media platforms to reach communities and groups with high levels of smoking and smoking-related diseases.

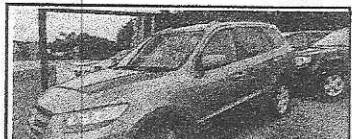

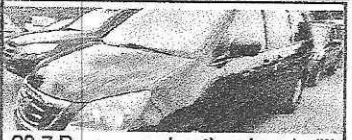

Dylan Parson, 21, Pine Ridge Drive Lenoir City, was charged with Public Intoxication, Man/Sell/Del/Resale Sch. IV & II, Simple Possession, Mfg/Del/Sale or Poss. Of Meth.

Kayley Marcum, 20, Copenhagen Road Lenoir City, was charged with Public Intoxication.

Officer R. Miller LCPD, responded to a call of service at Highway 321 (Waffle House) in Lenoir City, TN. The call referenced that there were two individuals asleep in a running vehicle parked in a handicap parking space in the Waffle House parking lot. On scene Officer made contact with the vehicle in question where Officer observed the male driver slumped over asleep and the female passenger also asleep with the vehicle running. Officer was able to wake both parties up by knocking on

the window of the vehicle, at which time Officer made contact with, Dylan Parson, driver and Kayley Marcum, passenger. While speaking with both subjects they appeared very lethargic and appeared out of it to the point that Officer believed that they were a danger to themselves as well as the public. While speaking with PARSON Officer also noticed a blue powder like substance around his nasal cavity. During the investigation the owner of the vehicle, MARCUM, gave verbal consent to search the entire vehicle including all the contents located inside as well. A search of the vehicle revealed (.43 Grams) of a crystal-like substance which tested positive through TRU-NARC for methamphetamine, (2.71 Grams) of a grey rock/powder like substance that tested positive through TRU-NARC for Fentanyl, (8 Grams) of a green leafy substance believed to be marijuana along with THC Wax, and (15) blue Xanax Pills. Also located with these items were (1) glass pipe used to smoke methamphetamine, (3) cut straws with residue inside of them, and (1) digital scale with residue. PARSON was mirandized, where claimed the bag that the items were located inside of belonged to him. PARSON also admitted to snorting a xanax sometime earlier that morning into late last night. Both subjects were transported to the Loudon County Jail.
