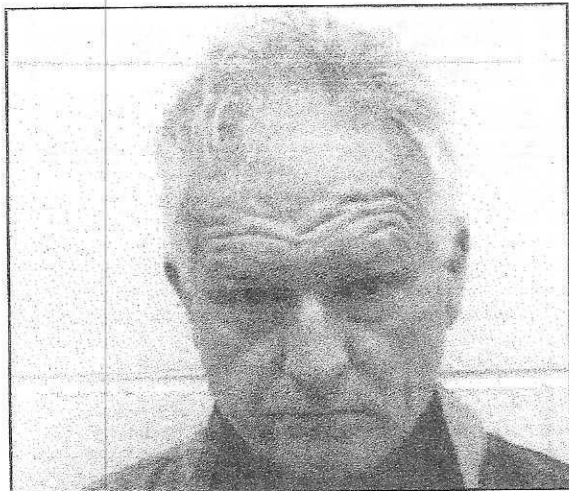

Comptroller's Office Updates Outcomes-Based Funding Formula Dashboards

The Tennessee Comptroller's Office of Research and Education Accountability (OREA) has released an update to its interactive dashboards explaining the outcomes-based funding formula (OBF), which allocates money to public colleges and universities based on how well they perform.

The formula gener-

ated \$1.25 billion for public colleges and universities for the 2022-23 school year.

The OBF uses a point system, in which a variety of measures within three main components (weighted outcomes of performance, fixed costs, and quality assurance) are used to determine each institution's point total. The proportion of state funding that

will be appropriated to each institution is then calculated using the point totals.

In total, there has been a 44% increase in the state OBF appropriation since 2016-17, driven by increased outcomes, inflation, salary and insurance increases, and other changing costs.

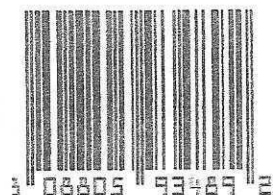

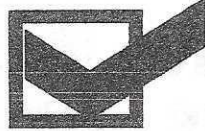

Alexis Waller, 19, Pathkiller Trail Loudon, was charged with Simple Possession, Poss. Of Drug Para., Man/Sell/Poss. Of Controlled Substance, and Light required on Motor Vehicle.

Deputy Marshall Lynn LCSO, observed a white Toyota sedan operating without a functioning right brake light, in the area of Highway 11 and Blair Bend Road. Deputy initiated a traffic stop on the vehicle at Carl's Drive In and made contact with the driver, later identified as Alexis Waller, who could not provide proof of financial responsibility. Deputy immediately detected the distinct odor of Marijuana emitting from the vehicle and asked Alexis Waller to exit. Deputy asked her how much Marijuana she had and where it was located. She then retrieved a Marijuana cigarette from the center console area of the vehicle and handed it to him. Deputy informed her that another officer was en route and he would be searching the vehicle. She then stated "you are going to take me to jail." Deputy asked if there was anything else in the vehicle and she retrieved a makeup bag from under the driver's seat and handed it to Deputy. A search of the bag revealed 2.3 grams

of a crystalline substance in a plastic baggie, which later tested positive for methamphetamine on a TruNarc Scan Report. Additionally, Deputy located a Marijuana smoking pipe, a Marijuana grinder, two plastic containers with Marijuana residue, Zig Zags, several additional plastic baggies with methamphetamine residue, and a digital scale which is consistent with illegal narcotics distribution, inside the bag. A search of the vehicle revealed two more Marijuana smoking pipes, a folded dollar bill containing a crystalline substance, which later tested positive for methamphetamine on a TruNarc Scan Report, and a rolled up dollar bill, which appeared to be used for narcotics ingestion. Alexis Waller was arrested and transported to the Loudon County Justice Center for further processing. The vehicle was towed by James Wrecker Service. When interviewed by narcotics investigators at the Justice Center, Alexis Waller stated "you look at me and see a drug dealer but I see someone who is just trying to provide for their family" and "I bet I work harder than you." This did occur in Loudon County, Tennessee. DASH CAM/BODY CAM.
