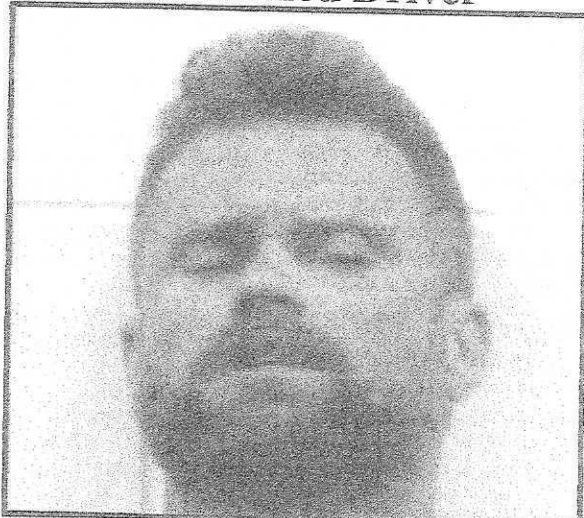

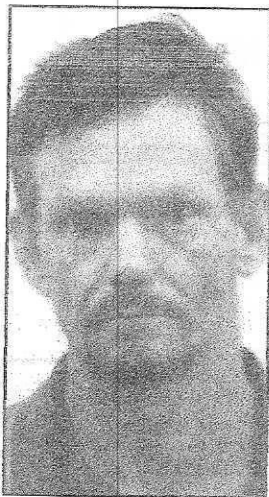

U.S. Adult Tobacco Product Use Decreased from 2019 to 2020

Yet nearly 1 in 5 adults reported tobacco product use in 2020

Findings from a Centers for Disease Control and Prevention (CDC) Morbidity and Mortality Weekly Report released today show decreases in the use of commercial tobacco products overall, combustible tobacco products, cigarettes, e-cigarettes, and two or more tobacco products among U.S. adults from 2019 to 2020. Yet

nearly 1 in 5 adults (an estimated 47.1 million) reported current (every day or some days) tobacco product use in 2020, including 30.8 million who smoked cigarettes.

To assess recent national estimates of tobacco product use among U.S. adults 18 years old or older, CDC analyzed data from the

2020 National Health Interview Survey. The survey assessed use of five tobacco products: cigarettes, cigars (cigars, cigarillos, or filtered little cigars), pipes (regular pipes, water pipes, or hookahs), e-cigarettes, and smokeless tobacco.

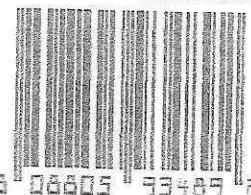

Lorrie Lankford, 55, Manis Road Lenoir City, was charged with Simple Possession x4, Poss. Of Drug Para., Unlawful Carrying or Possession of a Weapon x2, and Assisting other Agency.

Miranda Lankford, 30, Manis Road Lenoir City, was charged with Child Abuse/Neglect/Endangerment.


Deputy Chance Gray LCSO, was dispatched to the area of Manis Road near Highway 321 in reference to a small child walking in the middle of the roadway. Upon arrival in the area, Deputy made contact with complainant who was holding a small child wearing nothing but a diaper and screaming. Deputy then began speaking with complainant and her husband, who stated that they were driving on Manis Road near Highway 321 when they observed the child walking on the road with no one around. They then stated that the mother ran down the hill and stated that she was sorry. Complainant stated that she then advised the mother then told her to keep the baby until the police arrived on the scene. Deputy then began walking to the house which was located approximately 200 yards from the road where the child was located. Once at the house, Deputy made contact with the biological mother Ms. Miranda Lankford who appeared intoxicated being very unsteady on her feet. Ms. Lankford stated that she had just turned her back for a second and the child was gone, that the child was probably chasing a dog. Officer Riley Miller then arrived on the scene and stood with Ms. Lankford. Officer Riley Miller then advised that Ms. Lankford

began nodding off and could not stay awake. Deputy then made contact with the grandmother of the child Ms. Lorrie Lankford, who stated that the mother of the child told her that someone was coming to the home to bring her money and she wanted to introduce the child to them. She stated that approximately 45 minutes later the mother returned inside without the child. She stated that she then asked the mother about the child and she responded that she had brought her to the door and then fallen asleep in the truck in the driveway. She stated that she then began looking for the child. The child was identified as two-year-old. The mother Ms. Maranda Lankford did knowingly fail to protect the child from abuse, neglect, or imminent danger by not properly observing the child allowing her to get into the roadway, near a major Highway that could have caused great harm or death to the child. While on scene multiple cars travel Manis Road along with countless vehicles traveling 321 at high rates of speed. While speaking with Ms. Lorrie Lankford it was learned through dispatch that she had an active warrant out of Monroe County for violation of probation. While awaiting the arrival of DCS she asked to use the restroom and change the baby's diaper. She was then escorted to the home where Deputy escorted her into the home to prevent her from causing harm to herself or the child. While she was using the restroom, Deputy observed in plain view two meth pipes, one mirror with white powder residue on the stove next to a child's toy, and two blue pills lying on the kitchen floor. She then came out of the restroom and asked if

she could get her drink out of her bedroom. She was then advised that Deputy would have to escort her to which she stated, sure you can go anywhere I don't care. While in the bedroom, Deputy observed in plain view one mirror with a cut straw and a white powder residue on the nightstand of the bed. She was then escorted to the porch of the home. LT. Shane Ezell was then advised of the situation and responded to the home. Once on scene LT. Ezell advised Ms. Lankford as to why he was there and asked her for consent to go into the home. Ms. Lankford agreed and signed a consent form. While in the home LT. Ezell located two blue round pills lying on the kitchen floor that was identified as clonazepam and one green round pill identified as oxycodone, all three easily accessible to the child. He also located 1.3 grams of a clear crystal substance identified as meth, along with 0.7 grams of a brown substance identified as Fentanyl in an unlocked, open firebox lying on the bedroom floor that was also easily accessible to the child. In an unlocked

closet of the same bedroom one 22 caliber rifle with a loaded magazine, one 410 gauge shotgun, and one 12 gauge shotgun were located among the child's clothing. Also in the same bedroom, one large pill container with Ms. Lankford's name was located containing .45 caliber ammunition. In the second bedroom of the home LT. Ezell located a 45 caliber pistol in a large toolbox. While in the home Ms. Lankford discovered that the handgun had been located in the toolbox she stated that she had just moved that toolbox yesterday. Ms. Lankford recklessly engage in conduct that placed the child in imminent danger of death or serious bodily harm by leaving drugs in the home that would have caused serious harm or death to the child had she gotten ahold of them. Ms. Lankford also while on scene kept changing her story as to what bedroom was hers. Ms. Lankford was confirmed to be a convicted felon out of Loudon County with a charge of ATT meth delivery/sell with the most recent conviction date of 02/21/2020.

This study found that, in 2020, 19.0% of U.S. adults used at least one tobacco product, down from 20.8% in 2019. Cigarettes remained the most commonly used product (12.5%), followed by e-cigarettes (3.7%), cigars (3.5%), smokeless tobacco (2.3%), and pipes (1.1%).

"We have made significant progress in preventing and reducing tobacco product use in this country by using proven strategies and implementing effective policies," said Karen Hacker, MD, MPH, Director of CDC's National Center for Chronic Disease Prevention and Health Promotion. "Despite significant declines in adult tobacco use, our work is far from over. We must continue to address tobacco-related health disparities and inequities to ensure everyone has the opportunity to be as healthy as possible."

Despite Declines, Use of Combustible Products Remains High

This study shows that adult cigarette smoking declined to the lowest prevalence recorded

since it was 42% in 1965. Although the percentage of adults who smoked cigarettes declined—from 14.0% in 2019 to 12.5% in 2020—nearly 31 million U.S. adults reported smoking cigarettes in 2020. More than three-fourths of adults who currently use tobacco products use combustible products (e.g., cigarettes, cigars, pipes), which are the predominant cause of tobacco-related disease, disability, and death in the United States.

The percentage of U.S. adults using other tobacco products also decreased from 2019 to 2020, including: use of e-cigarettes from 4.5% to 3.7%; use of combustible tobacco products from 16.7% to 15.2%; and use of two or more tobacco products from 3.9% to 3.3%.

Factors that may have contributed to the decline in cigarette smoking and other tobacco product use include high-impact anti-tobacco media campaigns (e.g., CDC's Tips From Former Smokers®), smokefree policies, and policies limiting the availability of specific types of tobacco products, such as

flavored products.

Disparities in Tobacco Product Use

In 2020, there continued to be marked differences in any current tobacco product use among different groups of U.S. adults. These groups included:

- Males (5%).
- Adults 25-44 years old (9%).
- Non-Hispanic American Indian/Alaska Native adults (34.9%) and non-Hispanic adults categorized as other race (1%).
- Adults living in rural (non-metropolitan) areas (3%).
- Adults whose highest level of educational attainment was General Educational Development (GED) certificate (40.5%).
- Adults with annual household

income of less than \$35,000 (25.2%).

Adults identifying as lesbian, gay, or bisexual (1%).

Uninsured adults (27.3%) and those insured by Medicaid (6%).

Adults living with a disability (4%).

Adults who regularly had feelings of anxiety (29.6%) or depression (6%).

What more can be done?
The implementation of comprehensive, evidence-based, population-level interventions, in coordination with regulation of tobacco products, can reduce the burden of tobacco-related disease, disability, and death in the United States.

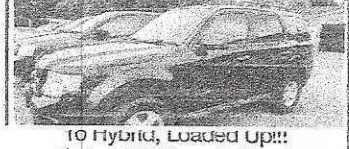

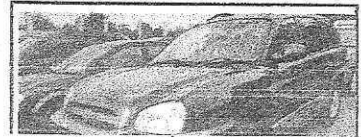

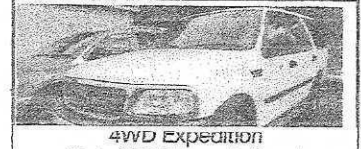

Andrei Bystry, 41, Laurel Lake Circle Madisonville, was charged with DUI, Leaving the Scene of Accident, Poss. Of Handgun While Under the Influence, and Resisting Arrest.

Deputy Pesterfield LCSO, responded to the area of Interstate 75 Southbound for a hit and run. The caller advised a white Toyota Sequoia hit multiple vehicles and continued to drive erratically. The Toyota pulled into the parking lot of the Philadelphia School, traveling the wrong way on the roadway, almost striking multiple vehicles. Deputy Akins contacted the vehicle and detained the driver, identified as Mr. Andrei Bystry. Deputy observed the offender had bloodshot watery eyes, slurred speech, and a strong odor of an alcoholic beverage coming from

his person. The offender was uncooperative and refused to follow orders. Due to the circumstances, Deputy placed the offender in custody at that time. 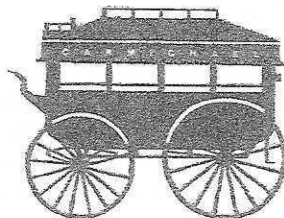
Upon arrival at the jail, the offender was still not compliant therefore, Deputy could not obtain a sample for chemical testing. Inside the offender's vehicle was a Springfield ACP handgun with multiple rounds of ammunition.
