

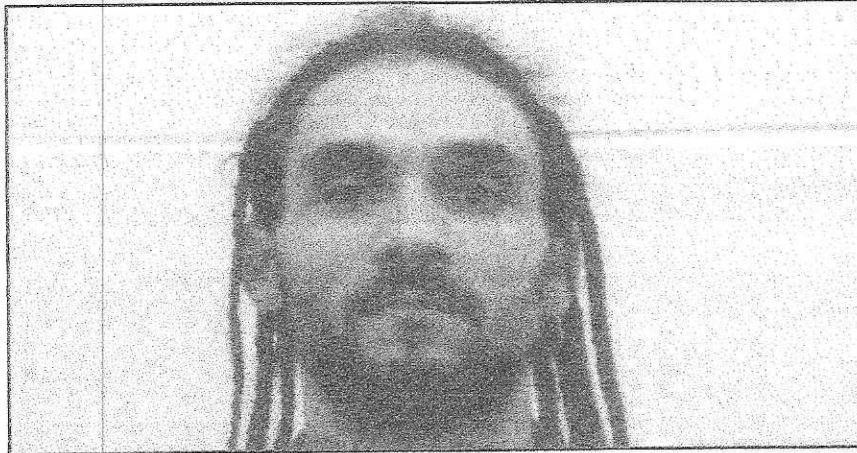

DUI Follows Wreck after Reckless Driver Call

Garrian King Charged With Being A Felon In Possession Of A Firearm

Arrest Connected With Circumstances Surrounding June 5, 2022 Shootings In Chattanooga

Garrian King was arrested in Chattanooga by agents with the Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF), the Federal Bureau of Investigation (FBI), and officers with the Chattanooga Police Department for being a felon in possession of a firearm in violation of Title 18, United States Code, Section

922(g)(1). This arrest is in connection with the shootings that occurred on June 5, 2022, in Chattanooga.

An initial appearance was held yesterday, in the United States District Court in Chattanooga, before the Honorable Christopher H. Steger, United States Magistrate Judge. Mr. King was detained without bond.

The details of the charge of possession of a firearm by a convicted felon by King on June 6, 2022, are outlined in the arrest warrant and supporting affidavit, which are filed as public records in the United States District Court for the Eastern District of Tennessee at

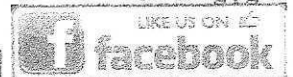

Miller LCPD, was conducting a routine patrol in the area of Old Hwy 95 near Ivy. Officer observed a silver blazer traveling east on Ivy Avenue. Officer observed the

driver not come to a complete stop at the stop sign on Hwy 95 @ Ivy. Officer initiated a traffic stop near Weigles, and made contact with the driver Brian Nadar who is from Michigan, stated he was here staying with his sister. 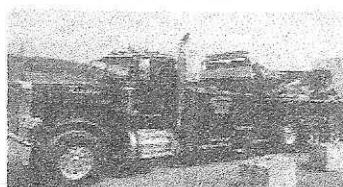

Due to victim thinking that Kimberly was going to harm herself, both individuals again got into a physical altercation due to victim trying to take the gun away from Kimberly. Victim friends were witnesses to the whole altercation, and did provide written statements. Officer did speak with Ms. Kimberly Edmonds who did advise him that she was not at all suicidal, and she stated she only said she was going to shoot herself to make her daughter feel guilty. After further investigation, and based off the stories of the witnesses, Kimberly Edmonds was placed under arrest.
