

Shimikia Bell, 44, Beals Chapel Road Lenoir City, was charged with Child Abuse or Neglect/Endangerment.

Deputy Harrison LCSO, was dispatched to Beals Chapel Road in reference to a juvenile male that showed up on the complaints porch who stated he was being abused and had run away from home. Once on scene, Deputy Spoke with the Juvenile, who stated the legal guardian Shimikia Bell who resides at Beals Chapel Road had hit him on his back and buttocks with a belt after he had missed questions on a test she had given him and his siblings. Victim stated Shimikia had given him a multiple-question test and when he missed a question she would have him stand in the corner of the room and hold a weight over his head for a period of time. If victim was to drop the weight or put his arms down Shimikia would state "that is 3 pops" referring to hits with a belt. Deputy did observe victim to have severe welts and lacerations on his back along with lacerations and bruising on his buttocks. Deputy transported the juvenile from the complainant's address to Beals Chapel Road. Sgt. Pesterfield arrived on scene and spoke with Shimikia who stated she did hit victim with the belt as a form of punishment. Detective Parton arrived on scene and spoke with both parties. There are a total of 4 children that live at the residence and an immediate response report was filed with DCS on scene. Based on the statements from both parties and physical evidence, Deputy placed Shimikia Bell in custody for child abuse. This did occur in Loudon County, Tennessee.



ing his life sentence. Additionally, he was ordered to pay restitution in the amount of \$5,890.10 to the family of the victim for funeral and related expenses.

According to court documents and evidence presented at trial, Williams sold heroin, fentanyl, and acetyl fentanyl to confidential informants on several occasions in 2018. The evidence further showed that Williams distributed drugs to a Kodak, Tennessee resident, which resulted in his death on Thanksgiving morning, November 22, 2018. Finally, the evidence showed that on March 27, 2019, agents seized quantities of heroin, fentanyl, and acetyl fentanyl, a firearm and ammunition, and over \$10,000 in cash from Williams.

United States Attorney Francis M. Hamilton III and Homeland Security Investigations Special Agent in Charge Jerry C. Templet Jr. made the announcement.

Law enforcement agencies participating in the joint investigation which led to the indictment and subsequent conviction of Williams include the Sevier County Sheriff's Office ("SCSO") and Homeland Security Investigations ("HSI") with the participation and assistance of the Sevier County Street Crimes Unit, the Tennessee Bureau of Investigation, and the U.S. Marshal's Service.

Assistant United States Attorneys Brent N. Jones and Anne-Marie Svolto represented the United States at trial.

This case was prosecuted as part of Operation Synthetic Opioid Surge (SOS), a Department of Justice program that seeks to reduce the supply of deadly synthetic opioids in high impact areas and to identify wholesale distribution networks and international and domestic suppliers.


