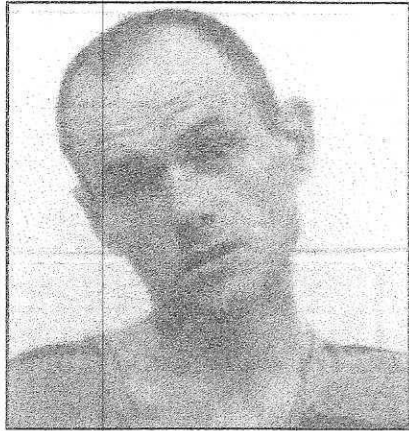
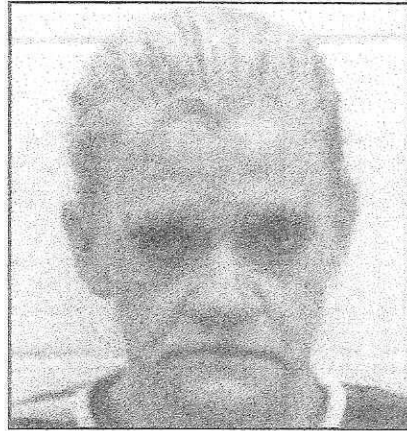

## Comptroller's Office Congratulates 12 Counties with Clean Audits

Tennessee Comptroller of the Treasury Jason Mumpower is pleased to announce a significant accomplishment by 12 Tennessee counties. These counties, which are audited by the Comptroller's Division of Local Government Audit, have each received a clean audit report for the fiscal year ending June 30, 2021.

The 12 counties are

Blount, Coffee, Cumberland, Gibson, Giles, Hamblen, Henderson, Lauderdale, Loudon, Marion, Roane, and Robertson.

The annual audits for these counties were completed without any findings. Audit findings are used to report on weaknesses, deficiencies, or areas of noncompliance within government operations.

All 12 counties are being recognized at the Tennessee County Services Association Legislative Conference in Gatlinburg.

"A clean audit is not easy to achieve," said Comptroller Jason Mumpower. "It takes hard work and dedication from each county official and numerous staff to ensure strong

accounting procedures and a system of internal controls that protect public resources. The Tennesseans who live and work in these counties should celebrate this achievement.”


This honor is especially noteworthy for Loudon County, which has received a clean audit for five years in a row. Robertson County has received its third consecutive clean audit, and Henderson County has had a clean audit for two years in a row.

The 91 Tennessee counties audited by the Comptroller’s

Office received a total of 278 findings in fiscal year 2021. This represents an average of 3.05 findings per county. In fiscal year 2020, Tennessee counties received an average of 2.97 findings in their annual audit reports.

Leatha Cardin, 56, Old Bailey Road Loudon, was charged with General Session Capias, Poss. Of Drug Para., and Mfg/Del/Sale or Poss. Of Meth.

Deputy N. Crawford LCSO, with the Loudon County Sheriffs Office was conducting patrol in the area of Highway 72 & Steekee School Road. While turning onto Steekee School Road Deputy noticed a white female pushing a bicycle on Steekee School Road. Deputy drove up to the female and got out and began speak with her, Deputy asked the female if she minded providing him with an ID to which she did. At this time she continued walking down the road. The ID number she gave me returned to a Tennessee ID to a Leatha A. Cardin. A records check revealed Ms. Cardin to have a warrant for her arrest out of Lenoir City, Tennessee for Simple Possession Of Methamphetamine. At this time Ms. Cardin was placed into custody. Upon arrival at the jail Ms. Cardin advised Deputy and Loudon County Sheriffs Office Correctional Staff that inside her purse was Methamphetamine, a glass smoking pipe, and a straw with residue. The substance is described as a white crystal-like substance consistent with that of Methamphetamine and based upon my training is believed to be Methamphetamine. Also located was a glass pipe and straw with a white residue that based upon my experience is consistent with the use of Methamphetamine. The crystal like substance was weighed at 3.5 grams and was taken along with the pipe, and straw as evidence. Ms. Cardin was booked into the Loudon County Jail without further incident. All the above did occur in Loudon County.
