

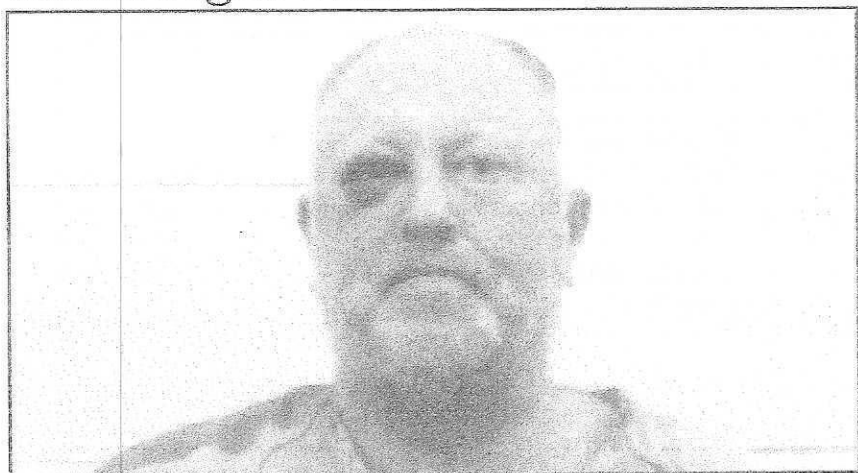

Federal Jury Convicts Deshawn Whited Of Multiple Hobbs Act Robberies, Carjacking, And Firearms Offenses

a federal jury convicted Deshawn Whited, 25, of Knoxville, Tennessee, of four counts of Hobbs Act Robbery, one count of Attempted Hobbs Act Robbery, one count of carjacking, four counts of brandishing a firearm in furtherance of a crime of violence, and one count of felon in possession of a firearm, following

a four-day trial. The Honorable Katherine A. Crytzer, United States District Judge, presided over the trial. Whited faces a sentence of over 100 years in prison. The armed robberies and the armed carjacking all occurred in Knoxville between January 12th, 2021, and January 20th, 2021. The evidence presented at trial included wit-

ness testimony, surveillance footage from multiple businesses across the Knoxville area, and physical, forensic and digital evidence, including items of clothing, firearms, cell phone information, and DNA.

"This prosecution is part of the Department of Justice's comprehensive strategy to re-

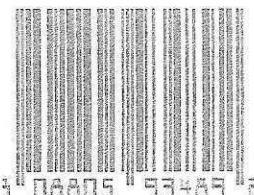

Thomas Hooper, 52, Edgewood Avenue North Carolina, was charged with Aggravated Assault, Possession of Sch. II, Simple Possession, Resisting Arrest, and Vandalism

Officer Everett LPD, was dispatched to the address of Hwy 72, Americas Best Value Inn. Complainant advice, male in room 108 broke a window. Upon Officer Everett arrival he advice male subject was uncooperative and none complaint with the officer commands. Upon Officer Luna's arrival, observed Officer Everett backing out of one of the rooms with the male subject. Upon both officers, attempting to deescalate the situation, male subject still wasn't cooperative with the officer's commands. Upon Officer Everett attempting to detain the male subject outside of the room, male subject aggressively resisted officer Everett, due to the point the male subject moved Officer

Everett towards the broken window, causing both the Officer and male subject to go through the glass window, braking almost the entire room window and ending up inside the room. Charles Taylor, 33, North Ocoe Street Cleveland, was charged with Simple Possession x3, and Poss. of Drug Para. Officer R. Miller LCPD, was conducting a patrol in the area of Highway 321 near Interstate 75 in Lenoir City, TN. During patrol duties Officer observed a white in color Ford sedan traveling south on Highway 321. While observing the vehicle Officer noticed that the male driver was not wearing a seatbelt and was also using his cellular device while the vehicle was in motion on a public roadway - Highway 321. Officer then initiated a traffic stop. Upon traffic stop Officer made contact with the male driver who was identified as Charles Taylor Jr. While speaking with TAYLOR Officer noticed

that he was showing signs of nervous behavior such as his hands trembling along with him continuously talking. During the traffic stop Officer noticed that whenever TAYLOR was looking for his vehicle registration, he moved a sweatshirt located in the passenger's side floor board two different which looked as if he was trying to conceal items. Officer noticed near the sweatshirt that there was an open container of Mikes Hard Lemonade. When Officer asked TAYLOR if he was attempting to hide something under the sweatshirt he nervously stated no and claimed that the Mikes Hard Lemonade was old. Officer also visually observed an open used bottle of U-Pass which is fake urine commonly used to pass drug tests. The U-Pass was visually observed whenever

TAYLOR opened his center console. Officer then had TAYLOR step out of the vehicle to speak with him about a citation. While speaking with TAYLOR Officer was granted verbal consent to conduct a search of the entire vehicle. Located in the center console of the vehicle near the U-Pass was a cut straw which is commonly associated with

snorting powdery substances. Officer also located a pill bottle with a torn off prescription label that contained a variety of pills underneath the sweatshirt TAYLOR was moving at the beginning of the traffic stop. Located inside of the pill bottle were, (26) Diazepam, (7) Hydrocodone and (1) Oxycodone.

Daniel Carver, 42, Highway 72 Loudon, was charged with Aggravated Assault.

Deputy Parks LCSO, responded to Clear Branch Road North in reference to a domestic. On scene, Deputy made contact with Mr. Daniel Carver who advised he and his girlfriend had gotten into an argument. Deputy asked Mr. Carver if the confrontation had gotten physical and he advised it did not. Deputy spoke with Mr. Carver's girlfriend/ victim, who advised they had been arguing and he became physical. Victim advised he grabbed her around the neck with both hands and began strangling her. She stated he then threw her across the room. She made her way to the chair in the living room and he followed. She advised he began to strangle her again and threw her across the room and she hit

the printer. There were visible marks on victim neck that were consistent with the story. These were documented on Axon Body Worn Camera. The printer was also knocked in the floor. Deputy spoke with a neighbor who showed pictures of the injuries immediately following the incident. Victim filled out a domestic assault statement form and Mr. Carver was placed under arrest. 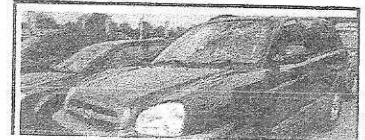

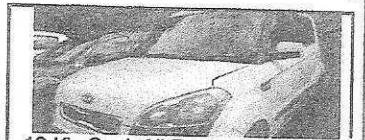

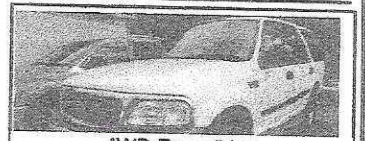

duce violence and increase safety in our community by aggressively prosecuting criminals who engage in violent crime," said United States Attorney Francis M. Hamilton III.

"The collaborative effort between the FBI and the Knoxville Police Department ensured this defendant was brought to justice and will no longer be able to threaten or harm the citizens and businesses in our community. We will continue to aggressively seek out those who prey upon innocent victims and hold them accountable," said FBI Special Agent in Charge Joseph E. Carrico.

"Preventing violent crime and addressing it after it occurs will always be the top priority of the Knoxville

Police Department. I am proud of the many members of our department who were involved in this investigation from the beginning and helped see it through to this conclusion. Their efforts and contributions ensured the removal of a violent individual from the streets of Knoxville," said Chief Paul Noel, Knoxville Police Department.

Assistant U.S. Attorneys Alan S. Kirk and Brent N. Jones represented the United States at trial.

Law enforcement agencies participating in the joint investigation and prosecution of Whited include the Federal Bureau of Investigation (FBI) Safe Streets Task Force and the Knoxville Police Department's Violent Crime Unit and Organized Crime Unit, as well as Knoxville Police Department Pa-

trol Officers and Forensic Crime Scene Technicians.

This case is part of Project Safe Neighborhoods (PSN), a program bringing together all levels of law enforcement and the communities they serve to reduce violent crime and gun violence, and to make our neighborhoods safer for everyone. On May 26, 2021, the Department launched a violent crime reduction strategy strengthening PSN based on these core principles: fostering trust and legitimacy in our communities, supporting community-based organizations that help prevent violence from occurring in the first place, setting focused and strategic enforcement priorities, and measuring the results.

Medical Center. Officer were available to calm Mr. Hooper. Which he was later Transported by the Loudon County Vehicle. To the Loudon County Jail without incident. Detective Jenkins returned to the scene to observed the damages. And speak with the Hotel manager, which stated Mr. Hooper broke 4 windows of each individual room, value of \$1000 dollars each, bringing an estimate value of \$5000 dollars worth of damage. It was later found by Detective Jenkins a small bag with the contents of white powder later to be believe to be Cocaine 0.5 Grams, inside the room on the coach, with also a small amount of green leaf substance, 4 Grams.

All of the above occurred in the City of Loudon TN.

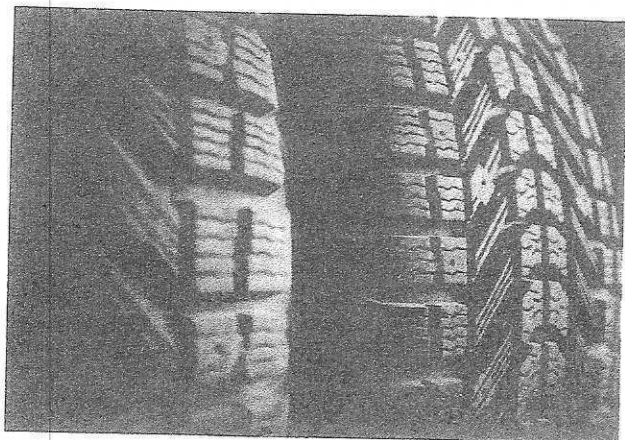

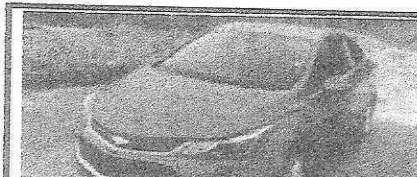
