



Deputy Harrison LCSO, observed a black Cadillac sedan following too closely to the vehicle in front of it in the right-hand lane on Interstate 75 northbound. 



of Solid Waste. The landfill director noticed a missing deposit on the monthly bank statement; however, the director did not have a receipt and the bank did not have a record of the money being deposited.

The fifth finding is related to the Office of County Clerk which failed to properly secure a deposit totaling \$3,115.88. The money was left unsecured in a separate room in the office. Investigators determined that

inmates assigned to help move items in the office had stolen the funds. The entire amount was recovered and deposited into the bank.

We believe Dickson County should consider adopting a central system accounting, budgeting, and purchasing," said Comptroller Jason Mumpower. 'This would bring the school department's budget and finance function into a central office with the county and highway department's finance operations. A centralized office can significantly improve accountability and the quality of services provided to citizens."

most recent use being the day prior. Deputy asked if there was to be anything illegal in the vehicle and where would it be located and he stated "I assume the back seat". Hess then stated a small amount of meth was lost in the vehicle and there was a black bag in the vehicle and described the contents of one of the pockets. Narcotics investigator C. Jenkins as well as Deputy Branson arrived on the scene to assist with a probable cause search of the vehicle. During the search, Deputy located a small Adidas bag hehind the center console in the back seat area of the vehicle. In the pocket with the contents that Hess described were two small black cases. One contained two small baggies with approximately 4.9g of meth and 0.4g of fentanyl and the other contained approximately 6.0g of meth. Another small camouflage container was located in the same pocket with approximately 0.6g of meth as well. In another pocket of the bag Deputy located multi-ple needles, liquid Narcan, a bottle cap, and a scale with a crystal-like residue.

Both Hess and Corely were read Miranda and denied ownership of the bag. Based on the above facts both subjects were placed in custody and transported to the Loudon County Jail. TruNarc scans were conducted on all substances which resulted in 3 positive tests for methamphetamine and 1 positive test for fentanyl. This did occur in Loudon County, Tennessee.




