## Chinese High-Altitude Balloon Recovery Behind the Bureau's role as the lead governing agency for the forensic examination of the Chinese high-altitude balloon

Chinese Balloon Recovery 03

FBI Special Agents assigned to the Evidence Response Team process material recovered from the high-altitude balloon recovered off the coast of South Carolina. The material was processed and transported to the FBI Laboratory in Quantico, Virginia.

In a news briefing on Thursday, senior FBI officials detailed the Bureau's role as the lead

governing agency for the forensic examination of the Chinese high-altitude balloon identified and shot down February 5 by the U.S. military off the coast of South Carolina.

The Operational Technology Division and the Laboratory Division are working closely with subject matter experts from the Department of Defense and other government agencies. Additionally, personnel from the FBI's Washington,

Columbia, Charlotte, and Norfolk field offices have deployed personnel, including ERT- and USERT-trained agents, to assist with the logistics of the recovery and analysis of the debris.

Michael Paul, assistant director of the Operational and Technology Division (OTD), and Eric Pokorak, assistant director of the Laboratory Division, said it is

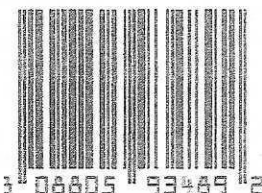

Michael Coffman, 35, Vale Street Loudon, was charged with Mfg/Del/Sale or Poss. Of Meth, Man/Sale Del/Resale Sch. IV, Simple Possession, and Poss. Of Drug Para.

LPD Officers and 9th DTF Agents responded to Vale Street Lot B Loudon, TN for a report of a possible overdose. Once on scene it was determined that a male subject identified as Michael Coffman was unresponsive and was administered 2 doses of Narcan by LPD Officers.

Coffman began to regain consciousness and was checked out and cleared by EMS personnel. On the previous night (2/2/2023) LPD officers responded to the residence for the same call of Mr. Coffman overdosing and at that time he was trans-

ported to the local hospital via EMS. On 2/3/2023 LPD officers observed in plain view a small amount of a crystal substance (1.5 Grams) believed to be methamphetamine and a straw with powder residue in a chair in the living room area of the residence. Mr. Coffman was placed into custody for simple possession and a search of his wallet revealed 1 (one) white round pill tentatively identified as Sublingual, a Sch III narcotic, and 20 (twenty) rectangle shaped pills, tentatively identified as Alprazolam, a Sch IV narcotic. Mr. Coffman did make the statement to arresting Officers the pills were "pressed pills" indicating they may contain Fentanyl. These said actions did occur in Loudon County, TN.

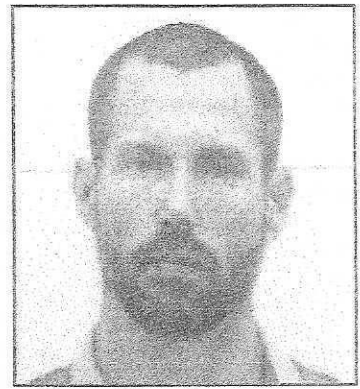

Kasey Chambers, 37, Howards Chapel Road Vonore, was charged with Driving on Revoked/Suspended License, Man/Sell/Del/Resale Sch. II, and Poss. Of Drug Para.


Deputy Jackson LCSO, observed a Dodge Van bearing TN tag # 007BDTM, turn on to East Coast Tellico Parkway. Upon running a registration check through Loudon County Dispatch, they advised that the registered owner, Taylor Blair, had a Revoked Driver's License. Deputy conducted a traffic stop at Riden Road, with a stop location on Riden Road. Deputy made contact with a male driver, who identified himself as Kasey Chambers. He could not provide a license, but gave Deputy his name and date of birth.

Upon checking him through Dispatch, it was found that his Driver's License was suspended. The male in the passenger seat identified himself as Wayne Alexander, and upon checking him through Dispatch, he was found to have an active warrant for FTA out of Loudon County, Docket # 2022-CR-445. He was taken into custody, and upon conducting a search incident to arrest, a needle was found in his jacket pocket. Mr. Alexander was questioned as to whether he had anything on his person prior to the search, and indicated that he did not. The female in the back passenger seat identified herself as Taylor Blair. While speaking with Mr. Chambers, he gave consent to search the vehicle. Upon searching the vehicle several items were found, a half crushed can of Mountain Dew with a cut straw and baggie; another crushed can of Mountain Dew with two baggies, one containing what appeared to be 0.7g of fentanyl; a powdered make-up container with three baggies, one containing what appeared to be 2.1g of fentanyl; in Ms. Blair's purse two blue pills identified as

Alprazolam 1mg and 15 yellow pills identified as Clonazepam 0.5mg; in one of Mr. Alexander's bags a scale, spoon with residue and a needle. Mr. Chambers claimed the Mountain Dew can with the cut straw, and Mr. Alexander claimed the other can, however, none of the vehicle occupants would claim the make-up container. Mr. Chambers, and Ms. Blair, were taken into custody. All three subjects were transported to the Loudon County Detention Center, without incident.

**Interference**

Seth Byrd, 22, Finley Drive Lenoir City, was Charged with Custodial Interference.

Deputy Kirkland LCSO, was made aware of a blue Ford Explorer traveling north on highway 321. According to the complainant, the vehicle contained a father and a 2-year-old that the father was not allowed to have custody of. The call originated as a Lenoir City Police Department call. After further investigation, it was revealed that the call occurred at Hirst Road. The complainant, (Step Grandpa), called and stated that Seth Byrd (His stepson) had taken his biological child from Hirst Road and was in the area of White Wind Road/ Waller Ferry. While en route to the area Deputy located the mother at Waller Ferry. The mother, stated that she allowed the child to go to the grandparent's house to visit with them and the biological father, Seth Byrd. The child was at the grandpar-

ents' house because she stated that Seth is not responsible or trustworthy enough to watch the child by himself, so the grandparents of the child were there to supervise Seth. Mother stated that she was not notified by the grandparents that her child was gone until hours after the child was taken. The Step grandpa, stated that Seth went to Walmart with Seth's mother and the child around 8 PM on 01/31/2023 and came back. Grandfather and his wife went to sleep while Seth had the child downstairs playing with him and when they woke up the next morning, Seth and the child were gone. Hours after Eric noticed the child missing is when Mother was contacted and then Law Enforcement. Mother stated that Seth and the child were with male because she saw them at the KARM store in Lenoir City. Due to the male being with Seth and the child, CID pinged his phone due to safety concerns for the child because of Seth's crimi-

nal history. The phone pinged at Finley Drive in Lenoir City. Lenoir City PD and Loudon County Sheriff's office responded to the area to locate the vehicle that Seth and the child were seen in. The vehicle, child, and father were located on Finley drive by other units. When Deputy arrived on the scene, Seth was sitting down in handcuffs. Deputy Hawkins read Seth his Miranda Rights and he agreed to speak without a lawyer present. Seth stated that he took the child from the residence on Hirst Road and dropped him off at a babysitter in Loudon while he went to his court date. After court, he picked the child up and drove

to the KARM store to shop. Seth stated this is when Mother showed up and was acting crazy.

Deputy asked Seth if at any point Mother yelled at him to give her the child back at the KARM store and he stated yes. Seth stated he did not give the child back because she was acting crazy. Seth and the mother have never been married nor do they have a parenting plan in place. Seth took the child without the permission of the mother and refused to give the child back when she asked. Due to this, Seth was placed under arrest for TCA 39-13-306: Custodial Interference.

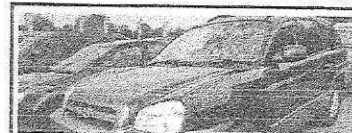

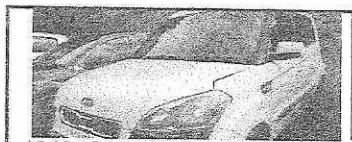

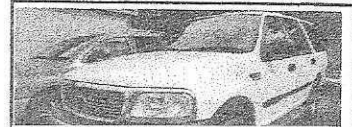

too early in the investigation to determine the intent and capabilities of the balloon.

Pokorak said much of the evidence remains underwater and that the FBI is coordinating further searches with the U.S. Navy and Coast Guard. Dive teams from the FBI and U.S. Navy are working together.

"We were on-scene late Sunday, on February 5, and the first evidence that was received was transported to Quantico and received late Monday, February 6," he explained. Pokorak described the search area as a "large-scale scene" and said

weather concerns in the next few days "may impact" evidence collection and the transportation of recovered items:

FBI technical and forensic experts from the FBI's Science and Technology Branch positioned for incoming evidence.

Once the evidence is received at the FBI Laboratory in Quantico, Virginia, a team of experts engages in a decontamination process, Pokorak continued. "In

simple terms, that is removing the salt water from the evidence itself. Rinsing and washing it so that it can be further processed."

The evidence recovered so far has been limited to surface findings, including the balloon (or canopy itself) some wiring, a tiny amount of electronics—but only a small portion of the payload.

"We have not seen the payload where we expect to see the lion's share of the electronics," said Paul. "OTD deployed specialists to assist with screening and to specifically assess electronic components that might be recovered during the operation."

He said this investigation marks the first time the FBI Laboratory and OTD have responded to a "hot air balloon of this nature" and the processing of the

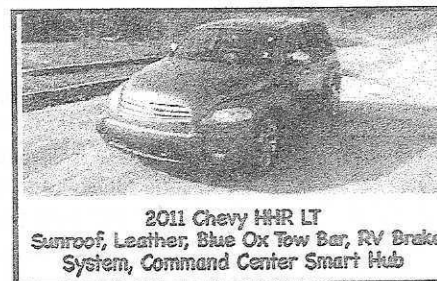
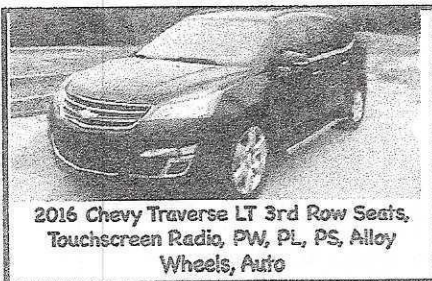
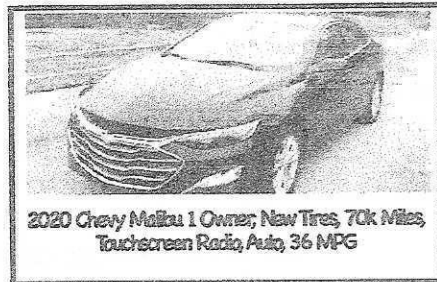
corresponding scene. Paul said no "energetic or offensive material" has been detected but emphasized much of the evidence has yet to be recovered.

Asked about the manufacturer of the balloon or whether its design was based on stolen intelligence, Paul said the FBI is not in position "at this point to have that information." He said both the FBI Laboratory and OTD are working to determine the source of the balloon components. Additionally, the FBI has no information or physical evidence (at this time) that contradicts previous statements made by other government agencies.

The Laboratory Division leads the collection, transportation, and subsequent forensic examinations of evidentiary material. It is staffed with subject matter experts, including highly trained evidence response dive teams and hazardous evidence response teams, which contribute to the mission of collecting, analyzing, and sharing timely scientific and technical information within the FBI and with other government and law enforcement agencies.

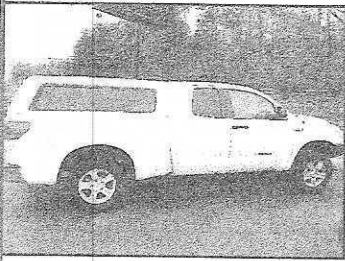

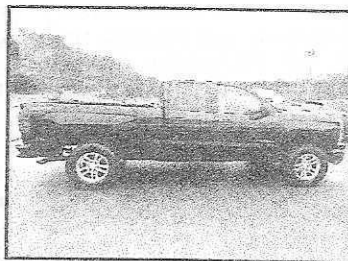
