U.S. Teen Girls Experiencing Increased Sadness and Violence

New CDC report raises urgency to invest in schools as a vital lifeline to help struggling youth

Teen girls are experiencing record high levels of violence, sadness, and suicide risk

LGBTQ+ teens continue to face extremely high levels of violence and mental health challenges

According to new CDC data [9.8 MB, 89 pages] released today, nearly 3 in 5 (57%) U.S. teen girls felt per-

sistently sad or hopeless in 2021—double that of boys, representing a nearly 60% increase and the highest level reported over the past decade.

Teen girls who felt sad or hopeless from 2011 to 2021. Girls: 2011=35%, 2021=57%. Boys: 2011=21%, 2021=29%.

While all teens reported increasing mental health challenges, experiences of violence, and suicidal thoughts and behaviors, girls fared worse than boys across nearly

all measures. The new report also confirms ongoing and extreme distress among teens who identify as lesbian, gay, bisexual, or questioning (LGBTQ+).

“High school should be a time for trailblazing, not trauma. These data show our kids need far more support to cope, hope, and thrive,” Debra Houry, M.D., M.P.H., CDC’s Chief Medical Officer and Deputy Di-

Loudon County Sheriff's Office deputies, with the assistance of the Tennessee Highway Patrol, located 3 missing juveniles out of Indiana. The juveniles were in possession of a stolen vehicle as well.

On February 18th at around 2:45PM, LCSO deputies received information from the Tennessee Highway Patrol that a stolen vehicle and missing juveniles from Indiana were in the area of the 81MM on I-75. Corporal Chance Gray observed a vehicle matching the description heading southbound on I-75. Gray along with other deputies successful got the vehicle stopped and the driver fled on foot. Deputy Justin Parks was able to take the juvenile driver into custody after a short foot pursuit. Two additional missing juveniles were located in the vehicle.

LCSO is working with

the THP to arrange the two juveniles to be transported back to Indiana and the owner of the vehicle to take back possession. The driver is being held at the Loudon County Juvenile Shelter pending charges.

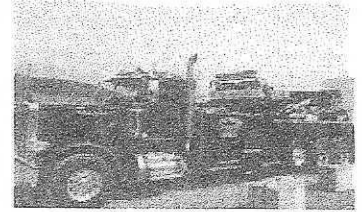

Kayla Forbes, 20, Concord Wood Drive Knoxville, was charged with Simple Possession and Poss. Of Drug Para.

Sgt. Rogers LCSO, observed a vehicle traveling at a high rate of speed with a LED light bar activated. As the vehicle passed by the light bar turned off and the vehicle accelerated at a higher rate of speed. Deputy turned around, initiated his emergency lights, and observed the vehicle turn right on to Old Midway Rd, left on Rawhide Trail, pulled in the first driveway on the left and then the driver turned the vehicle off in an attempt to hide.

Upon contact with the driver, Mr. Julius Sutton, he admitted he ran because he had been assaulted by another law enforcement agency and he was scared that it would happen again. While speaking to Mr. Sutton Deputy observed "rolling-travs" with

marijuana residue laying in the floor board. Mr. Sutton acknowledged the paraphernalia in the floor board and further stated that there were "roaches" in the ash tray. Deputy had the driver and the passenger, Ms. Kayla Forbes, exit the vehicle.

Upon a probable cause search of the vehicle Deputy recovered 2 prepackaged baggies of cannabis(5g, 7g), 1 bag of Delta9 gummies, 1 blunt, a gram of THC wax and multiple marijuana grinders and a scale with residue in the center console and glove compartment.

Deputy also recovered a Sig Saur P365 9mm handgun loaded with 5 bullets that Loudon E911 confirmed was reported stolen by Knoxville PD. Along with the stolen firearm Deputy found a 50 round drum magazine in the rear of the vehicle. Mr. Sutton claimed possession of the stolen firearm, cannabis and

before said paraphernalia.


In Ms. Forbes' purse Deputy recovered a locked container that Ms. Forbes willingly opened which contained multiple marijuana bowls, grinders and 1 prepackaged bag of cannabis (8g). Loudon E911 confirmed Mr. Sutton did not have a valid license and had an active warrant out of Knox County.

Deputy also confirmed Mr. Sutton had previous felony

convictions. The tag on the vehicle TN BKR1899 did not come back to Mr. Sutton and was not registered to the Mitsubishi.

After running the VIN, Loudon E911 advised the vehicle had not been registered in since 2020.

Both subjects were taken into custody and transported to the Loudon County Jail. Said did occur in Loudon County, TN.

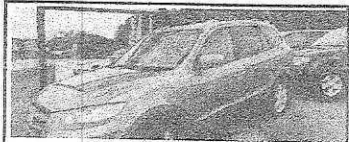

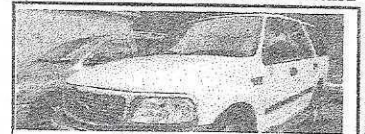

 rector for Program and Science. "Proven school prevention programs can offer teens a vital lifeline in these growing waves of trauma."

The analysis includes 2021 data and trends from the Youth Risk Behavior Survey (YRBS), which examines health behaviors and experiences among U.S. high school students. Youth mental health has continued to worsen—with particularly stark increases in widespread reports of harmful experiences among teen girls:

Nearly 1 in 3 (30%) seriously considered attempting suicide—up nearly 60% from a decade ago.

1 in 5 (18%) experienced sexual violence in the past year—up 20% since 2017, when CDC started monitoring this measure.

More than 1 in 10 (14%) had ever been forced to have sex—up 27% since 2019 and the first increase since CDC began monitoring this measure.

Teen girls who experienced sexual violence increased by 20 percent between 2017-2021

The report also found more than half (52%) of LGBTQ+ students had recently experienced poor mental health and, concerning, that more than 1 in 5 (22%) attempted suicide in the past year. Trend data are not available for students who identify as LGBTQ+ due to changes in survey methods.

Findings by race and ethnicity also show high and worsening levels of persistent sadness or hopelessness across all racial and ethnic groups; and that reported suicide attempts increased among Black youth and White youth.

"Young people are experiencing a level of distress that calls on us to act with urgency and compassion," said CDC Division of Adolescent and School Health Director Kathleen Ethier, Ph.D. "With the right programs and services in place, schools have the unique ability to help our youth flourish."

School-based activities can make a profound difference in the lives of teens with a relatively small infusion of support to schools. More than 95% of U.S. youth spend much of their daily

lives in school. While their primary goal is academic learning, schools can take evidence-based steps to foster the knowledge, skills and support needed to help prevent and reduce the negative impact of violence and other trauma and improve mental health. For example, safe and trusted adults—like mentors, trained teachers, and staff—can help foster school connectedness, so that teens know the people around them care about them, their well-being, and their success. Schools can provide education that equips teens with essential skills, such as understanding and ensuring true sexual consent, managing emotions, and asking for what they need. Schools can also connect teens to their classmates and communities through school-based clubs and community outreach.

CDC has collected and analyzed data on youth health and well-being for more than three decades. These data are a critical first step to revealing, understanding, and addressing emerging threats to the health and well-being of the nation's youth.
