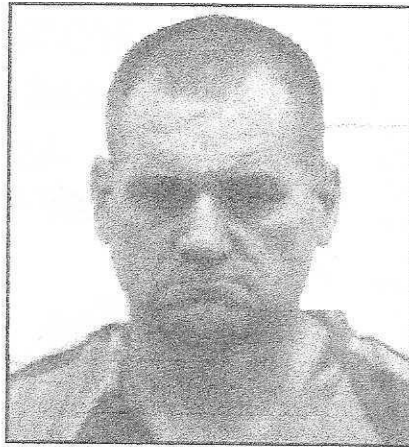

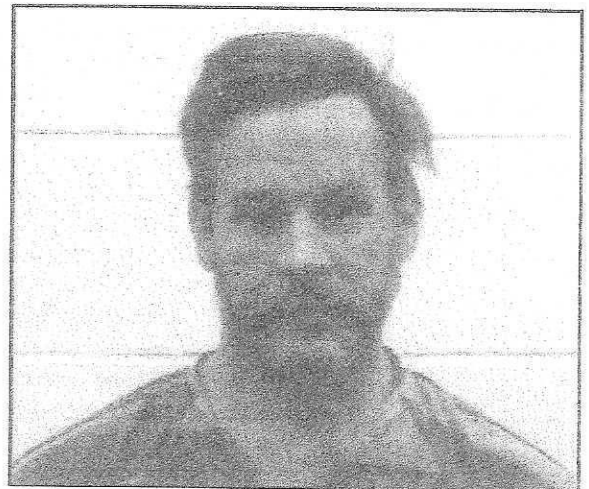

Lake County's History of Poor Audit Results Continues

The Tennessee Comptroller's Office audit of Lake County government for the fiscal year 2022 shows that much work needs to be done to improve the county's financial management.

The audit report contains 12 findings, which is equal to the most findings of any county audit released to date. All seven of the findings present-

ed in the fiscal year 2021 audit were also repeated in the 2022 report. Additionally, since 2018, Lake County has reported from seven to 12 findings in their audit reports. Each of these audits reported material audit adjustments, accounting deficiencies, budget deficiencies, and a lack of segregation of duties. These are serious internal control issues that have not been

addressed. Repeated findings demonstrate county leaders' inability or unwillingness to correct a deficiency, weakness, or area of noncompliance.

Lake County's FY 2022 audit findings additionally include purchasing deficiencies and several violations of state and local policies. A small cash

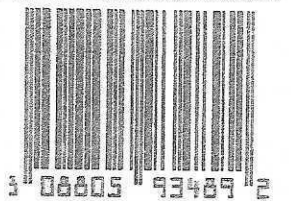
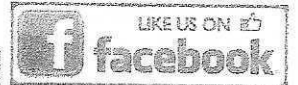

Stephanie Hicks, 41, Hamilton Avenue Lenoir City, was charged with Mfg/Del/Sale or Possession of Meth.

Jon Wright, 50, Bill Smith Road Lenoir City, was charged with Mfg/Del/Sale or Possession of Meth, and Poss. Of Drug Para.

Deputy Davis LCSO, conducted a traffic stop on a gold Toyota Camry bearing a registration of 368BJFR on Highway 11 East and Highland Park Drive. The reason for the stop was because the vehicle's registration did not come back on file. Upon approach, Deputy made contact with the driver Stephanie Hicks and the front passenger Jon Wright. While talking with Stephanie and Jon, Deputy noticed Jon was acting very nervous and suspicious. Jon and Stephanie soon after consented to

letting Deputy search the vehicle. Sergeant Rogers arrived on scene to assist with the traffic stop while Deputy searched the vehicle. Jon consented to letting Sergeant Rogers search him when exiting the vehicle. Sergeant Rogers located a clear pipe in Jon's left front pocket. Jon advised Deputy the pipe had methamphetamine residue in it. During Deputy search of the vehicle, he located a glove inside of the air intake of the vehicle. Inside the glove were three small bags with a white crystalized substance in them. Neither Jon nor Stephanie claimed ownership of the three small bags with the white crystalized substance. Jon and Stephanie were taken into custody and charged with manufacture, delivery, sale or possession of meth-

amphetamine. Jon was also charged with possession of drug paraphernalia for being in possession of the glass pipe with methamphetamine residue. Deputy weighed the white crystalized substance as packaged on an uncertified scale. The weight of the white crystalized substance was 3.51grams, 2.31grams,


and 1.56grams. Deputy Jenkins tested the white crystalized substance with the Trunarc machine. The white crystalized substance tested positive for methamphetamine. Jon and Stephanie were transported to Loudon County Detention Facility. This incident occurred in Loudon County Tennessee.

Justin Midgley- Snow, 42, Denton Court Sevierville, was charged with DUI.

Officer H. Wilkes LCPD, was on routine patrol when he observed a red Mazda bearing Texas registration, HJS-0448, traveling with their passenger brake light out. A traffic stop was conducted at Citizens Bank, where Officer identified the driver as 42 year old, Justin Midgley-Snow. While speaking with the offender, Officer noticed the odor of alcohol coming from the offender. While speaking with the offender, verbal consent to search the vehicle was


granted. While searching the vehicle, Officer did find four 24oz empty cans of Budweiser Chelada's under the driver seat, that were still cold. Officer asked the offender if he had anything to drink today, to which he stated he had one alcoholic beverage at lunch in Maryville. While interviewing the offender, he later stated that he had four or five alcoholic beverages at lunch. The offender was asked to perform SFST's, to which he agreed. During HGN, Officer did observe the offender to have lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and onset of nystagmus prior to 45 de-

grees. During the walk and turn test, Officer did observe the offender to perform an improper turn, and perform the incorrect number of steps multiple times. During the one leg stand, Officer observed the offender to use his arms for balance, and put his foot down several different times. Due to the totality of the circumstances, Justin Midgley-Snow was placed into my custody for Driving Under the Influence, and

placed into the back of Officer patrol vehicle. Money-Makers was called for the vehicle. The offender was read the TN Implied Consent Form, to which he consented to provide a blood sample. From there, the offender was transported to the Fort Loudon Medical Center, and then to the Loudon County Jail without further incident. All of the above did occur in Lenoir City, Loudon County, Tennessee.

Ashley Yarber, 40, Kirk Avenue Lenoir City, was charged with Mfg/Del/Sale or Poss. Of Meth, Simple Possession, and Poss. Of Drug Para.

Stevie Colon Thomas, 36, Kagley Drive Lenoir City, was charged with Mfg/Del/Sale or Poss. Of Meth, Simple Possession, and Poss. Of Drug Para.

Inv. Clay Jenkins LCSO, assisted Cpl. Chance Gray 946 on a traffic stop on a white Chrysler Sebring TN registration 363BGFW on the I-75 NB get on ramp at MM 68 due to driver not wearing her seatbelt. Deputy then spoke to driver Ashley Yarber and asked if there was anything illegal inside of the vehicle and she stated, "no there shouldn't be." Cpl. Gray then deployed his K9 partner Kora who did alert to the odor of narcotics.

After a probable cause search of the vehicle, inside

of Yarber's purse on the drivers seat was a meth pipe with residue and half of a wafer of Methadone. Inside of a cigarette pack was 2 baggies with a crystal like substance (Meth) weighing approx. 0.9 gram and the other 1.2 gram. Deputy spoke to both Ashley Yarber and passenger Stevie Colon about the meth and both denied ownership. Both were taken into custody and transported to the Loudon County Jail.

Before entering the jail, Ashley Yarber told Cpl. Wallen that she had meth in her bra. Cpl. Wallen then retrieved 2 baggies out of her bra weighing 0.9 gram and 1.2 gram. After entering the jail, Deputy Brooke Slattery then found a meth pipe inside of Stevie Colon's private area.

All narcotics were tested and tested positive for Methamphetamine.

All of this did occur in Loudon County, TN.

shortage was also noted in the Sheriff's Office resulting from poor receipting, depositing, and reporting practices.

"One of our audit findings notes the county's audit committee has not met since October 2020," said Comptroller Mumpower. "The audit committee, along with the county's new administration, must take action. Our auditors are writing the same findings year after year. We want Lake County government to improve, and we hope that county leaders are ready to make corrections."

It should be noted that some offices within Lake County government did not have any findings in this year's audit report. These offices include the County Clerk, Trustee, Clerk and Master, Register of Deeds, Assessor of Property, and the Circuit, General Sessions, and Juvenile Courts Clerk.
