Black and Hispanic Patients on Dialysis Have Higher Rates of Staph Bloodstream Infections

Actions to Reduce Inequities Can Save Lives

Adults on dialysis treatment for end-stage kidney disease were 100 times more likely to have a Staphylococcus aureus (staph) bloodstream infection than adults not on dialysis during 2017-2020, according to a new Vital Signs report released today by the Centers for Disease

Control and Prevention (CDC).

More than half of people in the U.S. receiving dialysis belong to a racial or ethnic minority group—about 1 in every 3 people receiving dialysis is Black and 1 in every 5 is Hispanic. CDC data found patients on dialysis in these groups have higher rates of staph bloodstream infections than White patients on dialysis.

Dialysis treatment, although necessary and lifesaving, comes with risks. Healthcare providers use needles or catheters to connect a patient to a dialysis machine, and germs, like staph, can get into a patient's bloodstream. Staph

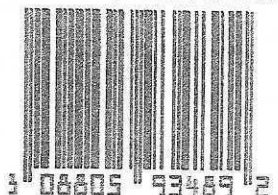

Juan Dortantes, 29, Huffs Ferry Road Loudon, was charged with DUI, Driving on Roadways Laned for Traffic, and Evading Arrest.

Sgt. Rogers LCSO, observed a black sedan moving at a high rate of speed on Highway 11 near Huntsville Hollow Rd. RADAR unit confirmed the vehicle was traveling 64mph in a 40mph zone. As the vehicle passed Deputy noted it did not slow down and Deputy then began to follow it. While behind the vehicle he observed it nearly side-swipe another vehicle while still traveling at a high rate of speed. Deputy initiated a traffic stop near Sugarlimb Rd. At which time the vehicle showed no signs of stopping as it turned towards the interstate. With his emergency lights and siren on Deputy pursued the vehicle to Hotchkiss Valley Rd E where the driver then made a U-turn. As the vehicle was turning around Deputy observed the driver holding a beer bottle in his hand. The vehicle continued on Sugarlimb Rd. to

Hotchkiss Valley Rd. W, then to Huffs Ferry Rd. where it pulled in a driveway marked. The driver, identified as Juan Manuel Juarez Dorantes was taken into custody. Mr. Juan smelled strongly of an alcoholic beverage. Deputy did locate six Modelo beer cans in the vehicle. Mr. Juan stated he had consumed six beers and was on his way home from a friend's house in Maryville. Mr. Juan was transported to the Loudon County Jail, at which time he was advised of his Miranda rights and then did consent to SFST testing. Mr. Juan displayed all six clues during HGN. During the Walk and Turn, Mr. Juan could not keep balance during instructional phase, stepped off line, used his arms for balance, incorrect number of steps and stops while walking. During the one leg stand, Mr. Juan put his foot down twice and used his arms for balance. Mr. Juan was read Tennessee Implied Consent to which he refused to give a blood draw. Said did occur in Loudon County, TN.

Juan Alberto Gomez, 18, Vale Street Loudon, was charged with No Driver License, and Man/Sell/Del/Resale Sch. VI.

Officer B. Nix LPD, witnessed a Mazda sedan traveling at a high rate of speed on Mulberry Street. Using his radar, Officer clocked the vehicle at 56MPH in a 30MPH zone. Officer was able to stop the vehicle on Mulberry Street in front of Foothills Credit Union.

Officer approached the vehicle and was able to see that the driver was a Hispan-

ic male. Using a translator Officer was able to ask the male if he had a license of identification card to which the translator stated he did not. Felipe Estrada-Martinez, 37, Larkspur Lane Powell, was charged with DUI, Violation of Implied Consent, and Driving on Roadway laned for Traffic.

Sgt. Bialek LCPD, was dispatched to the area of Highway 321 North and CVS in regards to a possible drunk driver on a tan Chevy pickup truck. Upon officer's arrival, Officer Eldridge observed a tan Chevy pickup truck bearing TN tag BKX6194 drive over the median on Highway 321 North into the northbound lane from the southbound lane.

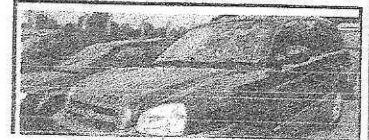

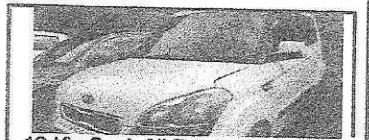

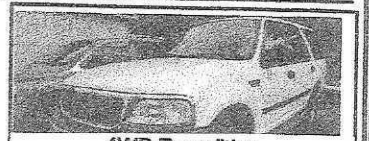

bloodstream infections can be serious and even deadly. Some infections are resistant to some of the most common antibiotics used to treat them, making the drugs ineffective.

CDC data confirmed one of the key ways healthcare providers can reduce the risk of infection is by using lower-risk alternatives, such as fistulas and grafts, to replace central venous catheters to connect patients' blood circulation to dialysis machines for treatment.

Hispanic patients on dialysis had a 40% higher risk of staph bloodstream infections than White patients on dialysis between 2017 and 2020. Other challenges for many patients on dialysis include:

Lack of access to preventive care for conditions like diabetes and high blood pressure, which increase the risk of developing end-stage kidney disease.

Lack of patient education about treatment options for end-stage kidney disease.

Extended use of a central venous catheter to connect a patient's blood circulation to a dialysis machine for treatment (also known as a vascular access type). Catheters have the highest risk of infection among all vascular access types.

Socioeconomic factors, including poverty, household crowding, and lower education levels.

"Preventing staph bloodstream infections begins by detecting chronic kidney disease in its early stages to prevent or delay the need for dialysis," said CDC Chief Medical Offi-

cer Debra Houry, M.D., M.P.H. "Healthcare providers can promote preventative practices, including methods to manage diabetes and high blood pressure, as well as providing education on treatment options among all patients and particularly those at greatest risk, to slow the progression of chronic kidney disease."

CDC researchers used data from the 2020 National Healthcare Safety Network (NHSN) and the 2017-2020 Emerging Infections Program (EIP) to describe bloodstream infections among dialysis patients. To examine associations with race, ethnicity, and social determinants of health, these data were linked to population-based data sources (CDC/ATSDR's Social Vulnerability Index, United States Renal Data System, U.S. Census).

Key findings:

In 2020, 4,840 dialysis facilities reported 14,822 bloodstream infections to NHSN; 34% were due to staph.

In both NHSN and EIP systems, vascular access via central venous catheter was strongly associated with staph bloodstream infection.

Among seven EIP sites in 2017-2020:

The staph bloodstream infection rate was 100 times higher in dialysis patients than adults not on dialysis.

Among patients on dialysis, staph bloodstream infection rates were highest in Black and Hispanic patients.

Adjusting for state of residence, age, sex, and vascular access type, the staph bloodstream infection risk was highest in Hispanic patients and patients 18-49 years old.
