LCSO WARNS CITIZENS OF A NEW SCAM

There is a new wave of scam attempts aimed at defrauding citizens using the name of fallen deputy Sergeant Chris Jenkins.

LCSO Deputies have received multiple reports of potential scam cases involving a criminal posing as Sergeant Chris Jenkins. These scams are targeting people on dating apps from other states that have engaged in private conversations with the scammer, posing as an interested, potential match on the app. The scammer then identifies themselves as Sergeant Chris Jenkins,

working under cover with the Loudon County Sheriff's Office, and threatens prosecution for various "crimes" if the individual doesn't pay them money.

We at LCSO are disgusted that this scammer is using the name of Sergeant Jenkins in an attempt to defraud citizens. If you feel you have been targeted by this, or any other scam, please contact the Loudon County Sheriff's Office or Loudon County E-911 at 865-458-9081 to make a report.

FBI vs. USSS 2023 Hockey Game

FBI Edges Secret Service in Charity Hockey Game

2023 Matchup Honors Fallen Agent

The FBI narrowly defeated its hockey rivals, the U.S. Secret Service, in a 2-1 win on March 4.

The sold-out charity game was expected to raise at least \$20,000 to benefit the families of fallen law enforcement officers. It also paid special tribute to fallen FBI Miami Special Agent Daniel Alfin.

Following a fierce effort by both teams that saw them neck-and-neck at the start of the third period, the FBI clinched the game-winning goal in the matchup's final minutes.

"Typically, these games are always close," said Kyle Miller, an FBI auditor and analyst who plays defense for the Bureau's hockey team. "It always comes down to

who can make the plays in the end, and, fortunately, we were able to do that again this year."

Before the game kicked off, Elliot Segal—event host, Secret Service team coach, and radio personality—paid homage to the life and legacy of Alfin. Alfin and his colleague Special

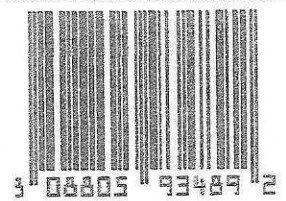

GERARDO-ASAU, CARDENAS, 24, Hwy 295 Texas, was charged with DUI, and Driving on Roadways laned for Traffic.

Deputy Jackson LCSO, responded to I-75NB on report of a reckless driver with a description of a black SUV with Texas registration. The vehicle, a black Dodge Durango, bearing Texas tag # RYT8049, passed him at the 79mm. Deputy was able to get behind the vehicle, and observed it swerving several times in the right lane

with its blinker on. Deputy initiated a traffic stop just before the NB off ramp at the 81mm, and the vehicle continued swerving and slowed to 45MPH, and finally came to a stop at the 82.4mm. Once Deputy approached the vehicle, Deputy smelled a strong odor of an alcoholic beverage emitting from the driver's side window, and Deputy could see empty bottles of beer in the vehicle. The driver, Gerardo Cardenas, displayed red watery eyes, and when asked to step out of the vehicle, he nearly fell into the roadway. While speaking with Mr. Cardenas outside his vehicle, Deputy could smell a strong odor of alcoholic beverage emitting from his person. Mr. Cardenas told him that he was travelling to Kentucky from Atlanta. Deputy

asked him how many beers he had, and he stated one or two about 30 minutes prior to our contact, but denied drinking while driving. Deputy then spoke to the passengers of the vehicle, Fernando Cruz, David Hugo, and Juan Martinez, who all appeared intoxicated. On Officer second approach to the vehicle, he saw there was an empty case of Modelo behind the driver's seat, along with sev-

eral empty beer cans. They all stated that they had been drinking, the front seat passenger stated approximately 40 minutes ago. Officer asked if they were drinking with the driver, and they all stated yes. Mr. Cardenas was taken into custody for DUI and failure to maintain lane, and the passengers were taken into custody for DUI by consent. They were all transported to the Loudon County Detention Center. Once at the jail, LPD Officer Luna met Officer to help translate, and Mr. Cardenas consented to SFST and a breath test. He performed poorly on SFSTs, and could not provide a sufficient breath sample 3 times, even after Officer Luna thoroughly explained it. All of the above occurred in Loudon County, TN.

Crystal Pidilla-Disho, 40, Third Ave Lenoir City, was charged with Domestic Assault.

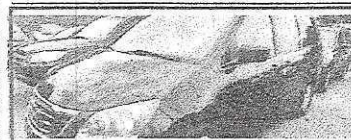

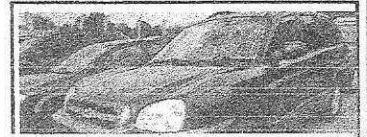

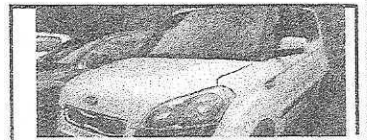

 Agent Laura Schwartzenberger were killed in February 2021 while executing a search warrant as part of a crimes against children investigation.

FBI Director Christopher Wray, Secret Service Director Kimberly A. Cheatle, and Segal then escorted Alfin's son Eli to the end of a red carpet on the ice so that Eli could perform the ceremonial puck drop. Alfin's wife Jessie also attended the game.

"It's great that we were able to take a minute and certainly pay respects to a fallen agent and have his son here and be able to experience this in the remembrance of his father," Miller said.

This year's event was held on the Capitals Rink at the MedStar Capitals Iceplex in Arlington, Virginia.

The annual game, which took a break in 2021 due to the COVID-19 pandemic, is a tradition that began in the early 2000s. This year's win was the Bureau's fifth-consecutive victory against the Secret Service. And while the team doesn't maintain an official schedule, it has historically faced off against crews from the U.S. Secret Service, the U.S. military, and the Canadian embassy.

No License and More

A records check through Central Dispatch revealed insurance was unconfirmed. Joshua provided copies of two separate citations that had been issued to him within the last month for expired registration, no drivers license (expired), financial responsibility, along with other violations. In accordance with department policy, a vehicle inventory search was completed prior to tow. During the search officers located one glass pipe with burnt marijuana residue. Joshua was taken into custody and transported to the Loudon County Jail without further incident. All the above did occur in Lenoir City, Loudon County, TN.
