## METH TRAFFICKER SENTENCED TO 292 MONTHS' IMPRISONMENT

Armando Mejia-Almazan, 44, a Mexican National, was sentenced to 292 months in prison by the Honorable Travis R. McDonough, Chief United States District Judge, in the United States District Court at Chattanooga.

As part of the plea agreement filed with the court, Mejia-Almazan agreed to plead guilty to an indictment charging him with one count of conspiracy to distribute 50 grams or more of

methamphetamine (actual) and 500 grams or more of a mixture and substance containing a detectable amount of methamphetamine, in violation of Title 21, United States Code, Sections 841(a)(1), 841(b)(1)(A), and 846. After his release from imprisonment, Mejia-Almazan will be on supervised release for five years and may be subject to deportation.

According to court documents and evidence

presented at sentencing, Mejia-Almazan, who had previously been removed from the United States and unlawfully returned, distributed more than 50 kilograms of ice methamphetamine to a Chattanooga-based drug trafficking organization. Mejia-Almazan utilized multiple apartments in the Atlanta metro area to facilitate his drug traf-

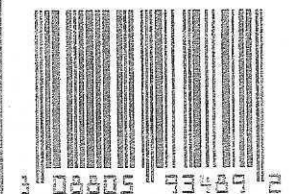

### Reckless

Joseph Young, 46, Homeless Knoxville, was charged with DUI, and Violation of Implied Consent.

Officer Carroll LCPD, was advised by dispatch of a Reckless Driver in the area of Hwy 321 N/Interstate Battery. Dispatch advised that 959 from Loudon County was off duty, and was behind a maroon Kia Sedona van that was failing to maintain its lane of travel bearing the tag#BNK2821. Officer, did observe the vehicle in the area of Hwy 321 N/I75 overpass. While behind the vehicle, the Officer observed the vehicle change multiple lanes in an intersection, and the Officer conducted a traffic stop at Waffle House on Hwy 321 N. Upon speaking with the driver, the Officer observed 2 open alcohol containers still half full in the center console, and a strong odor of marijuana omitting from the vehicle. The driver was identified as Joseph James Young. Mr. Young did advise he had smoked some marijuana earlier in the day, but it was awhile ago. While speaking with Mr. Young, the Officer also observed a female passenger laying down in the back of the van asleep. Officer spoke with the female, who was identified as Ashley Michelle Cannon, who had a local Violation of Probation warrant out of Loudon County General Sessions, and was placed into custody. Mr. Young did consent to performing Standardized

Field Sobriety Testing. During the Horizontal Gaze Nystagmus test, Mr. Young had lack of smooth pursuit, Nystagmus at Maximum Deviation, Onset Nystagmus prior to 45 degrees, and Vertical Nystagmus. During the Walk and Turn test, Mr. Young did miss heel to toe, stepped off line, and used his arms to help keep balance. During the One-leg stand test, Mr. Young did use his arms for balance, put his foot down during the test, and had a hard time keeping balance. Mr. Young was placed into custody, and read Implied Consent to which he refused. Both subjects were transported to the Loudon County Jail without any further incident.

Ashley Cannon, 36 Dogwood Lane Lenoir City, as charged with Violation of Probation, and Contraband in Penal Institution.

Deputy Walker LCSO, was notified of a Female arrestee brought in by Lenoir City Patrolman Carroll for an active warrant. Deputy then asked, now known as, Ashley Cannon if she had anything illegal on or in her person to which she stated "no". Deputy then escorted Inmate Cannon into the facility and began the booking process. Inmate Cannon was then taken to the female bathroom and searched to be changed into a Jail issue uniform. While searching Inmate Cannon she removed her clothing and bent

at the waist and a small baggie containing a grayish powder fell into the floor. Deputy then secured the baggie and spoke with Cpl. Brannon to which Deputy turned the suspect narcotics over to him and he called Narcotics Lt. Ezell. Narcotics Lt. Ezell then

weighed and tested the suspect powder with TruNarc #2049 to which it tested positive for 0.6 grams of Fentanyl. Deputy is charging Ashley Cannon with Introduction into a penal facility. This did occur in the Loudon County Detention Facility, TN.

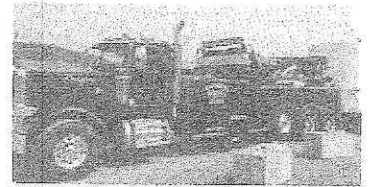

Maynor Mendez, 22, Loudon, was charged with DUI, Violation of Implied Consent, No License, and Evading Arrest.

Deputy L. Hawkins LCSO, was traveling East on Highway 72 in the area of Queener Road. Two cars ahead of him, Deputy observed a white Chevrolet Cobalt driving across the center yellow dividing line. It aggressively corrected back into its lane of travel to avoid striking a car traveling the opposite direction. The vehicle then crossed the center line once more. Deputy activated his emergency


equipment and attempted a traffic stop on Highway 72 at The New Life Family Worship Center. The vehicle continued to travel at 45-50 mph on Highway 72. The vehicle failed to stop for approximately one quarter mile. It then stopped partially in the roadway on Highway 72 at The Food City. Deputy made contact with the driver, Maynor Perez Mendez. He advised he could not speak English. Deputy contacted Officer Marco Luna LPD, to translate. While speaking with Mr. Mendez he had glossy/bloodshot eyes and an odor of an alcoholic beverage was coming from his person. When he exited the vehi-

cle he had trouble keeping his balance. Officer Luna asked if Mr. Mendez saw the flashing blue lights on my vehicle, he replied "Yes." He then advised he did not stop because, "I don't know, I just bought this car." At that time Mr. Mendez refused to answer any further questions. He was placed into custody and was asked to provide a blood or breath sample, he refused. While conducting a vehicle inventory an empty bottle of "Co-

rona" was found in the passengers floor board. Mr. Mendez could not provide an address for himself and advised he was previously staying at a hotel. Dispatch was given Mr. Mendez's information but could not locate any identification or valid drivers license. Mr. Mendez was transported to The Loudon County Jail. All the above did occur in Loudon County, Tennessee.



### Vote

On Thursday, April 6, 2023, the Tennessee House of Representatives debated whether to expel three members. Members Justin Jones, Gloria Johnson and Justin Pearson disrupted the House chamber on Thursday, March 3A, 2023. After careful consideration of all three resolutions, I voted to expel Justin Jones and Justin Pearson.

All three violated House rules and each of their individual conduct was unacceptable. It was obvious in the video recording and during discussion that Gloria Johnson did not participate to the extent that Jones and Pearson did. Either Jones or Pearson smuggled a bullhorn into the Chamber. The two used that bullhorn to shout and scream and incite the crowd to chant "flo action, no peace". The video showed Johnson did not appear to do anything other than stand near the Well and move her lips.

While Johnson needs to be censured for her unacceptable conduct that day, the evidence presented did not warrant her expulsion.

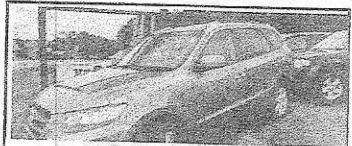
Had all three participated the same, I would have voted to expel all three.

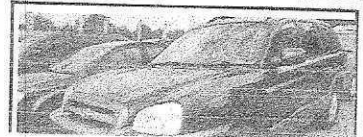

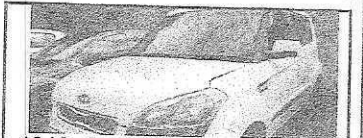

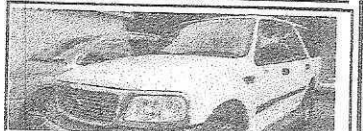

ficking and acted under the direction of a Veracruz, Mexico-based methamphetamine broker affiliated with the Cartel de Jalisco Nuevo Generacion ("CJNG").

"The United States Attorney's Office is committed to targeting the ongoing threat to our communities from cartel-based drug traffickers," said United States Attorney Francis M. Hamilton III. "We will continue to work with our law enforcement partners to ensure that those who seek to profit from flooding our communities with dangerous drugs will face justice."

"I'm very proud of the work done by the dedicated men and women of DEA in this case," said Special Agent in Charge J. Todd Scott, head of Drug Enforcement Administration's ("DEA") Louisville Field Division. "Mr. Mejia-Almazan had tentacles reaching down into Mexico, straight to the Sinaloa and Jalisco New Gen-

eration Cartels, the two ruthless, violent, criminal organizations that are intentionally poisoning Americans to drive addiction."

This sentencing was the culmination of an Organized Crime Drug Enforcement Task Forces (OCDETF) investigation. OCDETF identifies, disrupts, and dismantles the highest-level drug traffickers, money launderers, gangs, and transnational criminal organizations that threaten the United States by using a prosecutor-led, intelligence-driven, multi-agency approach that leverages the strengths of federal, state, and local law enforcement agencies against criminal networks.

The Appalachia HIDTA mission is to use a multi-disciplinary approach to deal with the ongoing threats to public health and safety, particularly as it regards prescription drug diversion, the emerging threat of heroin, as well as the continued threats of marijuana, cocaine, methamphetamine, and synthetic drugs. The Appalachia region

is arguably the epicenter of this crisis and requires unprecedented multi-disciplined cooperation to effectively address the many faceted health and public safety problems that result from this daunting threat. The Appalachia HIDTA will serve as the conduit for this cooperation.

Law enforcement agencies participating in the joint investigation which led to the indictment and subsequent conviction of Mejia-Almazan, included DEA Chattanooga

Resident Office, DEA Atlanta Field Division, Federal Bureau of Investigation Chattanooga Resident Agency, Chattanooga Police Department, and Hamilton County Sheriff's Office. Numerous agencies from the Appalachia High Intensity Drug Trafficking Area (HIDTA) Task Force assisted in the investigation.

Assistant U.S. Attorney Kevin T. Brown represented the United States.
