

### 'Sergeant Chris Jenkins Law' signed by Gov. Bill Lee

Governor Bill Lee and carry an item in signed the "Sergeant Chris Jenkins Law." named in honor of the Loudon County Sheriff's Office Deputy who was hit and killed in February 2022 when he was responding to a report of a ladder in the roadway.

The law makes it an offense for someone to operate a vehicle on a public roadway

### Increased Use of Telehealth Services and Medications for Opioid Use Disorder During the COVID-19 Pandemic Associated with Reduced Risk for Fatal Overdose

Study findings sup-port the continuation of providing telehealth services for opioid use disorder and its related care

The expanded availability of opioid disorder-related telehealth services medications during the COVID-19 pandemic was associated with a lowered likelihood of fatal drug overdose among Medicare beneficiaries, according to a new study.

"The results of this study add to the growing research documenting the benefits of expanding the use of telehealth services for people with opioid use disorder, as well as the need to improve retention and access to medication treatment for opioid use disor-der," said lead author Christopher M. Jones.

PharmD, DrPH, Director of the National Center for Injury Prevention and Control, CDC. "The findings from this collaborative study also highlight the importance of working across agencies to identify successful strategies to address and get ahead of the constantly evolving

### Shooting

At the request of 9th Judicial District Attorney General Russell Johnson, TBI special agents continue to investigate the shooting of a man during an encounter with a trooper from the Tennessee Highway Patrol.

Preliminary information indicates the shooting occurred at approximately 4:30 Thursday afternoon, as law enforcement officers were arriving to the scene of a shooting at a body shop in the Midtown community. The trooper encountered the suspect, who was armed with a handgun, in the nearby front yard of an abandoned house, in the 100 block of Dogwood Lane. There, the suspect turned toward the trooper in an aggressive fashion as he raised his gun, after which the trooper fired his service weapon, striking and injuring the suspect, who was subsequently hospitalized. No law enforcement officers were hurt in the incident '

At this time, this investigation remains active and ongoing. TBI agents are working to independently determine the series of

events leading to the shooting, including collecting evidence and conducting interviews. Throughout the process, investigative findings will be shared with the District Attorney General for his further review and consideration. The TBI acts solely as fact-finders in its cases and does not determine whether the actions of an officer were justified in these types of matters. That decision rests with the District Attorney General requesting TBI's involvement.

The TBI does not identify the officers involved in these types of incidents and instead refers questions of that nature to their respective department to answer as it sees fit.



secured by a web-derived strap or a ladder without two lateral straps at both ends of the ladder. The law also states that items weighing less than 2.2 pounds being transported must be contained with a fiber netting or web-derived strap to keep it in the open bed or trailer.

In February 2022, Jenkins was hit by a tractor-trailer on I-75 north as he exited his patrol vehicle while answering a call for a ladder in the roadway according to an arrest report. According to the report,

the driver of the tractor-trailer was "clinically under the influence of marijuana" when the crash happened.

According to a previous report, Jenkins used his cruiser as a rolling roadblock while clearing the roadway, but the truck driver failed to slow down and struck two vehicles, Jenkins' patrol cruiser and Jenkins


While the tractor-trailer driver faced charges including vehicular homicide by intoxication, the truck driver who failed to secure the

that Jenkins was attempting to remove was also charged. The man plead guilty to three counts of reckless endangerment and a one count of driving on a suspended license in September 2022.

The bill was introduced in the State Senate on January 25, 2023, and it passed unanimously five days later. The bill also passed the House unanimously on March 13.

Lee signed the bill into law on March 23. The bill was sponsored by Rep. Lowell Russell in the house and Senators Adam Lowe, Becky Duncan Massey and Randy McNally in the senate.


Ronnie Green, 39, Douglas Drive Athens, was charged with Simple Possession.

Published today in JAMA Psychiatry, this study is a collaborative research effort led by researchers at the National Center for Injury Prevention and Control, a part of the Centers for Disease Control and Prevention (CDC); the Office of the Administrator and the Center for Clinical Standards and Quality, both part of the Centers for Medicare & Medicaid Services (CMS); and the National Institute on Drug Abuse, a part of the National Institutes of Health (NIH).

"CMS is committed to ensuring that the beneficiaries we serve can access the high-quality behavioral health services they need," said senior author Dr. Shari Ling, M.D., Deputy Chief Medical Officer at CMS. "This study shows that many beneficiaries were able to utilize opioid use disorder-related telehealth services during the pandemic, but we need to continue our efforts to broaden the use of telehealth, particularly in underserved communities."

In this national study, researchers analyzed among two cohorts of Medicare beneficiaries to explore receipt of opioid use disorder-related telehealth services, receipt of medications for opioid use disorder, and fatal overdoses before and during the COVID-19 pandemic. To do this, they compared data from two cohorts of Medicare beneficiaries across two time periods. The first cohort was constructed with data from September 2018-February 2020 and included 105,162 Medicare beneficiaries with opioid use

disorder (the "pre-pandemic cohort"). The second cohort was constructed with data from September 2019-February 2021 and included 70,479 Medicare beneficiaries with opioid use disorder, (the "pandemic" cohort). In addition, the researchers conducted an analysis to examine the demographic and clinical characteristics associated with fatal overdose in the pandemic cohort.

Key findings of this study include:

Medicare beneficiaries that began a new episode of opioid use disorder-related care during the pandemic and received opioid use disorder-related telehealth services were found to have a 33% lower risk of a fatal drug overdose.

Medicare beneficiaries who received medications for opioid use disorder from opioid treatment programs (OTP) and those who received buprenorphine, one of the medications for opioid use disorder, in office-based settings also had reduced odds of a fatal drug overdose of 59% and 38%, respectively

Mortality rates (classified as all-cause mortality and drug overdose mortality specifically) were higher in the pandemic cohort compared to the pre-pandemic cohort; however, the percentage of deaths due to drug overdose were similar between the two cohorts.

"At a time when more than 100,000 Americans are now dying annually from a drug overdose, the need to expand equitable access to lifesaving treatment, including medications for opioid use disorder, has never been greater," said Wilson Compton, M.D., M.P.E., deputy director of the National Institute on Drug Abuse and senior author of the study. "Research continues to indicate that expanded access to telehealth is a safe,

effective, and possibly even lifesaving tool for caring for people with opioid use disorder, which may have a longer-term positive impact if continued."

Although the results of this study were able to identify the positive impact opioid use disorder-related telehealth services had on lowering the risk for fatal drug overdose in the pandemic cohort, the authors note that only 1 in 5 Medicare beneficiaries in the pandemic cohort received OUD-related telehealth services. Similarly, only 1 in 8 beneficiaries in the pandemic cohort received medications for opioid use disorder. These findings underscore the need for continued expansion of these potentially life-saving interventions across clinical settings.




