Cameron Ty Bolyard, 35, of Greenville, Tennessee, was sentenced to 600 months in federal prison, by the Honorable Clifton L. Corker, in the United States District Court for the Eastern District of Tennessee at Greeneville.

As part of the plea agreement filed with the court, Bolyard pleaded guilty pursuant to a Federal Rule 11(c)(1)(C) plea

agreement to counts one and two of an indictment charging him with use of a minor to engage in sexually explicit conduct for the purpose of producing a visual depiction of such conduct in violation of 18 U.S.C. § 2251 (a) and (e) and being a parent of a minor, knowingly permitted such minor to engage in sexually explicit conduct for the purpose of producing a visual depiction of

such conduct in violation of 18 U.S.C. § 2251 (b) and (e). Upon his release from prison, Bolyard will be on supervised release for 10 years. Bolyard will be required to register with state sex offender registries and comply with special sex offender conditions during his supervised release.

According to the written plea agreement

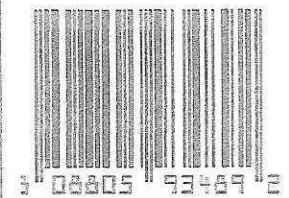

Freddie Mejia, 23, Highland Ave Loudon, was charged with Mfg/Del/Sale or Poss. of Meth, Simple Possession, Poss. of Drug Para., Driving on Revoked/Suspended License, and Possession of a Firearm.

Agent Fritts DTF, observed Freddie Mejia traveling on Highway 72 in a Blue Nissan Altima. Agent had prior knowledge that Mejia's driver's license was revoked and confirmed his license to be revoked.

The vehicle turned onto Carding Machine Road and pulled into the Big Red Carwash. Law enforcement made contact with Mejia and Agent asked him if he had anything illegal on him. Me-

jia stated that he had a gun in his waistband.

Mejia is a convicted felon and is currently on state probation for felony charges. Agent read Mejia his Miranda Rights and he agreed to speak. Agent asked Mejia if he had anything illegal in his vehicle and he stated that he had approximately 2 ounces of methamphetamine and another pistol.

Agent asked Mejia for consent to search his vehicle and he agreed. In the driver's seat was a black backpack that contained two pistols, multiple magazines, ammunition, 10 grams of Marijuana, and approximately two ounces of methamphetamine.

Found on the inside of a hollowed-out dash stereo CD

receiver was approximately six ounces of methamphetamine. In the center cup holder was a glass pipe used for smoking methamphetamine. Mejia was taken into custody and transported to the Loudon County Jail.

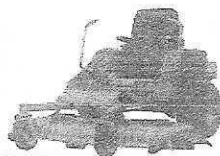
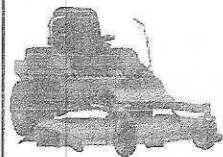

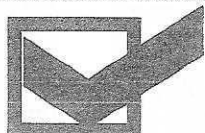

Heather Baryo, 38, McJung Ave, Knoxville, was charged with DUI, and Falsification of Drug Test Results.

Officer Wilkes LCPD, was on patrol when he observed a black Nissan Altima bearing TN tag BHX6981, accelerate to a high rate of speed while Officer was behind the vehicle doing 40 miles per hour, the designated speed limit on Hwy 321. While approaching the intersection of Hwy 321 and McGhee Blvd, Officer observed the vehicle to narrowly miss a vehicle stopped

at the red light while attempting to switch into another lane. While observing the vehicle, Officer observed the Altima to run the red light at the intersection of U.S. Highway 321 and Highway 11. At that time, Officer conducted a traffic stop on the vehicle at Hwy 321 at the St. Thomas Church. Officer made contact with the driver, who he identified to be Heather Baryo. Ms. Baryo stated that she was unsure of the speed limit in the area, and that she was messing around with her cellular device and wasn't completely paying attention to the road.

While speaking with Ms. Baryo, the Officer asked her if she would perform SFST's, to which she agreed. During HGN, O observed lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and onset of nystagmus prior to 45 degrees. During walk and turn, I observed her to use her arms for balance and perform the incorrect number of steps. During the one leg stand, Officer observed her to sway, use arms for balance, and put her foot down. During a consensual search of the vehicle. Of-


ficer located two bottles of fake urine used to pass a drug test. Officer additionally located a bottle of Crown Royal and a bottle of prescription medication labeled Subutex. Due to the totality of the circumstances, Ms. Baryo was placed into his custody for DUI. Ms. Baryo was read the TN Implied Consent form, to which she consented to a blood draw. Ms. Baryo was transported to the ER for a blood draw, and then to the Loudon Co Jail. Ms. Baryo's vehicle was retrieved by a friend.



filed with the court, investigators received multiple Cyber-Tips from the National Center for Missing and Exploited Children where Bolyard uploaded multiple images and videos to his Google Account of child pornography. Multiple images and videos were created by Bolyard where he recorded a minor victim engaged in sexually explicit conduct with Bolyard. Additionally, Bolyard uploaded over a hundred videos and images of child sexual abuse material, unrelated to the minor victim, to his account.

“This 50-year prison sentence sends a clear message that preying upon and sexually victimizing the most innocent and vulnerable victims, our children, will not be tolerated,” said U.S. Attorney Francis M. Hamilton III for the Eastern District of Tennessee. “We are grateful for the work of the Homeland Security Investigations- Johnson City Office and the Knoxville Police Department’s Internet Crimes against Children

Group.”

“This significant sentence is a testament to the outstanding collaboration among HSI and our law enforcement partners, including the Knoxville Police Department, the Internet Crimes Against Children, and the U.S. Attorney’s Office. This investigation into Mr. Bolyard’s criminally abhorrent conduct is a prime example of our commitment to protect the most innocent and vulnerable population from exploitation by predators. No child should ever fall prey to victimization or endure its trauma,” stated HSI Nashville Special Agent in Charge Rana Saoud.

The criminal indictment was the result of an investigation by Homeland Security Investigations- Johnson City Office and Knoxville Police Department’s Internet Crimes against Children Group. This investigation was led by TFO HSI John Williams.

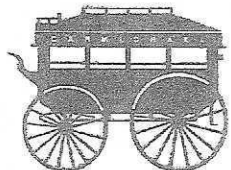



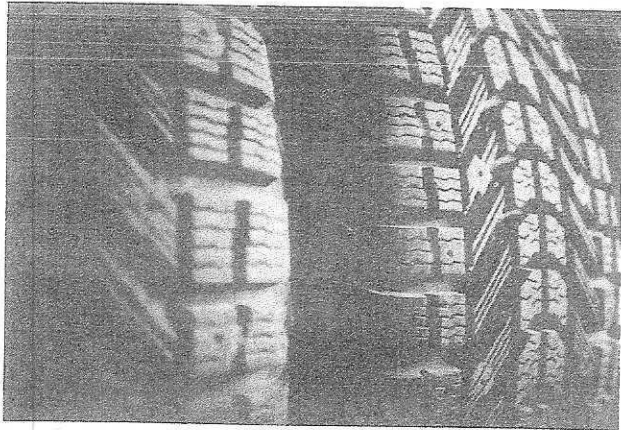
