

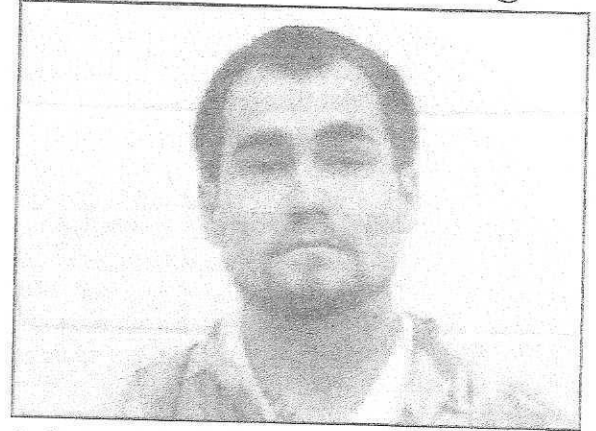

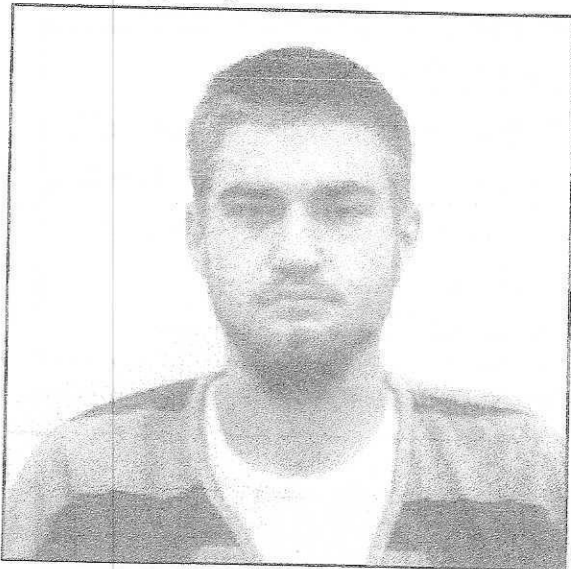

FBI Increases Ten Most Wanted Fugitives Reward

The FBI is now offering up to \$250,000 for information that leads to the arrest of a Ten Most Wanted Fugitive

Throughout its more than 100-year history, the FBI has solicited help from the public to locate wanted criminals—especially those on the Ten Most Wanted Fugitives list.

On May 25, 2023, the FBI announced that the reward for information leading directly to the arrest of a Ten Most Wanted Fugitive increased from up to \$100,000 to up to \$250,000.

In some cases, the potential reward amount may be higher.

“The FBI recognizes the crucial role that public assistance has played in tracking fugitives throughout the years,” said Assistant Director Luis Quesada of the FBI’s Criminal Investigative Division. “Raising the rewards for the Ten Most Wanted Fugitives will ideally garner additional public tips resulting in the capture of these

dangerous criminals.”

The FBI began publishing its Ten Most Wanted Fugitives list in March 1950 after a reporter asked for names of the “toughest guys” the Bureau sought to capture. A Washington Daily News article that followed—titled “FBI’s Most Wanted Fugitives Named”—created so much publicity that former FBI Director

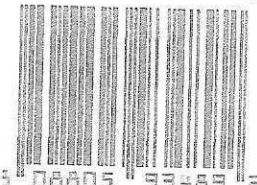

Kidnapping

Guadalupe Garcia Pena, 38, Commerce Street Loudon, was charged with Domestic Assault, Kidnapping, Criminal Impersonation, and Criminal Trespass.

Loudon City Officers encountered the victim. She reported to the Officers that she had been held against her will for several hours and was assaulted by her ex-husband Guadalupe Garcia Pena. She stated that this incident took place at Commerce Street Loudon (The Old High School). She did appear to have injuries to her face. She went on to state there should be blood from the assault still in the room that Garcia was staying at this address. Officers went to Commerce Street (Building is UNIFT For Human Hab-

tation) where we encountered a Hispanic male sitting outside of the building crying. When Officers asked this individual his name he told the Officers he was Martin. When we challenged this and asked to look at his wallet he complied. The identification card in his wallet identified him as Guadalupe Garcia. We noticed that Garcia had what appeared to be offensive injuries to his hands. Officers asked for and received verbal consent to search Garcia's room. In his room, Officers found several sports of blood on a mattress, on the floor, and what appeared to be both cast-off and smeared blood on one of the walls. There was also a hole in the sheetrock which was consistent in size and shape with what you would expect to see someone's head had been run

though the wall. Garcia did knowingly and unlawfully confine the victim in a way that substantially interfered with her liberty. By Garcia's actions, the victim was substantially exposed to the risk of bodily injury and she

indeed receive bodily injury to her face and head area. Guadalupe was placed under arrest and transported to the Loudon County Jail without incident. All of the above occurred in the City of Loudon TN.

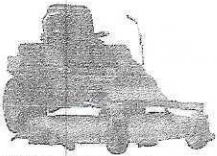

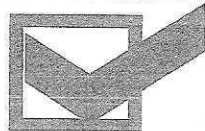

 Andrew Edgemon, 22, Pond Creek Road Philadelphia, was charged with Aggravated Burglary, and Theft of Property.

Deputy Pendleton LCSO, spoke to victim via phone in reference to an aggravated burglary that occurred at Pond Creek Road. Victim stated he left his residence at approximately 0800 and everything was normal. He left to go work on a shed on the back part of the property that was

not visible to the camper. He stated that Andrew Edgemon was seen on the property at approximately 1:00 pm. He stated that he was told they were seen walking in the Cash America pawn shop at approximately 1:45 pm. When victim arrived back at his camper at approximately 6:15 pm he opened the door to his residence which was not locked, and he locked it when he left. Upon entering his residence he noticed his shotgun which was located immedi-

ately across from the entrance under a winter coat was gone. The shotgun is described as a Savage Arms black synthetic 12 gauge pump action with a three-inch chamber serial number 21P3259. He then noticed a pick-axe head laying on the ground next to the door outside the front door of the camper. This is the object believed to be used to make entry into the residence. tor J. Edgar Hoover decided to implement an ongoing list.

The first person named to the list in 1950 was Thomas Holden, wanted for the murder of his wife, her brother, and her stepbrother. He was arrested in 1961 in Oregon after the FBI received a tip from a public citizen who had read an article about Holden in The Oregonian newspaper.

Over the years, the FBI has apprehended or located 494 fugitives on the Ten Most Wanted Fugitives list. 163 were captured as a direct result of citizen cooperation. In the last five years alone, the FBI has captured eight fugitives from the list, most recently Michael James Pratt and Jose Rodolfo Villarreal-Hernandez.

Fugitives named to the list must be considered particularly dangerous to society, with a long track record of committing serious crimes. The FBI also considers whether national and/or international publicity would likely assist in apprehending the fugitives.

Noteworthy Ten Most Wanted Fugitives

1. Thomas James Holden

Thomas James Holden was the first fugitive to be placed on the Ten Most Wanted Fugitives list. He was arrested in 1961.

293. Ruth Eisemann-Schier

Ruth Eisemann-Schier was the first woman placed on the Ten Most Wanted Fugitives list. She was arrested in

1969.
458. James "Whitey" Bulger

Notorious organized crime boss James "Whitey" Bulger was arrested in 2011 after 16 years on the run. He was arrested thanks to a tip from the public.

In May 2023, Donald Eugene Fields II became the 531st addition to the list. Fields is wanted for the alleged sex trafficking of at least one child in Missouri between approximately 2013 and 2017.

"There is no question that the growing threat of violent crime concerns both law enforcement and communities all over the country," said Quesada. "The reward offers of up to \$250,000 is a significant increase, representing the FBI's commitment to getting these disruptive criminals off the street."

In addition to traditional media outlets—such as newspapers, magazines, television, and radio—the FBI uses digital and electronic technology to share information on the current Ten Most Wanted Fugitives. Their faces are on digital billboards across the United States, as well as on the FBI's website and social media accounts. Smartphone users can download a free app, FBI Wanted, to have the latest information at their fingertips.

Police Beat

Luis Duran, 18, Kline Drive Loudon, was charged with DUI.

Officer Luna with LPD, was on routine patrol in the area of Hwy 72 and Sweetwater Creek Blvd, when a red SUV was observed stopping into the emergency lane and swerve back into the correct lane of travel before entering the middle lane on Hwy 72 before the red light at Carding Machine Rd. Vehicle was unable to maintain lane, crossing the double yellow line into upcoming traffic several times, appearing to have a hard time controlling the vehicle, being a danger to himself and other drivers. Officer Luna initiated a routine traffic stop in the area of Hwy 72 and Holt Dr. Upon approach to the vehicle Officer could smell a strong odor of alcohol coming from the driver person, driver had bloodshot eyes and slurred speech. Driver was identify as Luis Duran, Luis Duran stated to the officer he had been drinking prior to the incident, he stated not know the amount of alcohol he had been consuming. Luis Duran appear confused and stating coming from a friends house. Luis Duran agreed to perform field sobriety test, which he performed poorly. was transported to the Loudon County Jail without incident, where he later performed the sample giving results of, .055. Vehicle was towed from scene by James Towing. Luis Duran was cooperative with the officers through the incident. All of the above occurred in the City of Loudon TN.

Jose Cucul-Chub, 35, 5th avenue Lenoir City, was charged with, Domestic Assault.

Officers with the Lenoir City Police Dept. were dispatched to 5th Ave W, in regards to a physical domestic. The complainant (9 yr old Son) stated that his mom and dad were fighting and his dad was punching his mother in the head. Officers arrived on scene and made contact with the son, who let officers in the residence. Contact was made with the Father (Jose Cucul-Chub) and mother the victim and officers did observe, red markings, on the victims left jaw area. Cucul-Chub appeared to be heavily intoxicated, with bloodshot, watery eyes, and had also urinated on himself while speaking with officers. Victim, told officers they began to argue due to him being intoxicated when Jose became angry and used a closed fist punch, striking her on the left side of her face twice and then began to try to drag her by the hair. Both witnessed the altercation and Jose was placed in custody and transported to the Loudon Co Jail.

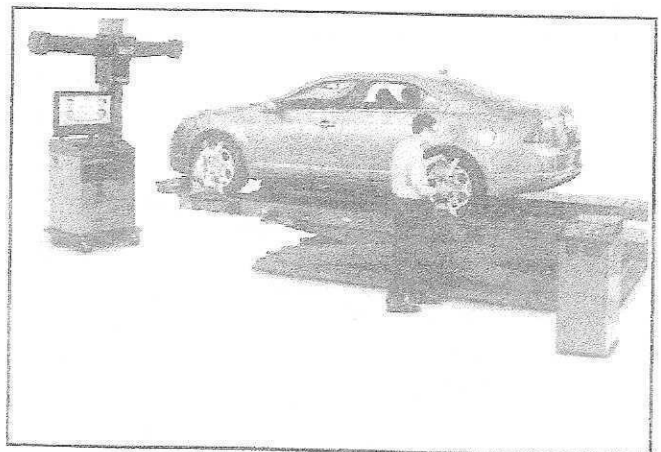
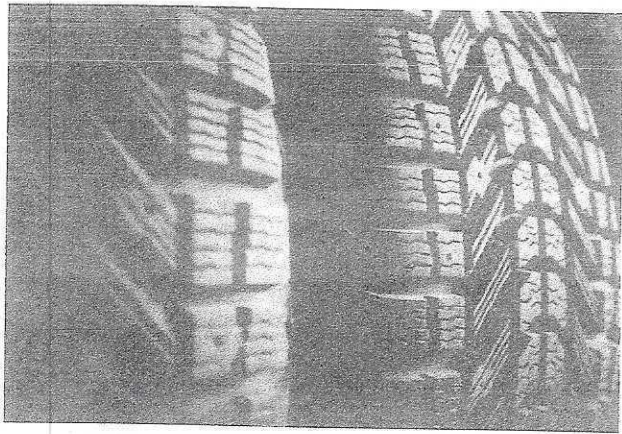
