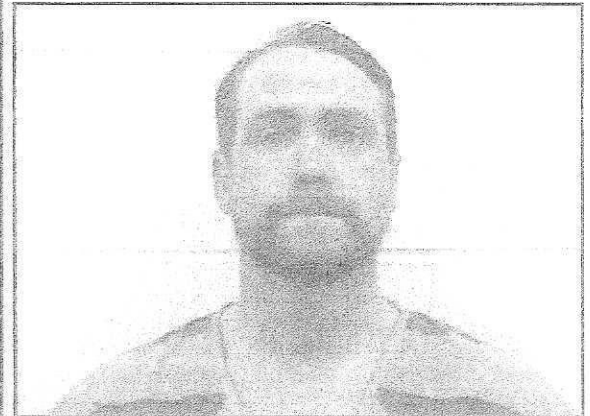

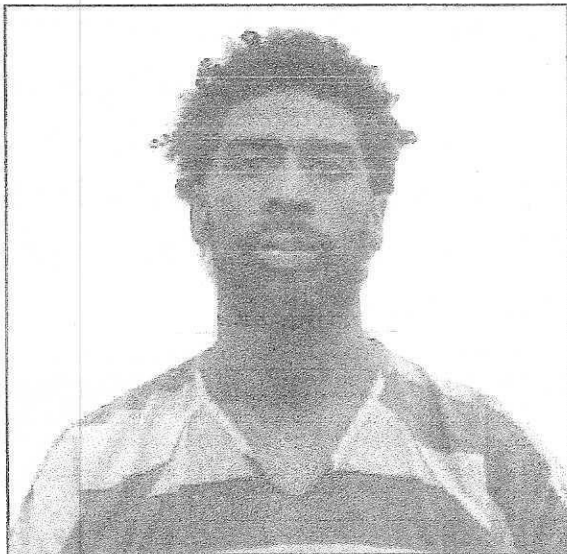

Former Carroll County Volunteer Fire Chief and Wife Indicted for Theft

Couple Served with the District 8 Station in Huntingdon

An investigation by the Tennessee Comptroller's Office has resulted in the indictments of William and Malisa Smith, who served respectively as the fire chief and treasurer for the Carroll County Volunteer Fire Department District 8 - Mixie station.

Comptroller investigators determined the Smiths stole at least \$30,150.86 from the volunteer fire de-

partment beginning in April 2014 until they resigned in March 2020.

The Smiths misappropriated the money from the department's bank account and from a separate credit union account.

The Smiths made unauthorized debit card transactions, check disbursements, and cash withdrawals. These included purchases at

various retail stores; personal lodging and travel expenses; payments for food and alcohol; fuel purchases; and payments for various personal services. Department members confirmed the transactions did not benefit the department.

Investigators interviewed the Smiths in February 2023. The

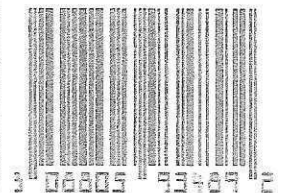

Deputy Talbott LCSO, responded to Kenosha Lane in reference to an aggravated burglary. When Deputy arrived on scene he spoke with the (victim). Victim advised that Colin Winters (offender) was at her residence doing power washing service on the exterior of the residence. Mr. Winters asked victims husband if he could use the restroom. The husband escorted Mr. Winters into the residence. Mr. Winters entered into the powder room located to the left of the front door "while facing the front door from the exterior of the residence". After Mr. Winters relieved himself, he was escorted back outside by the husband. The husband took his dog for a walk down

Kenosha Lane while the victim remained inside of the residence.

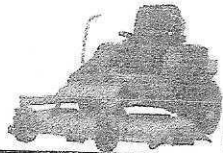
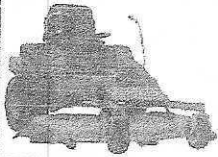

Zachary Sides, 33, Quite Pond Way Knoxville, was charged with, DUI, and Violation of Implied Consent.

Officer Law LCPD, was conducting traffic control at City Park Drive for Rocking on the docks, when a male who Officer later identified as Zachary Sides pulled up to his stationary position in a black BMW sedan (TN Tag 361-BBVZ) asking for directions. While speaking to Mr. Sides, Officer observed him to have bloodshot, watery eyes, and pin-point pupils. Officer asked Mr. Sides if he had smoked any illicit narcotics, and he responded not in a few weeks. Mr. Sides then consented to SFST, once Mr. Sides exited the vehicle, Officer could smell the odor of an alcoholic beverage emitting from his persons. During HGN Officer ob-

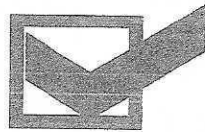

Juwan Norris, 26, Heritage Rt. Drive Delaware, was charged with Domestic Assault, and Criminal Trespassing x2.

Officer A. Lee LCSO, was dispatched to McGhee Square Apartment 12C in reference to a disturbance. Central Dispatch advised the complainants boyfriend, Juwan Norris, was inside the apartment breaking things and making threats to kill the complainant/victim. Officers made contact with Juwan and detained him. A records check revealed Juwan had an active warrant for his arrest for Criminal Trespassing. When speaking with the complainant she advised Juwan had been belligerent with her due to there being no marijuana to smoke and demanded she go to a dispensary to buy some. Victim states she agreed due to Juwan being belligerent towards her since 0930 hours. Upon her return, she states her living room TV and decorations had been

Juwan entered the property without the effective consent of its employee's or owners. Juwan Norris was identified as the primary aggressor and transported to the Loudon County Jail without further incident. All the above did occur in Lenoir City, Loudon County, TN.

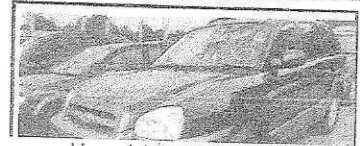

Smiths admitted they made personal transactions with fire department funds.

Based upon this investigation, in May 2023, the Carroll County Grand Jury indicted both William and Malisa Smith on one count of theft of property over \$10,000, and one count of fraudulent use of a debit card over \$10,000.

"The former fire chief and treasurer had exclusive control over the department's bank accounts," said Comptroller Mumpower. "In addition to separating financial duties, an independent person should also review the department's bank account activities to ensure that funds are properly spent."

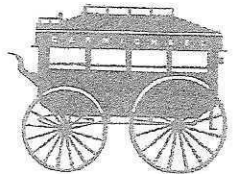
