Law Enforcement Community Recognizes the 20 Year Anniversary of the Heart of America Regional Computer Forensic Laboratory

The FBI, and other law enforcement officials today recognized the 20-year anniversary of the Heart of America Regional Computer Forensic Laboratory (HARCFL). The HARCFL, which officially opened on July 9, 2003, was the fourth of 17 FBI-sponsored digital forensic and training centers in the U.S. devoted entirely to the scientific examination of digital evidence.

Since 2003, the HARCFL has provided timely, objective digital

forensic services to law enforcement agencies within its service area—the entire state of Kansas and the western district of Missouri. The HARCFL, a fully accredited laboratory, also earned international accreditation originally from the American Society of Crime Laboratory Directors/Laboratory Accreditation Board and later from the ANSI National Accreditation Board—the world's largest forensic science accrediting body.

At inception, the

HARCFL had 11 full-time agencies with 14 full-time computer forensic examiners. Today, there are 17 participating law enforcement agencies with more than 20 full-time examiners. The increase in full-time examiners and participating agencies goes directly to the evolution and enhancement of technology and demonstrates digital forensics as an invaluable tool in solving

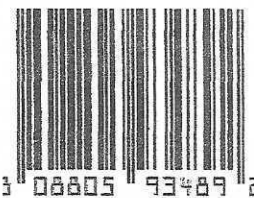
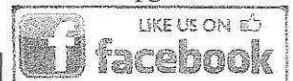

Marissa Witwer, 2nd Street Texas, was charged with Forgery, Man/Sell/Del/Re-sale Sch. IV, Poss. of Sch. II, Simple Possession Sch. VI and Offence of Prescription Drug Fraud.

Officer Chad Purdy LPD, was dispatched to Walgreens for a female trying to pass a fake prescription. Officer arrived on scene at Walgreens and located the female in a Black Dodge Caravan in the Walgreens parking lot. Upon approaching the vehicle, Officer's smelled a strong odor of Marijuana omitting from the Vehicle. Officers then asked the subjects out of the

Vehicle for a search. The driver admitted to Officer that he had Marijuana in his bag in the Vehicle's trunk. Officers did locate in the driver's bag 3.4 grams of a green leafy substance believed to be Marijuana. During the probable cause search, Officer Cogdill found three prescription bottles of Oxycodone in the center console with three different names on them. Subjects were identified as Ms. Marissa Jelle Witwer and Mr. Brenton Marshawn Brown. During a further search of the Vehicle, a fourth prescription bottle was in Mr. Brown's suitcase. After searching Ms. Witwer's suitcase in the back, two blue bags of a green leafy substance that appeared to be Marijuana were found. There was also a green leafy substance found in Ms. Witwer's purse. She had a total of 28.2 grams of a green

leafy substance she admitted that was hers. After speaking with the Pharmacist, he did confirm with the Dr. that the prescription was forged and attempted to be passed. After further investigation Officer's learned that the above

subjects had been passing fake prescriptions throughout the state of Tennessee. The above subjects were then placed under arrest and transported to the Loudon County Jail. This did occur in the City Of Loudon.



Stephanie Amburn, 49, Tellico Street Englewood, was charged with Aggravated Assault.

Deputy C. Lane LCSO, was dispatched to Highway 411 S in reference to a custody dispute. The complainant, called on behalf of his brother, the (victim), and advised dispatch that his brother's ex-wife, Stephanie Amburn (offender), had arrived at his residence trying to get their son whom they share, acting very irate and "crazy." Complainant also advised that there is an order of protection against Stephanie that had not been served yet. While Deputy was en route, the complainant advised dispatch that Stephanie left his residence and went to his mother's residence who lives next door.

Before the deputy arrived

on the scene they advised Stephanie had left the scene. Shortly after, Deputy arrived on the scene and spoke with the complainant, also his brother, the victim, and the witness.

While on the scene, the victim advised me that while Stephanie was at his mother's house, his mother called and was scared because of the way Stephanie was talking and acting. While confronting Stephanie, the victim stated he asked Stephanie to leave and she threatened to kill him and his family multiple times. The victim said Stephanie also tried to push him with her vehicle, striking him in the leg, then backed up and drove forward toward him several times before finally leaving. Also, in the past, Stephanie is on video threatening the lives of her Ex-Husband and

her 15-year-old son.

One witnessed the incident involving the vehicle and did confirm John's claims. The victim, did state she put him in fear of serious bodily injury and he felt extremely threatened. Stephanie Amburn is being charged with Aggravated Domestic Assault.

"Since its inception, the lab has been a leader in digital forensics for Kansas City and across the Midwest. In addition to the petabytes of data the HARCFL has processed over the last ten years, the lab has trained hundreds of law enforcement officers in digital forensic best practices," Acting Special Agent in Charge Chad Jaffe said. "Throughout the last two decades, the HARCFL has played a pivotal role in the success of countless cases and brought justice to hundreds of victims. This is a testament to the lab, and our hard-working and committed partners that dedicate time and personnel to this resource for our community."

Throughout the last two decades, the need for the lab has only grown with advances in technology. In terms of data, the HARCFL processed almost 400 terabytes of data in 2022 and more than 420 terabytes of data in 2021. In the past ten years (or since 2013), the lab has processed more than 4 petabytes, or 4,000 total terabytes, of data and performed more than 4,700 examinations of digital evidence for cases.

"The Overland Park Police Department is a proud partner in the Heart of America Regional Computer Forensic Laboratory (HARCFL). This valuable resource enables area police departments to remain on the cutting edge of law enforcement investigative practices involving computer/cyber-based criminal activity," said Overland

Case Highlights:

In the past decade, the HARCFL has participated in several

high-profile and extensive cases. A few highlights of the lab's efforts, include:

Airport Bombing Plot:

An avionics technician moved forward with a plot to detonate explosives at the Wichita Mid-Continent Airport. The HARCFL aided with the digital evidence and supported the investigation conducted by Wichita FBI's Joint Terrorism Task Force.

Kansas Man Sentenced to 20 Years in Prison in Plot to Explode Car Bomb at Airport

Frazier Glen Miller, Jr.:

The HARCFL supported the investigation of an individual who targeted Jewish people when he took the lives of three non-Jewish people, including a 14-year-old boy outside a Jewish facility on April 13, 2013. The HARCFL aided in processing digital media in the case.

John T. Booker, Jr.:

The HARCFL provided digital forensics expertise to the investigation into a plan to detonate a vehicle bomb on the Fort Riley military base in Manhattan, Kansas.

Hesston Shooting:

On February 25, 2016, a shooter, identified as Cedric Ford, drove toward a plant where he had previously been employed and fired shots on his way to and upon arriving at the plant. During the shooting, three people were killed and 14 more were wounded. In the aftermath of the shooting, the HARCFL deployed its Mobile Digital Forensics Lab to the scene and assisted in processing digital evidence in this investigation.

Thomas Hauk:

Thomas Hauk – Overland Park accountant sentenced to nine years in federal prison for embezzling funds from a financial services company. For nearly a decade, Hauk engaged in schemes to defraud his clients. The HARCFL processed digital evidence in the investigation.

Accountant Sentenced for \$4 Million Embezzlement Scheme

Attack at Fort Leavenworth:

On September 7, 2017, Clifford Currie walked into Fort Leavenworth military hospital where he worked as a civilian in

an administrative capacity and brutally attacked his supervisor, Army Lt. Katie Blanchard. He walked into her office, doused her in gasoline, and set her on fire. He then attempted to attack her with scissors but was stopped by a witness on the scene. Currie was convicted of assault with attempt to commit murder and was sentenced to 20 years in prison. The HARCFL was able to uncover evidence from Currie's cell phone and computer which greatly assisted in proving premeditation.

Former Hospital Worker Sentenced in Attack at Fort Leavenworth

Plot to Attack Immigrants:

Three subjects were convicted for their plot to attack an apartment complex in Garden City, Kansas. Hoping to inspire other attacks on Muslims, the men planned to bomb the complex, attacking the Somali Muslim population in the town. Four examiners at the HARCFL supported the investigation by performing forensic examinations on the subjects' computers/phones. Patrick Stein was sentenced to 30 years in prison, Curtis Allen to 25 years, and Gavin Wright received 26 years.

Swatting Incident:

A local police department responded to a reported incident of domestic violence involving a death and a threatened arson. Upon arrival, one of the Department's officers shot and killed the occupant after he believed the occupant was preparing to use deadly force against other officers. It was thereafter determined that the reported incident was a contrived "swatting" call made by Tyler Barriss. HARCFL examiners were involved in the examination of gaming devices and onsite assistance at several search warrant locations.



James David Hudgens of Tellico Village, Loudon, TN, passed away July 7, 2023, at age 85, from complications related to cancer. Born in Salina, KS on May 26, 1938, to the late James S. Hudgens and Rosemary Holden. He was preceded in death by his wife of 60 years, Lois M. Hudgens and his brother Mike. They had six sons: Timothy (Sheri) and Canton, GA; Patrick (Lisa) of Novi, MI; Christopher (Trisha) of Rogers, AR; John (Kelly) of Grand Blanc, MI; Brian (Christy) of Rockford, MI and Terry (Betsy) of Grand Rapids, MI; fifteen grandchildren: Robert (Dr. Katie), Stephen (Ashton), Megan, Sara Janca (Joe), Christina, Alex (Megan), Emily, Connor, Korinn, Taylor, Hannah, Sean, Madelyn, Katie and Ashley Hudgens; and six great grandchildren: Rilyn Jannakos, Emmett Manor, James, Bowen, Jack and Cooper Hudgens. He is also survived by his sister Susan Plancon of Columbus, OH; Steve (Chrissie) of Fenton, MI; and Ruth Hudgens of Salem, OR. David was recently engaged to Linda Zschiedrich of Loudon, TN. Dave Hudgens worked briefly as a daily newspaper reporter before beginning a 38-year career with General Motors Corporation in public relations. His career included stints at both the Buick and Chevrolet divisions in Michigan, the GM Washington office, in GM's Aerospace division in Milwaukee, and at the company's Corporate Staff in Detroit. Later in his career, Dave was associated with GM's international public relations efforts, handling PR in emerging markets and working with GM's worldwide public relations staff.

After retiring in 1995, he worked as a freelance public relations writer, counselor and

executive speechwriter in his own company, Wordbench and was affiliated with a Detroit PR firm as a consultant and senior counsel. Dave moved to Tellico Village in April 2000 where he began writing a weekly column on the Village for the Knoxville News-Sentinel called "Tellico Talk". He held a journalism degree from Marquette University and was a member of the Public Relations Society of America and the Automotive Press Association. Dave was a parishioner of St. Thomas the Apostle Catholic Church. He was chairman of the Communications Advisory Committee for the Tellico Village Property Owners Association, member Tellico Village Homeowners Association, Friends of Tellico Village Library, Computer Users, Woodworks, Loudon County Habitat for Humanity, served as a captain in the Tellico Boaters Assistance Response Team (T-BART) and on the board of the Child Advocacy Center. Dave will be remembered for his gift of storytelling; not many jokes he hadn't heard or shared. 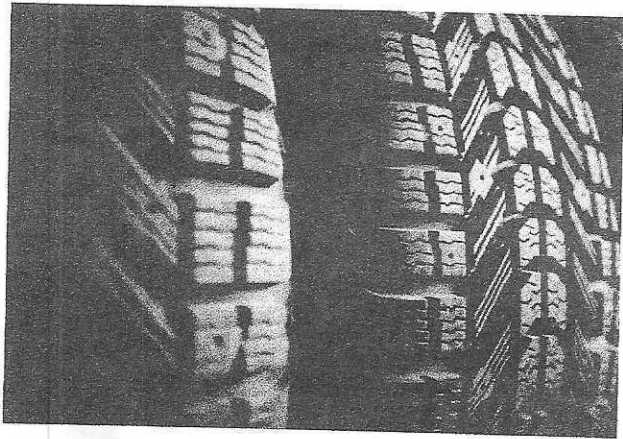

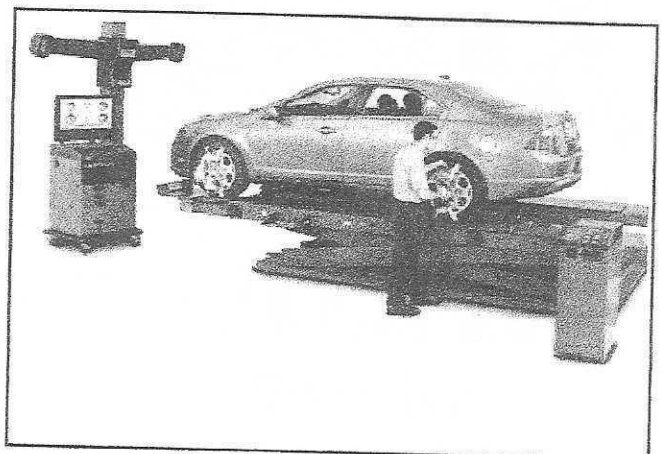
