## Loudon Grand Jury Meets Today to Consider Cases

The Loudon County Grand Jury is set to meet today to consider approximately 50 cases, according to District Attorney General Russell Johnson. This will be a new set of grand jurors that will be empaneled at the Loudon city municipal building on Highway 72 beginning at 8:30 AM.

Empaneling a large number of jurors, for

both potential jury trial service and grand jury service, can take several hours in Loudon County. Additionally, on Monday, Loudon County Criminal Court Clerk Steve Harrelson will be implementing a new system for payment of all jurors. They will be issued cards that operate like gift cards that can be loaded by the county finance department

with money which is required for the payment of jurors under state law. This will save the additional expense, clerk work and time, as well as the inevitable delay involved in issuing and mailing checks like has always been done in times past. Jurors are paid \$11 a day for any portion of the day that they are called in

## CDC warns of Listeria outbreak linked to "Soft Serve On The Go" ice cream cups

A CDC food safety alert regarding an outbreak of Listeria infections has been posted: <https://www.cdc.gov/listeria/outbreaks/ice-cream-08-23/index.html>

**Key Points:**  
Two people infected with the outbreak strain of Listeria have been reported, one from New York and one from Pennsylvania. Both have been hospitalized, and neither died.

The true number of

sick people in this outbreak is likely higher than the number reported, and the outbreak may not be limited to the states with known illnesses.

This is because some people recover without medical care and are not tested for Listeria. In addition, recent illnesses may not yet be reported as it usually takes 3 to 4 weeks to determine if a sick person is part of an outbreak.

Listeria was found in

a "Soft Serve On The Go" ice cream cup collected from a sick person's freezer, and laboratory scientists are working to determine if it is the outbreak strain of Listeria.

On August 9, 2023, Real Kosher Ice Cream recalled all flavors of "Soft Serve On The Go" ice cream cups.

CDC is concerned because the recalled

This new system will be easier and more efficient for the county, the clerk's office, the finance department, and the jurors, but it will cause a minimal delay in getting started with grand jury on Monday, commented Johnson.

Juries have had to be empaneled at the city municipal building because the Loudon County Courthouse burned in April 2019. Since no new courthouse was built to replace the old one, which was built in the 1870s, Loudon City's municipal building is the only government building large enough to hold large numbers or jurors that

still have to be empaneled by staggering their arrival times throughout the day.

The members of the grand jury are empaneled first, and then have to make their way to the courthouse annex to conduct their grand jury meeting for the remainder of the day in the room for the county commission meets. There again, because there is not a courthouse for them to meet in this provides a private space to conduct their meetings.

Therefore, the drivers license service provided by County Court Clerk Riley D. Wampler will not be available on Monday due to the grand jury meeting.

**Wanted**

Maston West, 43, Craigs Chapel Road Greenback, was charged with Domestic Assault, Criminal Impersonation, Simple Possession, Possession of Drug Para, and Violation of Probation x2.

Deputy Davis LCSO, was patrolling his assigned zone. When he observed a white male matching the physical description of Maston West building hay on a tractor in the field of Craigs Chapel Road. Deputy knew from prior knowledge that Maston West had two violation of probation warrants and one domestic assault warrant. I made a consensual encounter with the male. The male advised his name was Robert. Deputy advised the male that he knew who he was. The male advised multiple times that he was not Maston West but later confessed his name was Maston West. Deputy detained Maston after he identified himself. Prior to detaining Maston, he placed an orange container in the toolbox of the tractor. Dispatch confirmed


all three warrants. Warrants#- 2023CR948, 2021CR280, and 2021CR280. Deputy read Maston his Miranda rights and he consented to answering questions. Maston advised there was pipe and possibly about one gram of meth in the toolbox of the Tractor. A search warrant was obtained to search the Tractor. Deputy located a small baggy with a white crystalized substance in it and a glass pipe with residue of a white crystalized substance in it. Maston was taken into custody for simple possession, possession of drug paraphernalia, criminal impersonation, and the three warrants on file. Deputy Green tested the white crystalized substance with the TruNarc machine, and the substance tested positive for Methamphetamine. The white crystalized substance weighed 2.23 grams. The white crystalized substance and the glass pipe was placed in the drug box located at the Loudon County Sheriff's Office. This incident occurred in Loudon County Tennessee.

Corey Millsaps, 46, Pond Creek Road Philadelphia, was charged with Domestic Assault.

Deputy Willis LCSO, along with Deputy Stanley and Cpl. Hawkins responded to an ongoing Domestic at Utseesti Lane. Upon arrival, Deputy made contact with Corey Millsaps, the offender at the end of the driveway. While speaking with Mr. Millsaps he explained to the deputy he went to access her phone and the victim became upset and started yelling at him. He stated he refused to give her the phone back and she punched him in the face. He did state that he punched the wall instead of hitting her. He then exited the residence and got his kids in the car. He said he could not find the keys to his vehicle and she had locked the front door to the residence. He stated he did climb through the front window that was open to get his keys. Deputy Stanley and Cpl. Hawkins made contact with the victim/complainant sitting in her car in the driveway. While talking to her she stated he was contin-


uously trying to get her phone. At one point during the altercation, Mr. Millsaps punched the wall. She stated she was in the bedroom when he climbed through the window. Deputy Stanley did observe damage to the baseboards below the window. She said he advanced on her in the bedroom still trying to take the phone. She said this put her in fear so she threw her hands up in defense and ended up striking him in the lip. She then stated she went outside to create distance from him. She tried to lock herself and her daughter in the car. She then stated he was able to stop the door from closing and pulled her from the vehicle onto the ground. Deputy Stanley did observe indentations in the grass that corroborated this statement. Also observed were mud and grass stains on the back of victims shirt. Due to the evidence corroborating the victims statements, Mr. Millsaps was determined as the primary aggressor. He was placed into custody on the charge of Domestic Assault and transported to Loudon County Jail





**Robert "Bob" Johnston**, 81, of Tellico Village passed away Sunday, July 30, 2023 as a result of sudden cardiac arrest. Bob was born May 21, 1942 in Continental Ohio to Ilo and Edward Johnston. He graduated from Continental High School where he enjoyed playing team sports, especially basketball with his brother Ray. After high school, Bob began a career with American Airlines that spanned over four decades, with positions that evolved from ground operations in Chicago to his final role as Managing Director at Boston Logan Airport. He was granted a military leave of absence from American and served in the U.S. Army from 1966-1968. He returned to Chicago and attended Harper College on the G.I. Bill, majoring in Business Management. He entered into a rotational training program for high-potential management talent through American Airlines. As a result, he worked as Cargo, Freight Services, and Ramp Manager in Dallas, and General Manager in Oklahoma City and Seattle. It was during his assignment in Detroit that he met Eastern Airlines agent Alison (Leonard) Scott. They married on 9/7/97. Bob's accomplishments and civic activities with American included serving as Chairman of Airline Managers Council in Oklahoma City, Detroit, and Seattle airports. He was a member of Board of Directors for Seattle's Skyline School District, member of FBI/FAA National

Security Advisory Team representing Seattle airport, member of Detroit Economics Club, and honoree of Detroit's SHAR Human Services Award for individuals who have made significant contributions to the betterment of the community. Bob received a New York Fire Department award for coordinating fire and rescue teams following the terrorist attack on September 11, 2001 and American Airlines Flight #11. After deciding to retire, Bob and Alison found their way to Tellico Village, and after seeing their first beautiful sunset over the Little Tennessee River, they knew they were home. Bob was an avid golfer, wallyball player, and a pickleball player when its courts were still at Choto Rec Center. He and his partner were winners at the 2009 Pickleball Volley for the Cure Charity Event. Bob was preceded in death by his parents, Ilo Ketter and Edward Johnston and brother, Ray Johnston. He is survived by his wife, Alison, and daughters Andrea Jasch (Jesse) and Ashley (Zachary); grandchildren Justice Tow, Liberty Jasch, Samuel Bernstein, Rose Bernstein; brother Steven Johnston (Eulene), sister Marcia Thompson (Steven), and sister-in-law, Darlene Johnston. 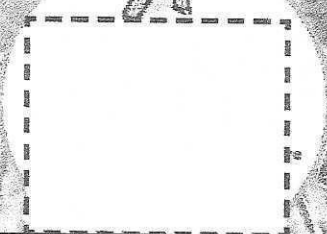

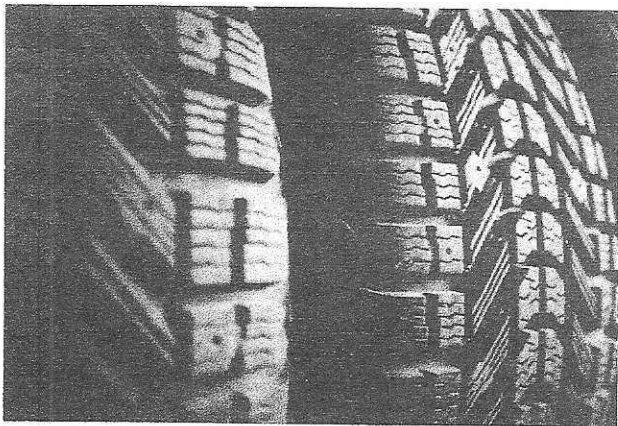
