Chad Thomas Sentenced For Fraudulent PPP Loans

Chad B. Thomas, 41, of Blountville, Tennessee, was sentenced to 40 months imprisonment by the Honorable J. Ronnie Greer, United States District Judge, in the United States District Court for the Eastern District of Tennessee at Greeneville.

As part of the plea agreement filed with the court, Thomas agreed to plead guilty to an information charging him with one count of wire

fraud in violation of 18 U.S.C. § 1343. Following his incarceration, Thomas will be on supervised release for three years. He was also ordered to repay \$307,700 in restitution.

According to court records, in May and July 2020, Thomas submitted three fraudulent Payroll Protection Program ("PPP") loan applications that included false information about payroll expenses and phony supporting documents. In the Spring

of 2020, Congress had authorized the issuance of forgivable PPP loans to qualified businesses for use in paying authorized expenses as a legislative response to the COVID-19 pandemic through the CARES Act. Applicants completed and submitted loan applications that described historical payroll information and attached support-

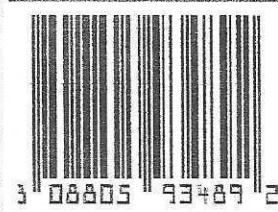

Resale Sch. II, Simple possession, and Poss. of Drug Para.

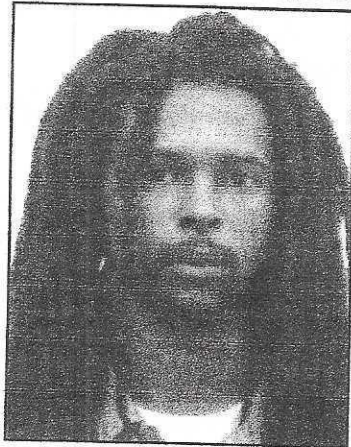
Deputy Parks LCSO, was watching northbound traffic on Interstate 75 around the 66 mile marker. Deputy observed a gray Nissan Sentra travelling slower than the speed of surrounding traffic and noticed the driver look at his patrol car and then attempt to hide his face. As the vehicle exited his view it decreased speed, causing the surrounding vehicles to pass the vehicle. The deputy pulled out of his position and got behind the vehicle. The vehicle immediately changed lanes and got into the left lane of the interstate. The deputy changed lanes and observed the registration of the vehicle flapping from the wind, not securely fastened,

and looked as if it may fly off the vehicle. The vehicle travelled in the left lane for approximately three miles, never in an attempt to pass any cars as there were none in the right lane. The deputy initiated a traffic stop on the vehicle for violating the Slow Poke Law and display of registration plates. The final stop was made on Interstate 75 Northbound at the 71 Mile Marker.

The deputy approached the vehicle and made contact with the driver, Mr. Richard Allen Jr., and informed him of the reason for the stop. Mr. Allen advised he only had a state-issued ID and did not have it on him. Other passengers presented identification and the deputy made contact with the owner of the vehicle, Mr. Jayden Jennings, and gathered the registration and proof of insurance. While speaking with the passengers, the deputy observed the odor of raw marijuana coming from the vehicle. The deputy asked Mr. Allen if he would come back to my vehicle while he wrote his warning citation. While speaking

with Mr. Allen he advised the group was heading to Wartburg and staying in Knoxville at a hotel for two days. Mr. Allen stated he thought Wartburg was about ten minutes from Knoxville and did not disclose any plans for his visit to Wartburg when asked and diverted the subject. Mr. Allen displayed rapid breathing and sounded breathless when speaking. When the deputy asked if there was anything illegal in the vehicle, Mr. Allen stated there was not. The deputy approached the vehicle again and asked Mr. Jennings if he would step out and speak to him. The deputy told Mr. Jennings he smelled marijuana in the vehicle and asked if there was anything illegal in the vehicle. Mr. Jennings then appeared dazed and confused and seemed unable to formulate and articulate a response. Eventually, Mr. Jennings asked if he could show the deputy where the drugs were but was unable to do so. The deputy spoke with Ms. Seneca Gentry who advised she had a small amount

of marijuana in her bag. Ms. Gentry stepped out of the vehicle as well as the front seat passenger, Ms. Ashley McDaniel. A search of the vehicle was performed and a small amount of marijuana was located in Ms. Gentry's bag. Two pressed M-30 pills were located in Ms. McDaniel's wallet as well as a THC Vape and a snort pen. There was also approximately \$7,032.00 dollars located in Ms. McDaniel's wallet. While searching the vehicle, the deputy pulled the panel connecting the dashboard and center console. Located in the void was a gallon bag of pressed M-30 pills (approximate field weight of 2.41 pounds). Mr. Jennings was placed under arrest, and while performing a search of his pockets approximately \$716.00 cash was located on his person. All subjects

were then placed into custody and transported to the jail without incident. The vehicle was towed to a secure lot at the Loudon County Justice Center. A further search of the vehicle revealed a Tisas Zigana PX-9 handgun with a loaded magazine in a diaper bag in the trunk. A meth pipe and a small amount of marijuana believed to be Ms. Gentry's was also located in the diaper bag (approximate field weight 3.23 grams). All drug evidence, paraphernalia, firearm evidence, and cash were seized and bagged, and placed into evidence, and the THC Vape and snort pen were taken to be destroyed. All of the above occurred in Loudon County, Tennessee. Cpl. Christina Wallen LCSO, responded to I-75 NB near the 71 mile marker to assist Deputy Justin Parks with a traffic stop. Deputy Parks had placed the offender, Ashley McDaniel, in custody for charges

related to the traffic stop (see OCA#20230831375), and asked Deputy Wallen to transport her to the Loudon County Detention Facility. Prior to placing McDaniel in the rear of her patrol unit, Deputy searched her for weapons and contraband and asked McDaniel if she had anything illegal on her person or in her person. McDaniel advised that she did not. Once on scene at the jail, McDaniel was asked again by Deputy Amelia Netherton (victim) if she had anything illegal on her person or in her person, and she was advised that she would face additional charges if she brought anything into the jail. McDaniel, again advised she did not. Once inside the jail, McDaniel was searched by Deputy Netherton and Deputy Holly Cook (victim). McDaniel had a plastic grocery bag wadded up and stuffed inside her vaginal canal. When Deputy

Netherton asked McDaniel what the item was, McDaniel stated that the item was a tampon and sat on the toilet to remove the item. McDaniel then proceeded to defecate with her hand between her legs, tore open the bag causing blue pills to scatter across the floor, and eventually threw fecal matter at Deputies Netherton and Cook before attempting to flush the baggie and remaining pills inside the baggie. Additionally, after searching the rear of her patrol unit, Deputy located 2 additional blue pills in the seat where McDaniel was positioned. Because of the water and fecal matter causing some of the pills to dissolve, the exact count of pills is unknown, but there were more than 60 pills still intact, and an additional 15 pills were recovered from the floor. All of the above did occur in Loudon County, TN.

Michael fuller, 34, Urban Way Knoxville, was charged with Man/Sell/Del/Resale Sch. VI & II, Resisting Arrest, Evading Arrest, and Possession of a Firearm.

Law enforcement spoke to Michael Fuller by phone and he agreed to deliver cocaine and marijuana to an address in Lenoir City. Fuller stated to law enforcement that he was exiting the Lenoir City exit. Fuller was observed pulling into the address and walking to the door occupied by law enforcement. Fuller knocked on the door and law enforcement made contact with Fuller. When Fuller saw law enforcement he took off running. Law enforcement gave multiple commands for Fuller to stop, but he continued to evade. After law enforcement caught Fuller he continued to resist by tucking one arm under him. Upon searching Fuller he was found

to be in possession of approximately 3 grams of cocaine and 17.8 grams of marijuana. Fuller was read Miranda and he agreed to speak with law enforcement. Fuller stated that he believed he was delivering cocaine and marijuana to a female in Lenoir City. Agent asked Fuller if he had anything illegal in his vehicle and he stated that he had a pistol. Upon searching Fuller's vehicle a pistol was recovered. Fuller was taken into custody and transported to the Loudon County Jail.

Robert Haun, 48, Sunny side Road Philadelphia, was charged with Aggravated Assault, and Interference with Emergency Calls.

Loudon County Deputies were dispatched to Sunny-side Road regarding a domestic involving a shooting. The victim, stated that her husband, Robert "Bobby"


Haun (Suspect) had come home, and they began to argue about why the dog had been left outside all day. Victim states that Bobby had gotten upset over victim raising her voice over a dog and he stated he was leaving her. At this point, the victim began cleaning the pool. Bobby came out to ask her where the titles were, and she did not know. The victim stated this is when Bobby threatened to beat, drown, or shoot her. In fear, victim ran to her parent's house with Bobby chasing her. Victim stated she told Bobby she was going to call the police. Once she had gotten to her parent's house, Bobby started walking back to their residence. The victim stated that she had gone around the large garage on their property and she observed Bobby on the porch. Bobby also saw her

and threw her phone in the pool and said, "Call the law now". This action prevented the victim from calling 911. The victim went back up to the pool in an attempt to retrieve her phone. When she arrived back at the pool, Bobby had come back outside to get her to leave. At this point, she had made it to the front of the house and Bobby had come outside with a weapon. The victim was running away when she heard a shot from the pistol. Due to victim running away, she did not see where Bobby was aiming. When victim got to the house next door, she turned around and saw Bobby pointing the weapon at her or the dog. The victim was able to describe the weapon as being black with silver on top. 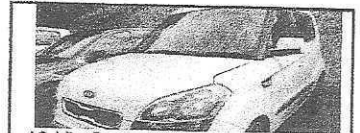

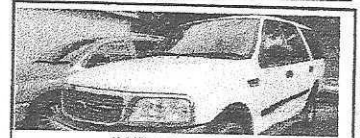

County Deputies made contact with Bobby, he did admit to retrieving a gun. Bobby stated he had shot it in the air. Bobby had also concealed the weapon in a dog food bag in a spare bedroom. This action of shooting the weapon coupled with the threats that Bobby had made earlier to the victim placed her in fear of imminent bodily injury. This did occur in Loudon County, TN.

ing documentation. Thomas submitted three fraudulent PPP loan applications and obtained a total of \$307,700 in fraudulent loan proceeds. As part of his scheme, Thomas submitted false payroll information and included fictitious support-

ing forms as part of his applications, including IRS forms. For the final loan—a PPP loan in the amount of \$207,500—on May 12, 2020, Thomas incorporated a business named Kingdom of God, Inc. as a religious organization with the Tennessee Secretary of State. On July 6, 2020, Thomas electronically submitted a fraudulent PPP loan application for Kingdom of God, Inc. to a lender in San Diego, California. Thomas falsely represented that the company had 26 employees and an average monthly payroll of \$83,000. Thomas also included a monthly payroll journal that showed Thomas' family members, minor children, and several nationally known religious figures were paid employees of Kingdom of God, Inc. Neither the state of Tennessee nor the IRS had any record of Kingdom of God, Inc. ever paying any employees. Kingdom

of God, Inc. did no business and was ultimately dissolved by the Tennessee Secretary of State for failure to file reports. The San Diego lender approved the fraudulent loan application, and on July 14, 2020, deposited the sum of \$207,500 into a Kingdom of God, Inc. bank account that Thomas had formed.

As part of the investigation, law enforcement seized and administratively forfeited the sum of \$161,938.01 from bank accounts Thomas controlled.

U.S. Attorney Francis M. Hamilton III of the Eastern District of Tennessee; and Resident Agent in Charge Jason Brown of the United States Secret Service made the announcement.

The criminal indictment was the result of an investigation by the United States Secret Service. This investigation was led by Special Agents Kay Berry and Thomas Whitehead.

Assistant United States Attorney Mac D. Heavenier III represented the United States.

On May 17, 2021, the Attorney General established the COVID-19 Fraud Enforcement Task Force to marshal the resources of the Department of Justice in partnership with agencies across government to enhance efforts to combat and prevent pandemic-related fraud. The Task Force bolsters efforts to investigate and prosecute the most culpable domestic and international criminal actors and assists agencies tasked with administering relief programs to prevent fraud by, among other methods, augmenting and incorporating existing coordination mechanisms, identifying resources and techniques to uncover fraudulent actors and their schemes, and sharing and harnessing information and insights gained from prior enforcement efforts.
