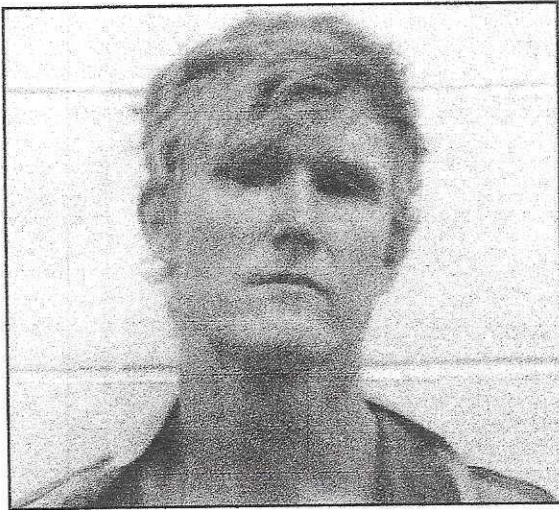

## Five Amazon Marketplace Sellers And Four Amazon Marketplace Companies Sentenced For Price Fixing

Five individuals and four companies have been sentenced for participating in a conspiracy to fix the prices of DVDs and Blu-Ray Discs sold on the Amazon marketplace. This investigation has resulted in a total of six individual guilty pleas and four corporate guilty pleas.

Victor Btsh. of New York, was sentenced to 18 months'

incarceration, followed by two years of supervised release, and a fine of \$38,000; Btsh's three companies, Michelle's DVD Funhouse, MJR Prime, and Prime Brooklyn, were each respectively sentenced to a \$156,520, \$125,688, and \$61,844 criminal fine on August 23, 2023, in the U.S. District Court for the Eastern District of Tennessee.

Additionally, Em-

manuel Hourizadeh, Raymond Nouvahian, Morris Sutton, Bruce Fish, and Fish's company, BDF Enterprises, Inc. were all sentenced on July 21, 2023, also in the U.S. District Court for the Eastern District of Tennessee. Hourizadeh, and Nouvahian, both of New York, were sentenced to one month's imprisonment.

### Charged

Gregory Wright, 40, Highland Ave Murfreesboro, was charged with, Man/Sell/Del/Resale Sch. II x3, Sch. I, & VI, Tampering/Fabricating with Evidence, and Resisting Arrest.

Law enforcement spoke to Gregory Wright by phone, and he agreed to deliver cocaine, crack cocaine, ecstasy, MDMA and marijuana to a location in Loudon City.

Wright stated to law enforcement that he was 40 minutes from the address. Wright was observed pulling into the location and stated to law enforcement that he was at the address.

Wright was observed walking to the door occupied by law enforcement. Wright knocked on the door occupied by law enforcement and law enforcement made contact with Wright. When Wright saw law enforcement he tried to run and continued to re-

sist arrest. Law enforcement was able to get Wright to the ground where he continued to resist for several minutes until being cuffed. Wright tried to swallow a bag of drugs that contained fentanyl and cocaine. Found in Wrights left hand were 2 bags of Marijuana and a bag of cocaine. Upon searching Wright he was found to be in possession of additional fentanyl, MDMA, and crack cocaine. The approximately total of narcotics found in Wright's

possession were 5 bags of fentanyl (3.6 grams), 4 bags of crack cocaine (1.4 grams), 2 bags of cocaine (5.9 grams), 2 bags of marijuana (13.8 grams) and 1 bag of MDMA 1.3 grams. Wright was read Miranda and he agreed to speak with law enforcement. Wright stated that he believed he was delivering the drugs to a female in Loudon City and trying to hook up with a female. Wright was taken into custody and transported to the Loudon County Jail.

Dustin Conrad, 36, Marble Hill Road Friendsville, was charged with DUI, Evading Arrest, Open Container, Violation of Implied Consent, Poss. of Drug para., Traffic Control Device, Speeding, and Altering falsifying or Forging Auto Title.

Deputy Jackson LCSO, observed a vehicle travelling on Highway 321 North at a high rate of speed. Deputy confirmed with his radar that the vehicle was travelling 60 MPH in a 45 MPH zone. Deputy initiated a traffic stop on the vehicle, a gray Nissan Xterra bearing TN registration 399BHJC, at the intersection of 321 North and Jackson Bend Rd. The vehicle slowed as if it was stopping, then turned on Jackson Bend Rd, fleeing at a high rate of speed. The deputy initiated his emergency equipment and continued on Jackson Bend Rd to South

Holston Baptist Church, where the vehicle travelled down an embankment to get back onto 321 North. The vehicle then turned, travelling on 321 South, where it continued until it reached St. Thomas Way turning into the church parking lot. The vehicle continued to evade and by passed several emergency vehicles to get back onto 321 South. It continued on 321 South, disregarding several red lights and maintaining a high rate of speed, through Lenoir City. The vehicle began to enter I-40 EB at the 364 exit, where it stopped at the end of the entrance ramp. Contact was made with the driver of the vehicle, Dustin Conrad, who was subsequently taken into custody. Loudon County Dispatch advised that the registration was expired, however, there was an expiration sticker from a different registration, 240BCQJ, displayed. Upon

inventory of the vehicle an open container of Sweetwater IPA was found in the passenger side floorboard. Leading to a probable cause search of the vehicle, where a glass pipe was found. Deputy read his Miranda Rights and he agreed to speak with him, the deputy noticed that his eyes were bloodshot and his mood shifting erratically. The deputy noticed, due to his training and experience,

he displayed signs of impairment throughout my interactions with him, not being able to follow commands, going from being awake to lethargic, along with his driving behavior. Once at the Loudon County Detention Center, deputy asked if he would be willing to conduct standardized field sobriety tasks, and read TN Implied Consent, he refused both. This occurred in Loudon County, TN.

When Strobel arrived at the location he stated to law enforcement that he was at the address. Strobel was observed walking to the door occupied by law enforcement. Strobel knocked on the door occupied by law enforcement and law enforcement made contact with Strobel. The Officer asked Strobel if he had anything illegal on him and he stated

that he had some crack in a bag. Found in Strobel's possession was approximate 2 grams of Crack Cocaine and a crack pipe. Charles Spears, 35, Browder Hollow Road Lenoir City, was charged with Domestic Assault.

Deputy Parks LCSO, responded to Browder Hollow Road in reference to a

domestic. When Deputy arrived on scene, he spoke with the complainant, who advised Mr. Charles Spears and her husband, were inside the residence. Complainant advised Mr. Spears was heavily intoxicated and was bleeding due to punching a glass fish tank. Deputy approached the residence and could see Mr. Spears trying to assault the victim and entered the residence to stop the assault. Mr. Spears lost his balance while attempting to assault the victim and deputy placed him into handcuffs. The deputy spoke with the victim who advised his family and his neighbors had been drinking and Mr. Spears became belligerent. He further stated that later on victim 2, Mr. Spears girlfriend, had come to their front porch with her child to get away from Mr. Spears. Victim 1 then went to


the residence to try to calm Mr. Spears down. Deputy spoke with victim 2 who advised that Mr. Spears had become belligerent after drinking and punched the glass ceiling fan light shattering it. Mr. Spears continued on to punch the glass fish tank, breaking it. 



ment, seven months home confinement, a criminal fine of \$55,000 each, and two years of supervised release; Sutton, of New Jersey, was sentenced to one month's imprisonment, five months home confinement, a \$20,000 criminal fine, and two years of supervised release; Fish, of Minnesota, was sentenced to six months' imprisonment, six months' home confinement, a \$48,750 criminal fine, and two years of supervised release; and Fish's company, BDF Enterprises, was sentenced to a \$234,000 criminal fine.

"Americans are becoming increasingly reliant on online marketplaces, making it more important as ever to protect them from being cheated on the internet," said Deputy Assistant Attorney General Manish Kumar of the Justice Department's Antitrust Division. "These sentences reflect the Division's commitment to seeking punishment for criminal antitrust violations wherever they may occur." "Conspiring to fix prices in online marketplaces is a federal crime," said U.S. Attorney Francis M. Hamilton III for the Eastern District of Tennessee. "These convictions and sentences demonstrate our office's commitment to prosecuting price-fixing conspiracies and to protecting consumers in the Eastern District of Tennessee from paying inflated prices in online marketplaces."

"Activities related to price fixing and collusion do not promote an environment conducive to open competition, ultimately harming the consumer," said Executive Special Agent in Charge Kenneth Cleevly of the U.S. Postal Service (USPS) Office of Inspector General. "The sentencings in this case represent a win for all law

enforcement agencies who investigate those who engage in this type of harmful conduct to ensure that justice is served."

According to court documents, these defendants agreed with co-conspirators to raise and maintain the prices of DVDs and Blu-Rays sold through Amazon marketplace storefronts, resulting in those products being sold at collusive and noncompetitive prices. Hourizadeh, Nouvahian, and Sutton pleaded guilty to price fixing on January 7, 2022. Btsh and all three corporate entities pleaded guilty to price fixing on February 9, 2023, after having been indicted on March 16, 2022. Lastly, Fish and BDF Enterprises pleaded guilty to price fixing on February 10, 2023, after having been indicted on March 16, 2022.

Amazon Marketplace is an e-commerce platform that enables third-party vendors to sell new or used products alongside Amazon's own offerings. Amazon Marketplace is owned and operated by Amazon.com, Inc.

Trial Attorneys Robert M. Jacobs, Kevin C. Culum, Elizabeth K. Noonan-Pomada, and Nickolas R. Foran from the Antitrust Division's Chicago Office and Assistant U.S. Attorney William A. Roach, Jr. for the Eastern District of Tennessee prosecuted the case. The case was investigated with the assistance of the FBI's New York Field Office and the USPS Office of Inspector General's Contract Fraud Investigations Division.

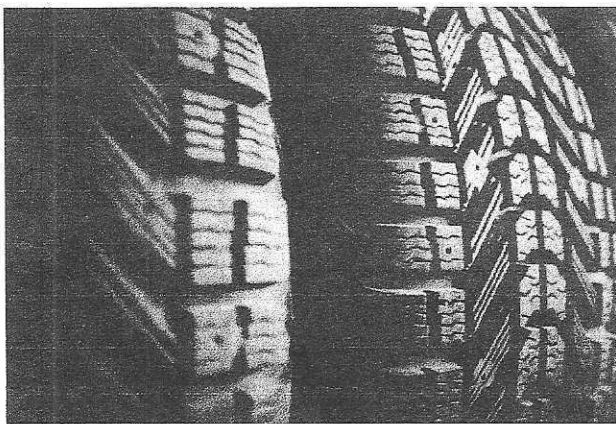
