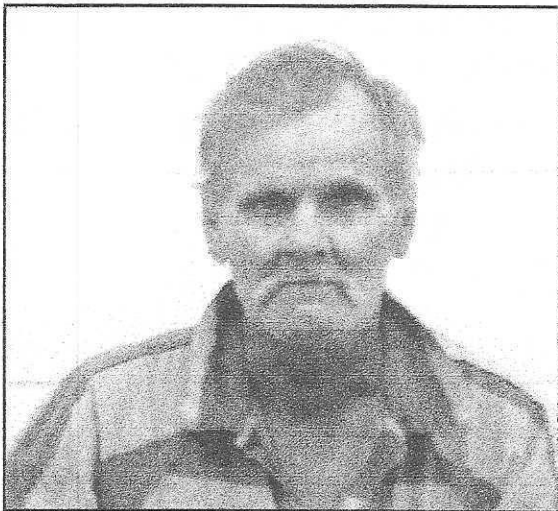

Campus Outreach Director, Minister, and former Student President Indicted

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of three men associated with Middle Tennessee State University's Campus Outreach ministry organization. The investigation began after MTSU's Internal Audit staff notified

the Comptroller's Office about the situation.

Investigators determined that campus director John Thomas "JT" Farmer, campus minister Greg McCall, and MTSU's former student chapter president Austin "Audy" Smothers collaborated to submit a false reimbursement request in an attempt to steal \$4,700 in student activity fees from the university.

The three men

claimed the money was spent to pay for students to attend a virtual New Year's Conference in late 2020, as MTSU's policies at that time prohibited reimbursements for travel expenses due to the COVID-19 pandemic; however, investigators confirmed the men had reserved cabins in Gatlinburg and planned for the

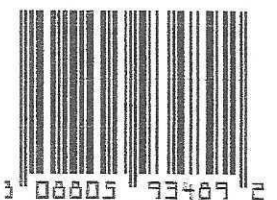

Charged

District Attorney General Russell Johnson is announcing that he predicted TBI to investigate a shooting of a four-year-old female that occurred just before noon this morning at 157 Airport Road inside the city limits of Rockwood. The child was shot once in the chest by Breanna Gayle Devall Runions a 25-year-old

female who resides at the Airport Road residence with her girlfriend, Christina Daniels, along with the child victim and another child who is seven years old. Agents from TBI, along with Chief Kelly Pittman and investigators with the Rockwood Police Department, processed the scene and took statements from Runions and Daniels.

The narrative of the arrest

warrant explains how Runions, who is a handgun carry permit holder, may have initially led investigators to believe that she was demonstrating to the scared four-year old 'firearms safety'. Runions explained how she removed the magazine before pressing the gun to the girl's chest as a way demonstrating that the gun was safe with the magazine removed. However, Runions with the gun pressed directly to the girl's chest, Runions pulled the trigger causing the gun to fire, shooting the girl at contact range. This version was disputed somewhat by both Christina Daniels and another witness in the home who was also a minor. Instead, it may appear that that the two minors were being punished by Runions striking them with a sandal and placing them in separate corners of the adults' bedroom for not waking the adults up when the minors

awoke, and because the two minors took and ate food intended for Runion's girlfriend, Daniels.

After the minor child was shot, Runions and Daniels immediately drove the child to seek medical help and met the responding EMS at the Wal-Mart parking lot from where the child was taken by EMS to Roane Medical Center where she was pronounced dead.

An arrest warrant has been issued for Breanna Runions for Aggravated Child Abuse (a class A felony) and for Felony-Murder under TCA 39-13-202 (a)(2) which is a when a death results in the commission of a felony - in this case the felony being the commission of the aggravated child abuse. TBI and Rockwood PD were directed by DAG Johnson to contact the Department of Childrens Services as to the other child in the residence

and to further investigate the situation as to how and why the children were living with Runions and Daniels who are not the victim's parents.

Certain aspects of this investigation are ongoing and further charges may be forthcoming.

Robert Schlueter, 42, Queener Road Loudon, was charged with, DUI, Violation of Implied Consent, and Resisting Arrest.

Sgt. Bo Cogdill LPD, advised, Officer Ingram, he had just pulled up on a wreck on the Hwy 72 overpass of I-75. Upon arrival Sgt. Cogdill was speaking with the other party involved and Officer Ingram made contact with Mr. Robert Schlueter. He was leaning up against a patrol vehicle and had trouble standing when not leaned against the vehicle. His eyes were visibly bloodshot and he kept asking if "we could just give him a ride home" through slurred speech. Officer asked Mr. Schlueter multiple times if he would be willing to perform a Standardized Field Sobriety Test and at first he consented, but when asked to walk over to a level area of ground to per-

form the test he refused. Sgt. Cogdill advised the Officer Mr. Schlueter admitted to drinking 8 beers, and during Tow Inventory located was an empty bottle of vodka, a tumbler half-empty of vodka within immediate reach of the driver's seat, and an empty daily pill dispenser. Mr. Schlueter was placed into custody by Officer Ingram and Sgt. Cogdill and he did resist arrest. He was very agitated during transport to Loudon County Jail however he was transported without incident. Implied Consent was read at the jail because Officer did not believe it was safe to have Mr. Schlueter on the side of the road any longer than necessary due to his physical state at the time, and he did refuse Implied Consent. Mr. Schlueter is being charged with Driving Under the Influence T.C.A. 55-10-401, Resisting Arrest T.C.A. 39-16-602, and Vi-

olation of Implied Consent T.C.A. 55-10-406. This did occur in the City of Loudon.

Paul Covey, 61, Hickory Creek Road Lenoir City, was charged with Domestic Assault, and Interfere with Emergency Call 911.

Deputy Harrison LCSO, was dispatched to Hickory Creek Road in reference to a 911 hang up. On call back, Dispatch advised they could hear an altercation and a female yelling "Get off of me". Once on scene, Deputy Harrison along with Deputy Lane and Cpl. Dishner made contact with the homeowner at who advised she was home alone and did not call. She stated the neighbors across the street at Hickory Creek get into verbal arguments frequently. At this point, we went on scene at and made contact with the victim at the

side door of the residence. She stated she called after she and her husband got into a physical altercation. Victim stated it happens often and on this day she had fallen asleep on the couch when her husband, Paul Covey came into the living room yelling and accusing her of stealing something of his. This led to a verbal altercation and during this, Paul began to throw items around the house and at the victim. During the altercation, the victim stated she was backed into the corner of the kitchen as Paul began to throw chairs from the dining room table at her. After this was when she stated she had picked up the phone to dial 911. Victim stated Paul was asking her if she had called law enforcement and this was when Dispatch could hear her yelling



“Get off of me” as he was attempting to take the phone away from her. Victim stated Paul was successful in taking the phone and left the residence shortly after with her phone. Deputy did observe multiple items thrown and scattered across the bonus room to the side of the house as well as two chairs from the dining room table laying in the kitchen with legs broken. The victim stated these actions placed her in fear that she was going to be harmed. Deputies were able to search the residence and buildings on the property but were unable to locate the offender at the time of the incident. This did occur in Loudon County, Tennessee.

conference to be held there in-person. This event was subsequently canceled. Farmer, McCall, and Smothers also collaborated to submit a fabricated receipt to MTSU to support their false reimbursement request in an attempt to induce MTSU to pay the claim.

Additionally, investigators noted that Campus Outreach at MTSU provided false information regarding its financial condition to MTSU. For example, on May 15, 2021 Campus Outreach at MTSU submitted a financial report form to the university indicating it had \$95 in its bank account. Investigators reviewed bank statements which showed the actual bank account balance on May 15, 2021 was \$59,727.37.

In August 2023, the Ruthersford County Grand Jury indicted Farmer, McCall, and Smothers each for one count of attempted theft of property over \$2,500, one count of forgery, one count of crimi-

nal simulation, and one count of false entries in a government record.

“I am pleased to note that MTSU officials have made significant updates to the university’s Student Activity Fee reimbursement procedures since this issue was first recognized,” said Comptroller Jason Mumpower. “Establishing and following clear policies and procedures, which include reviewing required documentation, helps prevent fraudulent activity from occurring.”

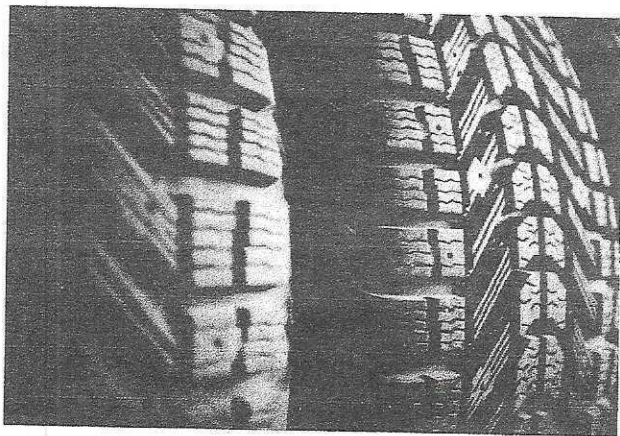

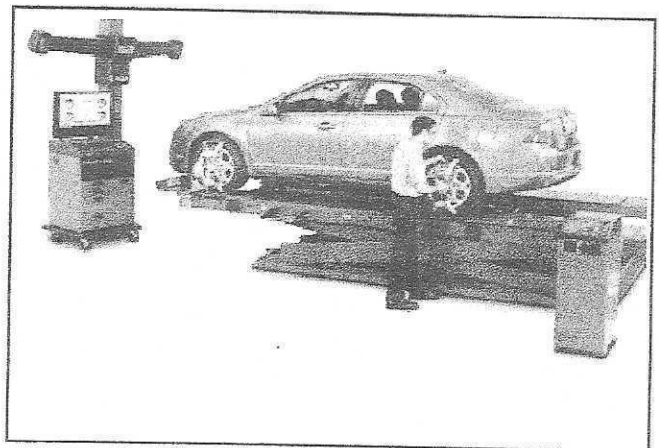
