Philip George Turner Sentenced To 17 Years For Distribution And Possession Of Child Pornography And Felon In Possession Of A Firearm

Philip George Turner, 39, currently of Kingston, TN, was sentenced to 204 months by the Honorable Katherine A. Crytzer, United States District Judge, in the United States District Court for the Eastern District of Tennessee at Knoxville.

As part of the plea agreement filed with the court, Turner waived an indictment

by a Federal Grand Jury and agreed to plead guilty to an information charging him with, one count of distribution of child pornography in violation of 18 U.S.C. § 2252A(a)(1)(2); one count of possession of child pornography in violation of 18 U.S.C. § 2252A(a)(5)(B); and, one count of felon in possession of a firearm and ammunition in violation of 18 U.S.C. § 922(g)(1). Follow-

ing his incarceration, Turner will be on supervised release for 20 years and will be required to register with state sex offender registries and to comply with special sex offender conditions.

According to court records, in May 2022, local law enforcement received a tip from an out of state undercover officer that Turner was

Bandon Smith, 26, Chestnut Street Sweetwater, was charged with DUI, Violation of Implied Consent, Open Container, Resisting Arrest, Expiration Tags, and Poss. of Handgun while Under the Influence.

Officer Law LCPD, was on routine patrol when Officer observed a silver GMC Sierra (TN Tag 275-BHQH) with expired registration (07/2023). Officer then activated his lights as soon as the vehicle turned right onto the I-75 SB ramp, and they proceeded to continue down the ramp until they were about 30 yards from the ramp finally stopping on I-75SB. Officer then identified the driver to be Brandon Smith,

while speaking to Mr. Smith officer observed him to have blood shot watery eyes, and the odor of an alcoholic beverage emitting from his vehicle. Mr. Smith later stated he had a few beers earlier prior to our encounter. Mr. Smith then consented to SFST, during HGN Mr. Smith kept moving his head along with his eyes (3) times while officer was trying to administer HGN. Officer then observed distinct and sustained nystagmus at maximum deviation, and an onset of nystagmus prior to 45 degrees in both of Smith's eyes. During the walk and turn Mr. Smith stepped off the line during the instruction phase and did an improper turn while performing the walk and turn. During the one leg stand, Mr. Smith

placed his foot down as it appeared he had lost balance when he first began the one leg stand. Mr. Smith was then told to place his hands behind his back, Mr. Smith then began actively resisting, and was failing to listen to the officer's commands. Officer, along with Officer Parmer were finally successful in placing Mr. Smith in custody. After placing him under arrest, he was read the Tennessee Blood and/or Breath Consent Advice-

ment. After reading the consequences, Mr. Smith refused to submit a blood sample to determine his blood alcohol content. While conducting a vehicle tow/inventory report, Officer did locate a ¾ open Busch light 12 ounce in the driver's side door. Also, in the vehicle was located a silver Kimber Pro Carry II (SN# KR288053). Mr. Smith was then transported to the Loudon County Jail without incident. All the above occurred in Lenoir City, TN.

Jose Borjas-Gonzalez, 34, North Chamberlain Avenue Rockwood, was charged with DUI, Violation of Implied Consent, and Driving on Revoked/Suspended License.

According to the report, Deputy Reagan LCSO, observed a silver Kia Forte traveling northbound on Highway 11. While observing, the deputy witnessed the vehicle cross the fog line on the right-hand side of the roadway two times. Deputy also observed the vehicle change lanes without using a signaling device.

The report further stated, This vehicle then stopped in the roadway and turned onto Kingston Street without using a turn signal. After turning, the deputy witnessed the vehicle cross over the double yellow center line. At that

time, the deputy activated his emergency lights and stopped the vehicle in the parking lot of 1001 Kingston St. Deputy made contact with the driver and identified him as Jose Borjas-Gonzales (Arrestee). Dispatch advised deputy that Mr. Gonzales's license was suspended out of Georgia. While speaking with Jose, deputy observed his eyes to be bloodshot and watery.

Deputy also could smell the odor of an alcoholic beverage emitting from the vehicle. At that time, the deputy requested that Jose exit the vehicle. While exiting the vehicle, he was slow to react and unsteady on his feet. Deputy spoke with Jose outside of the vehicle, and while speaking with him, the deputy could smell the odor of an alcoholic beverage emitting from his breath. Mr. Gonzales agreed to perform Standardized Field Sobriety

Testing. Sgt. C. Espinoza from LCPD responded to assist. Sgt. Espinoza began, and Jose Borjas-Gonzales performed poorly on all tasks. At that time, deputy placed Mr. Borjas-Gonzales into custody. While inventorying the vehicle, the deputy discovered a cooler in the back seat with ice and multiple beers inside. The deputy also found a beer that was loose in the back seat, and it was

cold to the touch. Money-makers Towing arrived on scene and towed the vehicle. Deputy then transported Mr. Borjas-Gonzales to the Loudon County Jail. Upon arrival, the deputy read the Implied Consent Form to Jose, to which he refused to give a sample of his breath and/or blood.

This did happen in Loudon County, TN, without further incident.

Haden Ferguson, 22, College Street Loudon, was charged with Public Intoxication, and Assault x2.

Officer C. Purdy LPD, was dispatched to College St for a White Male having a mental issue. Upon arrival his mother stated that her son was talking out of his head and not acting right and that he took off down Wharf St and he was located walking on Wharf St headed towards Grove St. Upon contact with Mr. Ferguson he appeared to be under the influence of some sort of unknown substance and was not making any sense and could not answer any questions. Believing Mr. Ferguson would be a danger to himself and the public if left unattended Officer placed Mr. Ferguson

into custody and transported him to the Loudon County Jail. This did occur in the City of Loudon.

Deputy L. Holmes was working his assigned post in intake when at approximately 1500 hours he was advised Loudon City Police Department was arriving with one male. Deputy Holmes and Cpl. As they got in the pat down room they decided to take him to the male change out room to do is strip search as policy states. As they got in the change out room Deputy L. Holmes asked inmate Ferguson to take his shorts off to which he stated "F*&^ you, I will fight you".

Cpl. Miller then asked him one more time to take his

shorts off to which he turned and punched Cpl. Miller straight in the face. Holmes then assisted Cpl. Miller into taking inmate Ferguson to the ground. As Holmes and other Deputies took Ferguson to holding cell 5 he started to become very agitated and irate again.

Captain Langley was notified of the incident and advised the male Deputies to

retrieve the shorts. Ferguson then charged at the Deputies as we entered. After retrieving the shorts they were advised to place him in the restraint chair. After one hour they were trying to get Ferguson out of the chair for mobility per policy and he became very irate again. Deputy L. Holmes was then Knocked out for about five to ten seconds.

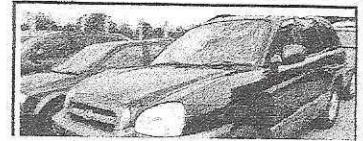

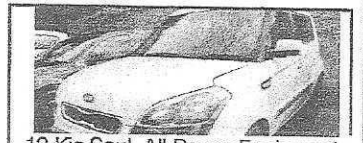

distributing child pornography on an Internet site. The Federal Bureau of Investigation (FBI) became involved as the FBI was also investigating a CyberTip that asserted Turner uploaded 120 files of child pornography containing still images and videos. As the investigation progressed, law enforcement learned that Turner was on parole for convictions from Illinois.

In June 2022, law enforcement went to Turner's home with a search warrant. Upon entering, multiple firearms were seen lying about the residence to which Turner admitted he was going to attempt to sell. The seizure yielded five pistols and ammunition, and child pornography.

U.S. Attorney Francis M. Hamilton III of the Eastern District of Tennessee; Special Agent in Charge, Joseph E. Carrico, of the FBI; and Special Agent in Charge, Marcus Watson of the Bureau of

Alcohol, Tobacco, Firearms, and Explosives (ATF) made the announcement.

The criminal information was the result of an investigation by Agent Cortny Dugger and Criminal Investigator Chanel Finnell with the Tennessee Ninth Judicial District Attorney General Office-Internet Crimes Against Children's Unit, the FBI, and ATF.

Assistant United States Attorney Jennifer Kolman represented the United States.

This case was brought as part of Project Safe Childhood (PSC), a nationwide initiative launched in May 2006, by the Department of Justice to combat the growing epidemic of child sexual exploitation and abuse. Led by the United States Attorney's Offices and the Criminal Division's Child Exploitation and Obscenity Section, PSC marshals federal, state, and local resources to locate, apprehend, and prosecute individuals who sexually exploit children, and to identify and rescue victims.
