



FBI, Partners Dismantle Qakbot Infrastructure in Multinational Cyber Takedown

Operation marks one of the largest-ever U.S.-led enforcement actions against a botnet

FBI Director Christopher Way announces a major operation targeting the Qakbot botnet.

The action, which took place in the U.S., France, Germany, the Netherlands, Romania, Latvia, and the United Kingdom, represents one of the largest U.S.led disruptions of a infrastructure botnet used by cybercriminals to commit ransomware, financial fraud, and cyber-enabled other criminal activity.

"The FBI neutralized this far-reach-

ing criminal supply chain, cutting it off at the knees," said FBI Director Christopher Wray. "The victims ranged from financial institutions on the East Coast to a critical ingovernfrastructure ment contractor in the Midwest to a medical device manufacturer on the West Coast."

Douglas Morrison, 38, Black Bluff Georgia, was charged with Man/Sell/Del/Resale Sch. I & VI, Poss. of Drug Para., Unlawful Carrying or Possession of a Weapon, and Failure to Keep Right.

Jamie Wood, 39, Asher Park Georgia, was charged with Man/ Sell/Del/Resale Sch. I & VI.

Deputy Harrison LCSO, was sitting stationary at the 79-mile marker watching northbound traffic when he observed a silver sedan traveling in the left-hand lane at a slow speed being passed by tractor-trailers in the right lane. Deputy pulled out of the median and paced the vehicle at 60mph in the left-hand lane on Interstate 75 northbound. Deputy conducted a traffic stop at the 82-mile marker for the moving violation. Upon contact with the driver, Douglas Morrison, and

passenger Jamie Wood, Deputy could smell the odor of marijuana emitting from the vehicle. The deputy had Morrison exit and come back to the passenger seat of his vehicle while deputy issued a written warning. While speaking with Morrison, he stated he was previously arrested for armed robbery in 2009. Due to the odor of marijuana, Deputy asked if there was any in the vehicle to which he stated they had smoked approximately an hour ago. Deputy Watson arrived on the scene to assist with a probable cause search of the vehicle. During his search, In the center console, deputy located a clear baggie containing approximately 3.5g of a green powder substance, a black bag in the driver floorboard containing a scale and a bag of marijuana weighing approximately 26.8g, a semi-automatic 9mm handgun was also concealed under the bag. As dep-

uty made my way to the back seat, he located another bag of marijuana weighing approxi-mately 27.8g, and in the trunk, the deputy observed a black and red suitcase. Inside the red suitcase concealed within the clothing, the deputy located a black bag, and inside the bag was a wrapped bundle of multiple bags of marijuana totaling 147g and a clear baggie containing approxi-mately 105 multicolored "Donkey Kong" MDMA pills. Both Morrison and Wood were placed in custody and while Deputy Watson was conducting a search of Wood, he had another baggie

of marijuana and two small baggies containing approximately 17 more multi-colored pills concealed in his underwear. Based on the above facts, both Wood and Morrison were placed in

Once read Miranda, both subjects denied ownership of the marijuana and pills in the trunk. A criminal history search for Morrison showed multiple felony charges with one conviction date being 04-15-2005. Both subjects were transported to the Loudon County Jail without incident. This did occur in Loudon County, Tennessee.





The Oakbot malware infected victim computers primarily through spam emails that contained malicious attachments or links.

After a user downloaded or clicked the content, Qakbot delivered additional malware—including somware—to their computer. The computer also became part of a botnet (a network of compromised computers) and could be controlled remotely by botnet users. All the while, a Qakbot victim was typically unaware that their computer had been infected.

Since its creation in 2008, Oakbot malware has been used in ransomware attacks and other cybercrimes that caused hundreds of millions of dollars in losses to individuals and businesses in the

U.S. and abroad.

"This botnet provided cy-bercriminals like these with a command-and-control infrastructure consisting of hundreds of thousands of computers used to carry out attacks against individuals and businesses all around the globe," Wray said.

Disrupting the Duck
As part of the operation,
the FBI gained lawful access Oakbot's infrastructure and identified over 700,000 infected computers worldwide-including more than 200,000 in the U.S.

To disrupt the botnet, the FBI redirected Qakbot traffic to Bureau-controlled servers that instructed infected computers to download an uninstaller file. This uninstallercreated to remove the Qakbot malware—untethered infected computers from the botnet and prevented the installation

of any additional malware.

'All of this was made possible by the dedicated work of FBI Los Angeles, our Cyber Division at FBI Headquarters, and our partners, both here at home and overseas, said Wray. "The cyber threat facing our nation is growing more dangerous and complex every day. But our success proves that our own network and our own capabilities are more powerful.'




