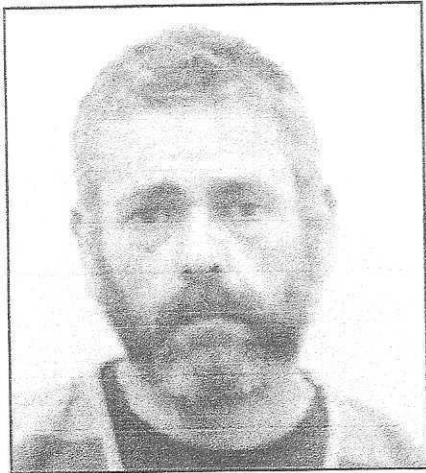

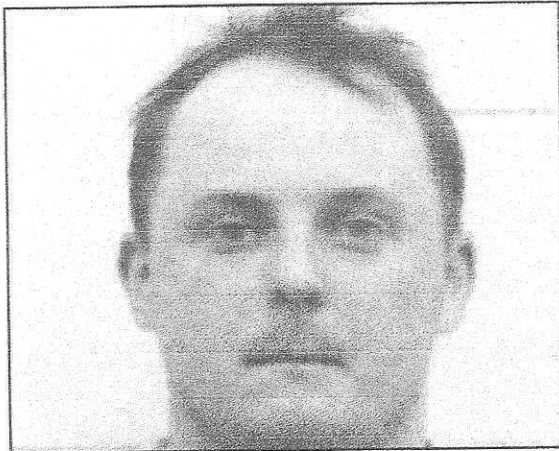

Despite over 2 million sexually transmitted infections reported in 2023, CDC data suggest that the STI epidemic may be slowing

The number of sexually transmitted infections (STIs) remains high in the United States, with more than 2.4 million reported in 2023. However, the latest data from CDC show signs the epidemic could be slowing. In 2023:

Gonorrhea cases dropped for a second year—declining 7% from 2022 and falling below pre-COVID-19

pandemic levels (2019).

Overall, syphilis cases increased by 1% after years of double-digit increases.

Primary and secondary syphilis cases, the most infectious stages of syphilis, fell 10%—the first substantial decline in more than two decades. These cases also dropped 13% among gay and bisexual men for the first time since CDC began reporting national trends among

this population in the mid-2000s.

Increases in newborn syphilis (known as congenital syphilis) cases appear to be slowing in some areas—with a 3% increase over 2022 nationally, compared to 30% annual increases in prior years.

“I see a glimmer of hope amidst millions of STIs,” says Jonathan Mermin, M.D.,

Brandon Shrewsbury, 27, Vonore Road Loudon, was charged with Public Intoxication. Deputy Pekala LCSO, was dispatched to Vonore Road in reference to a possible domestic. A neighbor of this address advised they heard screaming and a male say "I'm going to beat your ass". Upon arrival at Vonore Road, it was determined that no one appeared to be home, therefore they started walking back to their patrol vehicles parked at the store next door at Vonore Road. When Pekala and Deputy Kirkland went around a fence, they saw an intoxicated male standing on the fog line of the roadway talking to a citizen's academy ride-along. At this time the deputy instructed the male, later identified as Brandon Shrewsbury, to come speak with her however he refused and continued speaking with

the citizen. Due to Brandon's obvious intoxication level, the deputy lightly grabbed his arm to walk him in front of Deputy Kirkland's vehicle. Brandon was resistant however eventually made his way to the front where the deputy could conduct a terry frisk. The deputy asked Brandon if he had any weapons and he made a statement that he could do a lot with his hands. At this time due to Brandon's threat of physical harm and intoxication level, the deputy placed handcuffs on him and placed him in the back of the patrol vehicle in hopes he would calm down. While speaking with others present, it was determined that no domestic occurred. Brandon was ultimately transported to the Loudon County Jail for public intoxication. Upon arrival at the jail, Brandon decided to physically resist jail employees during the booking process.

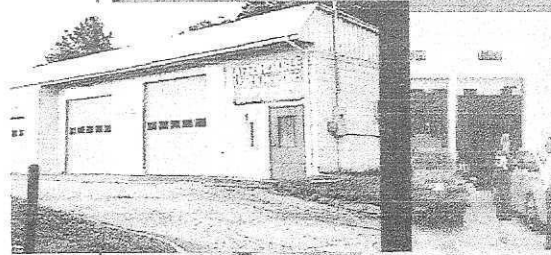

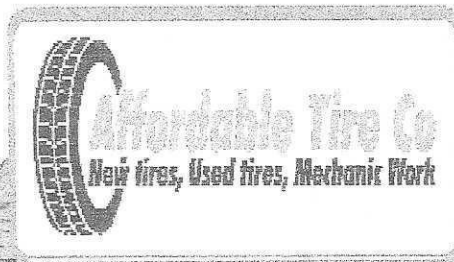

Kenneth Best, 48, Pickens Gap Road Knoxville, was charged with, Mfg/Del/Sale or Poss. of Meth.

Jennifer Corbin, 40, Bobby Drive Knoxville, was charged with Poss. of Drug Para.

Officers with the Lenoir City Police Dept. observed a suspicious vehicle parked in front of a closed business (524 Market Dr. Physicians Care) Sgt. Ketner observed Kenneth Best outside the vehicle and Jennifer Corbin sitting in the passenger seat. Sgt. Ketner noticed that Ms. Corbin had a syringe sticking out the side of her bra. Ms. Corbin then turned to the side and concealed the syringe. While speaking with Mr. Best he did admit to having methamphetamine inside his vehicle. Mr. Best then retrieved a box that was under the driver's seat. Inside the box there was approximately 2.5 grams of methamphetamine, and one glass pipe that was charred used to smoke methamphetamine. Inside the cen-

ter console there was another glass pipe used to smoke methamphetamine. Ms. Corbin removed the syringe and tourniquet from her bra and admitted that the syringe was being used to inject methamphetamine and Fentanyl. Both subjects were arrested and transported to Loudon County jail. These above actions did occur in Lenoir City, Tennessee.

Students Learning How the Government Works

The American Legion and the American Legion Auxiliary sponsor yearly programs called the Boys and Girls State respectively, a program started in 1935 to counter the Fascist inspired Young Pioneer Camps.

With slight variations, the program exists in 49 states (Hawaii being the exception). In Tennessee the programs consist of sending select high school juniors to a six-day camp where participants assume the roles of adults with all the rights and privileges, the duties and the responsibilities of a franchised citizen. The training is objective and practical with city,

county and state governments operated by the students elected to the various offices. Activities include legislative sessions, court proceedings, law enforcement presentations, assemblies, bands, chorus and recreational programs.

This year the American Legion Tellico Lake Post 256 again sponsored two boys, one each from Sequoyah and Greenback High Schools. The selection process starts with the interested students filling out application forms which are then evaluated by both school officials and Legion Post members. The top candidates are then interviewed, and a candidate and one or more alternates are selected from each school.

In past years the Post also selected and sponsored participants to the Girls State program, but with the formation of the newly chartered American Legion Auxiliary Unit 256 the selection and sponsorship has been transferred to the Unit. The candidate selection process for Girls State is identical to the Boys State program, with Auxiliary Unit members coordinating with

school officials to determine the most appropriate candidates.

This year the Tennessee American Legion Boys State ran Sunday, May 19th through Friday May 24th on the campus of Tennessee Tech University in Cookeville, and the Girls State was Sunday, May 26th through Saturday, June 1st at Lipscomb University in Nashville.

At the November general meeting of the American Legion Post 256 the students hosted by the Post and the Auxiliary for this year's programs took the opportunity to thank the Post for the experience and to express just how enjoyable and educational the experience was. While each had attended high school classes covering the general structure of government, the opportunity to assume a roll and participate was an "eye opening" experience.

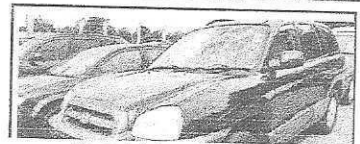

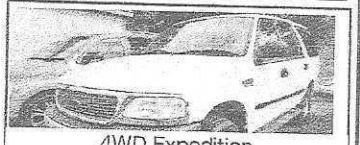

Inequities Persist

While the STI epidemic touches nearly every community, some geographic areas and populations are affected more severely, including American Indian/Alaska Native, Black/African American, and Hispanic/Latino people, as well as gay and bisexual men. These health equity differences are due in part to deeply entrenched factors that create obstacles to quality health services, such as poverty, lack of health insurance, less access to health care, and stigma. Sever-

al federal efforts are underway to address these disparities. Action at the community level is also key to meaningful progress.

The new data follow important developments and innovations in STI prevention, such as CDC's guidelines for doxy PEP to prevent bacterial STIs; newly Food and Drug Administration (FDA) authorized self-tests (or at-home tests) for syphilis, gonorrhea, and chlamydia; and a nationally coordinated response to the U.S. syphilis epidemic spearheaded by the National Syphilis and Congenital Syphilis Syndemic Task Force.

However, more efforts are needed to turn around the STI epidemic in this country, including:

Prioritizing the STI epidemic at federal, state, and local levels.

Developing new prevention, testing, and treatment solutions for more populations – including expanding the reach of

doxy PEP among groups for whom it is recommended, and conducting more research to determine if it can benefit other groups.

Investing in robust public health systems and trained workforces with capacity to provide STI services.

Delivering STI testing and treatment in additional outreach settings, like emergency departments.

Making STI services more accessible in local communities.
