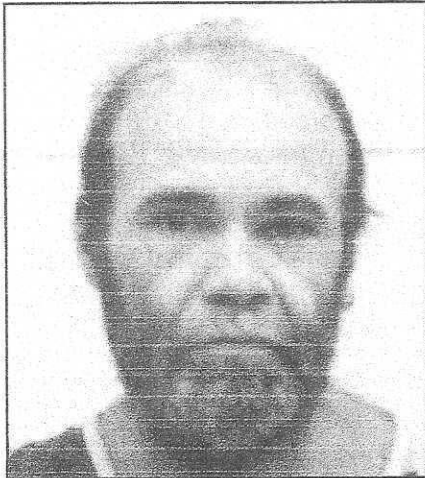

Audit Problems Linger in Lake County

The Tennessee Comptroller's Office is once again reporting poor audit results in the Lake County government's annual audit report.

The audit for the fiscal year ending June 30, 2024, contains 14 findings, nine of which were also reported in fiscal year 2023. These audit findings include material weaknesses,

significant deficiencies, and instances of non-compliance within several county offices.

Auditors noted findings related to the Offices of County Mayor, Director of Schools, Sheriff, Road Superintendent, and Ambulance Service Department.

The 14 findings include accounting, budgeting, and purchasing deficiencies. Material audit adjustments were

also required for proper financial statement presentation in the Offices of County Mayor and Director of Schools. These issues have been persistent in Lake County for many years and have remained uncorrected.

Lake County has had at least seven audit findings since fiscal year 2018.

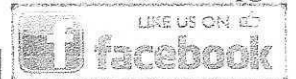

Lucas Kirkland, Blockhouse Road Maryville, was charged with, DUI.

Deputy Brockwell LCSO, arrived at Highway 321 S, JB's Country Store, for a Chest Pain call. Prior to arrival, dispatch notified the deputy that the person on the scene, Lucas Kirkland (offender), stated that they had taken meth an hour ago. When the deputy arrived on the scene, Kirkland was sitting in the driver seat of the vehicle as the only occupant. Kirkland exited his vehicle with the key fob to the vehicle

in his hand and placed it in his pocket. As the deputy was speaking to Kirkland, he stated that he had taken meth around 0200 at a girl's house. The deputy further questioned Kirkland about what happened, and he stated that he went to Maryville, TN to visit a girl and when he was there, he bought meth for 10 dollars and smoked it all. He started to feel the meth kick in and that's when he left to go home to his residence in Maryville, TN. Kirkland was driving in the opposite direction to go home on Highway 321 as he was headed into Lenoir City,

TN. While speaking to Kirkland, he was very jittery, moving around a lot, and stated he was hot in 20-degree weather wearing only sweatpants and a jacket with no undershirt. Based on the totality of the circumstances, the deputy then placed Kirkland under arrest for driving under the influence and transported him to the Loudon County Detention Facility. While at the Detention Facility (sallyport), Cpl. Wallen asked Kirkland if he would be okay with performing Standardized Field Sobriety Testing (SFST) to make sure he was able to operate a vehicle on a pub-

lic roadway safely and he complied to perform the test. Kirkland's SFST performance ensured us deputies that he was operating a motor vehicle on a public roadway while being under the influence. I then read Kirkland the Implied Consent Advisement form and Kirkland did consent to give blood. The deputy transported Kirkland to Fort Loudon Medical Center for the blood draw. The deputy then transported Kirkland back to the Loudon County Detention Facility. This did happen in Loudon County, TN without further incident.

Aggravated

Hubert Bennett, 49, Vonore Road Loudon, was charged with Aggravated Assault, and Especially Aggravated Kidnapping.

Cpl. J. Sartin LCSO, was dispatched to Fort Loudon Hospital in reference to a domestic assault victim who came to the hospital.

Upon arrival the deputy made contact with the victim who had dried blood on her face and head along with a large scrape mark on her side. The victim stated the night prior her husband, Mr. Hubert Eddie Bennett, and her were in their truck coming from Maryville. Mr. Bennett had been drinking and was upset with the victim who stated at one point he told her he would beat the back of her head in with the bottle on Jim Beam.

The report noted, The victim said she got out of the vehicle on Highway 321 and she then got back into the vehicle and Mr. Bennett's cousin, began driving. The victim stated that somewhere on Steekee or Vonore road, Mr. Bennett began hitting her in the back of the head. She then put her head down by the center

console and he was "hammer fisting the back of her head. The victim stated she then attempted to get out of the truck to get away and Mr. Bennett grabbed her by the hair and forced her back into the vehicle.

The report further noted, At some point during the altercation, the victim stated the driver began slowing the truck down, the victim stated Mr. Bennett pulled a "red curved bladed knife out" and told them if he stopped the truck he would "gut them" and then kill himself. Once they pulled into the residence, the victim stated she was able to get inside and hide in her daughter's room until the next morning when her oldest daughter was able to take her to the hospital for her injuries. The victim had visible marks on her hands, a large red mark with scratches on her side and an approximately 3 inch laceration on the back of her head.

The hospital completed a CT scan of Mrs. Bennett's head and discovered she had a brain bleed and transferred her to the University of Tennessee Hospital for further evaluation. This did occur in Loudon County, TN.

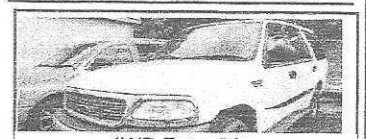

"It is discouraging to see another year of disappointing audit results in Lake County," said Comptroller Mumpower. "Year after year, county officials concur with our audit findings and develop corrective action plans to fix them; however, we don't see the follow through that is necessary to make government better. The Lake County Audit Committee

must hold officials accountable for making long overdue improvements."

It should be noted that some offices within Lake County government did not have any findings in this year's audit report. These offices include the County Clerk, Trustee, Clerk and Master, Register of Deeds, Assessor of Property, and the Circuit, General Sessions, and Juvenile Courts Clerk.

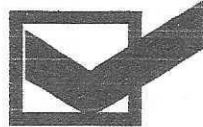

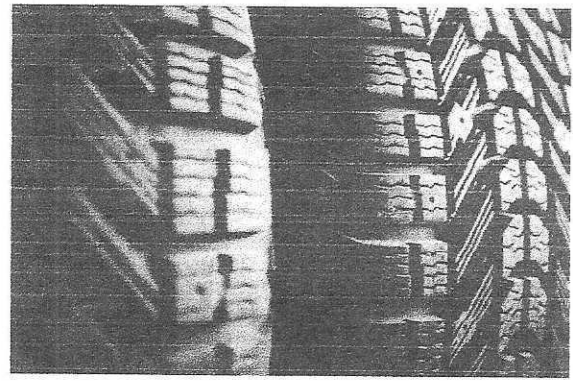

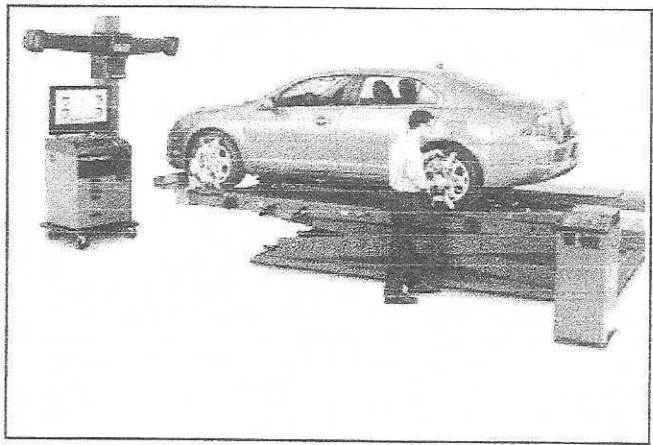
