## CDC Confirms First Severe Case of H5N1 Bird Flu in the United States

A patient has been hospitalized with a severe case of avian influenza A(H5N1) virus ("H5N1 bird flu") infection in Louisiana. This marks the first instance of severe illness linked to the virus in the United States. The case was confirmed by the Centers for Disease Control and Prevention (CDC) on Friday, December 13. Since April 2024,

there have been a total of 61 reported human cases of H5 bird flu reported in the United States.

Partial viral genome data of the H5N1 avian influenza virus that infected the patient in Louisiana indicates that the virus belongs to the D1.1 genotype related to other D1.1 viruses recently detected in wild birds and poultry in the United States and in recent human cases

in British Columbia, Canada, and Washington state. This H5N1 bird flu genotype is different than the B3.13 genotype detected in dairy cows, sporadic human cases in multiple states, and some poultry outbreaks in the United States. Additional genomic sequencing and efforts to isolate virus from clinical

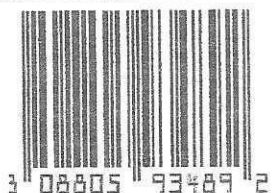

Austin Rogers, 19, Summer Street Loudon, was charged with, Contributing to the Delinquency of a Minor, Simple Possession, and Poss. of Drug Para.

Deputy Reagan LCSO, observed a white Chrysler Town and Country in the parking lot of the Bluffs Trailhead, Jackson Bend Rd. When the deputy stepped out of his vehicle, he could smell the odor of marijuana coming from the vehicle. The deputy recognized the vehicle from a past incident on December 4, 2024. The deputy

ran the registration to confirm (554BMWK). When the deputy approached the vehicle, he observed 4 individuals sleeping inside. The deputy tapped on the driver-side window to wake up the driver. When he woke up, the deputy identified him as Austin Rogers (Arrestee). The deputy explained to him that he could smell marijuana, to which he stated that he had roaches in the compartment under the radio. The deputy asked everyone to exit the vehicle and to provide identification. The deputy identified the front passenger as a 20 year old female, the mid-

dle passenger as 18 year old male, and the back passenger as a 16 year old male. While speaking with Austin, he stated that they all went on a trip to Gatlinburg the night prior and got tired during the drive. He stated that they were smoking marijuana on the ride home and stopped to rest. He also stated that if there is any marijuana left in the vehicle, it would be located under the passenger seat, and it would only be 1 gram. All individuals admitted to smoking marijuana except for 1 male. Deputy Frye arrived on the scene, and Reagan began searching the van. While conducting the search, the deputy located multiple pipes located under the passenger seat, as well as a pre-rolled marijuana roach and a metal container with marijuana in it. Upon searching further, the deputy located 3 large bags containing marijuana in a black bag in the back seat floorboard. A grinder was located in the sliding door panel on the left side.

Deputy Frye located other paraphernalia in the vehicle's trunk. A field weight of all of the marijuana equaled out to 29g. Rogers was read the Miranda Warning and waived his rights. He stated that all narcotics and paraphernalia were his. All other subjects were read Miranda and waived their rights. one stated, "What's his is mine, and what's mine is his. "But he will take all of it." The other two individuals told the deputy that none of what was found was theirs. A guardian was called and responded to the scene to pick up 1 male. With this being the third incident where he possessed narcotics the deputy placed Austin into custody and transported him to the Loudon County Jail. In the 1st incident, the marijuana was destroyed on scene, the second incident, he was cited for possessing 22.1g. (20241230196) All other individuals were released from the scene. This did happen in Loudon County, TN.

Belinda Baker, 41, Summer Glenn Lane Loudon, was charged with Domestic Assault.

Deputy Slattery LCSO, was dispatched to Summer Glenn Lane in response to a domestic disturbance in progress, reported by an anonymous caller. Upon arrival, the deputy met with the victim, who stated that he had been involved in a verbal altercation with his wife, Belinda Baker. The altercation began when Belinda entered the spare bedroom where the victim was staying and demanded that he hand over his cell phone. The victim refused, and the situation escalated when Belinda intentionally jumped on him and scratched the right side of his cheek, leaving a visible

scratch with dried blood. The victim attempted to diffuse the situation by walking out of the room, but Belinda followed him and wrestled him to the ground, again demanding the phone. During the struggle, the victim sustained a small open wound to his right knee. He further stated that he had to lock himself in the hall bathroom to escape from his wife. When the deputy spoke with Belinda, she acknowledged jumping on the victim in an attempt to take his cell phone. Based on the investigation and the visible injuries sustained by the victim, Belinda was determined to be the primary aggressor and was taken into custody for domestic assault. This incident occurred in Loudon County, Tennessee.

specimens from the patient in Louisiana are underway at CDC.

While an investigation into the source of the infection in Louisiana is ongoing, it has been determined that the patient had exposure to sick and dead birds in backyard flocks. This is the first case of H5N1 bird flu in the U.S. that has been linked to exposure to a backyard flock. A sporadic case of severe H5N1 bird flu illness in a person is not unexpected; avian influenza A(H5N1) virus infection has previously been associated with severe human illness in other countries during 2024 and prior years, including illness resulting in death. No person-to-person spread of H5 bird flu has been detected. This case does not change CDC's overall assessment

of the immediate risk to the public's health from H5N1 bird flu, which remains low.

This case underscores that, in addition to affected commercial poultry and dairy operations, wild birds and backyard flocks also can be a source of exposure. People with work or recreational exposures to infected animals are at higher risk of infection and should follow CDC's recommended precautions when around animals that are infected or potentially infected with H5N1 avian influenza virus. This means that backyard flock owners, hunters and other bird enthusiasts should also take precautions.

The best way to prevent H5 bird flu is to avoid exposure whenever possible. Infected birds shed avian influenza A viruses in their saliva, mucus, and feces. Other infected animals may shed avian

influenza A viruses in respiratory secretions and other bodily fluids (e.g., in unpasteurized cow milk or 'raw milk').

As a general precaution, whenever possible, people should avoid contact with sick or dead animals, in particular wild birds, and poultry.

For individuals with direct/close contact with wild birds or sick or dead poultry or other animals, wear recommended personal protective equipment (PPE). Wild birds can be infected with avian influenza A viruses even if they don't look sick.

Do not touch surfaces or materials (e.g., animal litter or bedding material) contaminated with saliva, mucus, or animal feces from wild or domestic birds or other animals with confirmed or suspected avian influenza A virus infection.

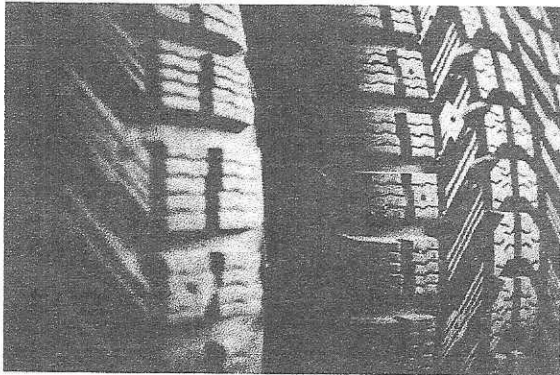

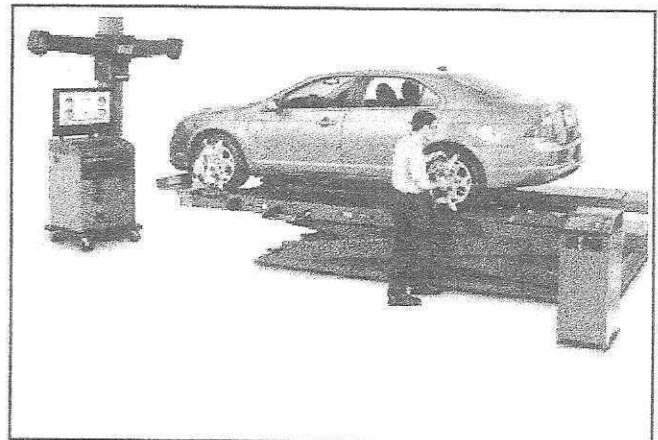
