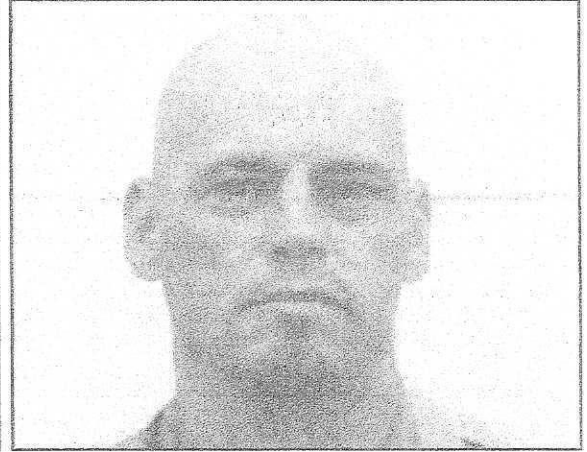

FBI Cyber Lead Urges Potential LockBit Victims to Contact Internet Crime Complaint Center

Vorndran discusses LockBit disruption at Boston Conference on Cyber Security

FBI Cyber Division Assistant Director Bryan Vorndran on June 5 highlighted the Bureau's "ongoing disruption" of the LockBit ransomware group and its affiliates, and urged potential victims to contact the Bureau's Internet Crime Com-

plaint Center (IC3).

The Bureau now has more than 7,000 LockBit decryption keys in its possession, Vorndran said in a keynote at the 2024 Boston Conference on Cyber Security. We can use these keys to help victims get their data back, he noted. Potential victims can contact IC3 by visiting our LockBit Victim Reporting Form at lockbitvictims.ic3.gov.

"We are reaching out to known LockBit victims and encouraging anyone who suspects they were a victim to visit our Internet Crime Complaint Center at ic3.gov," he said.

The LockBit ransomware variant has been utilized in over

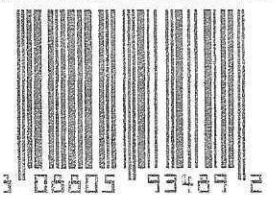

Wuimer Ribas, 32, Gateway Circle Philadelphia, was charged with DUI, Evading Arrest, License Required, and Driving on Roadway Laned for Traffic.

Officer Kelley LPD, was on routine patrol on Highway 72 when dispatch gave out a call for a reckless driver on Steekee driving toward Highway 72. Officer Kelley was in the area of Highway 72 at the interstate. Officer Kelley started driving toward the are where the reckless driver was coming from and dispatch notified us that the vehicle was a sil-

ver Oldsmobile Alero with a drive out tag on the back window. Dispatch notified Loudon Police Department that the vehicle turned left off Steekee onto Highway 72 heading toward Highway 11. Officer Kelley observed the silver 4 door sedan driving on Highway 72 heading toward the interstate. Officer Kelley turned around and was driving behind the Silver Sedan with a temp tag that matched the description of the vehicle we were looking for. Officer Kelley was observing the vehicle's driving and noticed the vehicle was slowing and speeding up at random times, failing

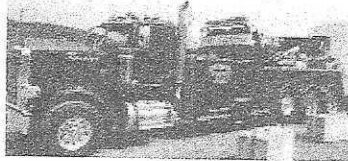

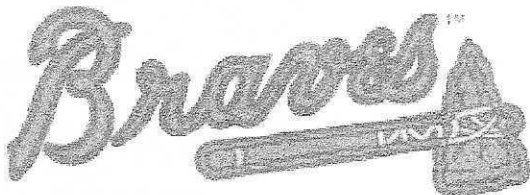

Deputy K Palmer, observed a white Kia Soul traveling North on Highway 321 at a high rate of speed. Using radar, the deputy clocked the vehicle going 66 mph in a 40 mph zone. The deputy stopped the vehicle on Highway 321 at Jackson Bend Road and contacted the driver, Tara Maureen Anderson.

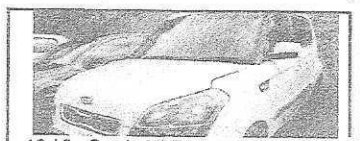

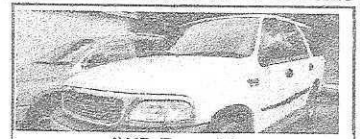

TBI Agents Investigating Officer-Involved Shooting in Blount County

At the request of 5th Judicial District Attorney General Ryan Desmond, TBI agents are investigating the circumstances leading to an officer-involved shooting that occurred Tuesday afternoon involving deputies with the Blount County Sheriff’s Office.

Preliminary information indicates that just before 3:30 p.m., deputies with the Blount County Sheriff’s Office responded to a domestic disturbance in the 1100 block of Jacob Springs Boulevard in Rockford. For reasons still under investigation, shortly after deputies arrived on scene, shots were fired by a male subject, resulting in the deputies returning

fire. During the exchange of gunfire, two deputies were struck. They were transported to a local hospital with non-life-threatening injuries. The male subject, identified as Ronald Millsaps (DOB: 7/31/64), barricaded himself inside the residence but was eventually taken into custody. He was not injured during the incident.

TBI agents obtained warrants charging Millsaps with one count of Aggravated Domestic Assault, two counts

of Attempted Criminal Homicide, six counts of Aggravated Assault, four counts of Reckless Endangerment, and one count of Especially Aggravated Kidnapping. He is currently being held in the Blount County Jail on a \$2.2 million bond.

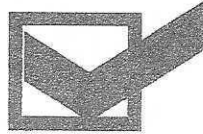
TBI agents are working to independently determine the series of events leading to the shooting, including collecting evidence and conducting interviews. Through-
