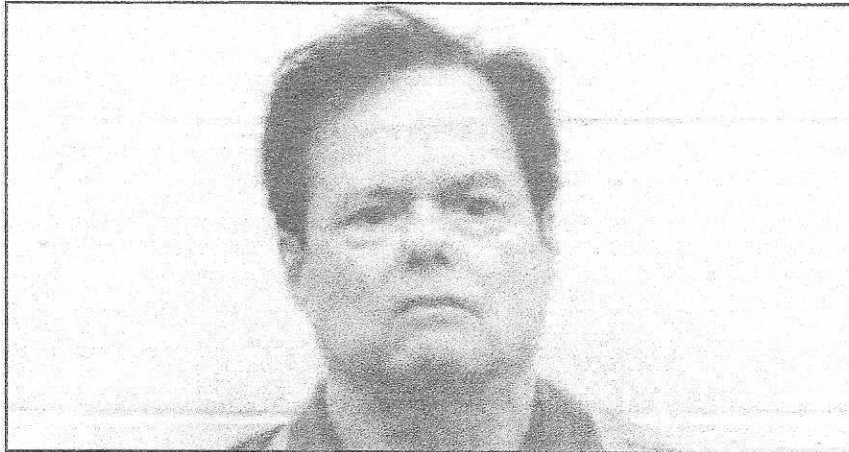

## CDC Confirms Second Human H5 Bird Flu Case in Michigan; Third Case Tied to Dairy Outbreak

*Risk to general public remains low*

A second human case of highly pathogenic avian influenza (HPAI) A(H5) virus infection has been identified in the state of Michigan. This is the third human case associated with an ongoing multistate outbreak of A(H5N1) in U.S. dairy cows. None of the three cases are associated with the others. As with the previous two cases (one in Texas, one in Michigan), the person is a dairy farm

worker with exposure to infected cows, making this another instance of probable cow-to-person spread. This is the first human case of H5 in the United States to report more typical symptoms of acute respiratory illness associated with influenza virus infection, including A(H5N1) viruses. CDC continues to closely monitor available data from influenza surveillance systems, particularly in affected states, and there has been no sign of unusu-

al influenza activity in people, including no increase in emergency room visits for influenza and no increase in laboratory detection of human influenza cases.

Based on the information available at this time, this case does not change CDC's current A(H5N1) bird flu human health risk assessment for the U.S. general public because all

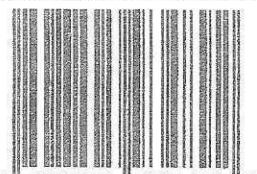

### Violated Order

Robert Bartsch, 68, Tommotely Drive Loudon, was charged with Violation of Order of Protection x2, Violation of Probation, and Man/Sell/Del/Resale Sch. VI.

Deputy Bowen LCSO, was performing his duties as Court Officer for Loudon County General Sessions Court. The deputy did witness Mr. Robert A. Bartsch in the court room. He was setting beside victims attempting to talk. Mr. Bartsch has an active no contact full Order of Protection against him Docket number 2024-CR-33. Where the victims and multiple other petition-

ers are the protected parties. At which time the victims moved seats in the courtroom. Mr. Bartsch exited the courtroom and upon his return he again took his seat next to the protected party and attempted in engaging in conversation. It was at this time the deputy was given a active warrant for Violation of Probation with a zero bond. The deputy then asked Mr. Bartsch to exit the courtroom with the deputy to the holding area just outside the courtroom where he was assisted by Deputy Matthew Brannon. The deputy then advised Mr. Bartsch that he was under arrest for the active Violation of Probation as well

as he was also being charged with 2 counts of the Violation of Order of protection. The deputy then returned to the courtroom and was later advised by Deputy Brannon that Mr. Bartsch stated that the Judge couldn't make him not have contact with the victims. The deputy is charging Mr. Robert A. Bartsch with 2 counts of Violation of Order of Protection. This did happen in Loudon County.

Inv. Clay Jenkins LCSO, responded to the Loudon County Juvenile Shelter 12665 E Lee Hwy, in reference to a black Porsche (Tn registration 675BJFS) in the parking lot possibly having narcotics inside of

it. The deputy learned from the jail that suspect Mr. Robert Bartsch had been telling people when he was getting booked in that he had a lot of Marijuana inside of his vehicle. The deputy then deployed my K9 partner Deja Vu who then positively alerted to the odor of narcotics at the rear of the vehicle. A search warrant for the vehicle was then applied for and granted. After search of the vehicle, inside of the trunk of the vehicle was approx. 7 ounces (196 grams) of pre packaged Marijuana. Mr. Bartsch was taken into custody prior for Violation of Order of Protection. All of this did occur in Loudon County, TN.

**Overdose**

Jeremiah Downs, 46, Reed Drive Powell, was charged with Simple Possession x2, Poss. of Drug Para., Public Intoxication, Mfg/Del/Sale or Poss. of Meth, Man/Sell/Del/Resale Sch. II, and Violation of Probation.

Officer R. Miller, with the Lenoir City Police Department, responded to the West Hills Market located at West Hills Drive in Lenoir City, TN in regards to a male subject in the parking lot who had possibly overdosed. The officer arrived on scene shortly after Sgt. Brad Rayfield at which time the officer made contact with the male subject. The male was identified as Jeremiah Downs.

While speaking with DOWNS he appeared to be profusely sweating, pale in color and could not stay

awake without being woken up. Medics along with fire rescue arrived on scene just shortly after our arrival to check the vitals of DOWNS.

Prior to medics attending to DOWNS the officer asked him if he had any items on his person that could potentially harm the medics at which time he responded that he had a "rig" (a hypodermic needle commonly used for injecting IV narcotics). The officer asked DOWNS if he could hand me the rig at which time he removed it from his front right pant pocket. The officer then had DOWNS step up from the sitting position where I then conducted a probable cause search of his pockets.

Located inside of the same front right pant pocket that the rig was located in was, (1) one dollar bill that was folded

up and contained a gray powder like substance believed to be fentanyl - approximate weight (0.86 grams), (1) clear bag containing a pink powder like substance believed to be Fentanyl - approximate weight (0.65 grams), (1) clear bag containing a crystal-like substance believed to be methamphetamine - approximate weight (3.32 grams), (1) clear bag containing a green

leafy substance believed to be marijuana - approximate weight (0.45 grams) and (1) small glass container that contained (1/2) of an orange suboxone pill.


Located in DOWNS backpack was a yellow digital scale that contained various amounts of residue on it. DOWNS was a danger to himself and the public.

Miranda Gussler, 28, Summit Circle Knoxville, was charged with Domestic Assault.

Officers with the Lenoir City Police Department were dispatched to Maple Street in reference to an unwanted guest. 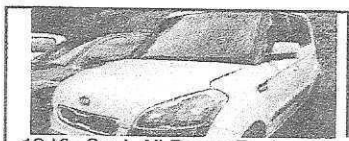

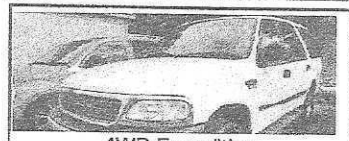

three sporadic cases had direct contact with infected cows. Risk depends on exposure, and in this case, the relevant exposure is to infected animals. The risk to members of the general public who do not have exposure to infected animals remains low. However, this development underscores the importance of recommended precautions in people with exposure to infected or potentially infected animals. People with close or prolonged, unprotected exposures to infected birds or other animals (including livestock), or to environments contaminated by infected birds or other infected animals, are at greater risk of infection and should take precautions.

**Case Background**

A dairy worker with exposure to H5N1-infected cows (at a different farm from the case last week) reported symptoms to local health officials. The patient reported upper respiratory tract symptoms including cough without

fever, and eye discomfort with watery discharge. The patient was given antiviral treatment with oseltamivir, is isolating at home, and their symptoms are resolving. Household contacts of the patient have not developed symptoms, are being monitored for illness, and have been offered oseltamivir. No other workers at the same farm have reported symptoms, and all staff are being monitored. There is no indication of person-to-person spread of A(H5N1) viruses at this time.

Specimens were collected from the patient; one of which was positive for influenza A(H5) virus using the CDC test at the state health department laboratory. The specimens were forwarded to CDC for further testing. They were received on May 29, and testing results that night confirmed A(H5) virus infection. Michigan was then notified of the results.

The designation of the influenza virus neuraminidase (the N in the subtype) is pending genetic sequencing at CDC and results will be made

available within 1-2 days, if successful. Additional genetic analysis will look for any changes to the virus that could change the agency's risk assessment.

**CDC Activities and Risk Assessment**

This case was detected through Michigan's active monitoring program for people exposed to infected livestock, in collaboration with CDC. The identification of an additional case of H5 is not surprising and shows the importance of a proactive public health response. Given the extent of the spread of this virus in dairy

cows, additional human cases in people with higher risk exposures would not be surprising. A CDC priority right now is to prevent additional cases of A(H5N1) infections in dairy herd workers, who are at higher risk of exposure. CDC has previously provided updated interim recommendations for worker protection to include those who work with dairy cows and asked states to provide personal protective equipment to farmworkers. In addition, the agency is conducting ongoing outreach to groups representing farmworkers.

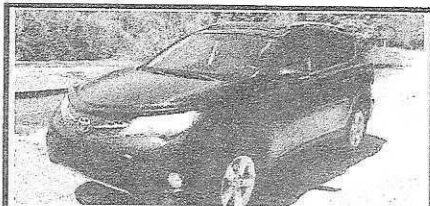

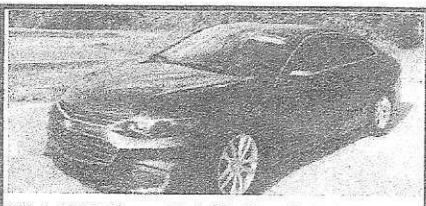

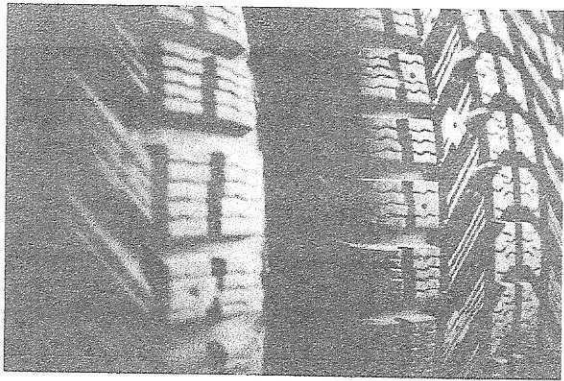
